AND WHEREAS at my appearance before the Committee of Privileges on the 25th day of November, 2009 I enquired of my right directly or through counsel to question the Honourable Minister of Finance, Dr. Ashni Singh the mover of the aforesaid motion and the seconder of that motion;

AND WHEREAS by way of letter dated the 15th December, 2009 the Clerk of the National Assembly informed me that "... in order to question the mover of the motion, the

Honourable Dr. Ashni Singh, either directly or through counsel, you would be required to table a motion in the National Assembly requesting leave of the House to so do.”;

AND WHEREAS the rules of natural justice, dictate that an accused person be given an opportunity to question his or her accuser;
