Prohibition on taking photographs etc. in court.

PART II.

5. (1) No person shall—

(a) take or attempt to take in any court any photograph, or with a view to publication make or attempt to make in any court any portrait or sketch, of any person, being a judge, registrar, magistrate, or coroner of the court or a juror or a witness in or a party to any proceedings before the court, whether civil or criminal; or

(b) publish any photograph, portrait or sketch taken or made in contravention of the foregoing provisions of this section or any reproduction thereof;

and if any person acts in contravention of any of the provisions of this section he shall, on summary conviction thereof, be liable in respect of each offence to a fine not exceeding two hundred and fifty dollars or to imprisonment for a term not exceed-

ing six months.

(2) For the purposes of this section a photograph, portrait or sketch shall be deemed to be a photograph, portrait or sketch taken or made in court if it is taken or made in the court-room or in the building or in the precincts of the building in which the court is held, or if it is a photograph, portrait or sketch taken or made of the person while he is entering or leaving the court-room or any such building or precincts as aforesaid.

(3) In this section—

"court" means any court of justice including any place where an inquest or inquiry is being held by a coroner;

"judge" means a judge of the Supreme Court sitting with or without a jury or in Cham-

bers;

"registrar" means the Registrar of the Supreme Court and includes any person lawfully discharging the functions of the Registrar in reference to any cause or matter in the Supreme Court and the Clerk of any court:

the expressions "coroner", "inquest" and "inquiry" shall have the respective meanings assigned to them by section two of the Coroner's Ordinance.
