1. This Ordinance may be cited as the Cinematograph (Amendment) Ordinance, 1954, and shall be construed and read as one with the Cinematograph Ordinance, hereinafter referred to as the Principal Ordinance, and any Ordinance amending the

same.

2. Section five of the Principal Ordinance as amended from time to time is hereby further amended—

(i) by the repeal of paragraph (c) of subsection (2A) and the substitution therefor of the following paragraph—
"(c) a certificate from the Central Board of Health in

the form set out in the First Schedule hereto where the premises are situate in a village, country or rural district, or, where the premises are

Second Schedule situate in an urban sanitary district, a certificate from the Medical Officer of Health of such district in the form set out in the Second Schedule hereto, that such premises are, with reference to public health or sanitation, fit for use for the purpose of this section;";

(ii) by the repeal of subsection (2C) and the substitution

therefor of the following subsection —

"(2C) The Superintendent, the City Engineer, the Director of Public Works, the Medical Officer of Health, their servants or agents or any officer of the Central Board of Health may, at any reasonable time, enter and inspect any premises licensed under the provisions of this Ordinance and if upon such inspection the Superintendent, the City Engineer, the Director of Public Works, the Medical Officer of Health or any person authorised by him or any officer of the Central Board of Health, as the case may be, is of opinion that the premises are unfit for use for the purposes of this section, any such officer or person shall forthwith report the matter to the Board who shall revoke or suspend the licence upon such terms as the Board may think fit:

Provided that in respect of premises for which a licence under this section was in force at that date, a provisional licence may be issued by the Board for such period as shall be specified by the Board which period may be extended from time to time by the Board pending the completion of such structural alterations as may be required for the grant of the certificates referred to

in subsection (2A) of this section.";

(iii) by the substitution for the word "schedule" in subsection (8) and the marginal note thereto of the words "Third Schedule".

3. The Principal Ordinance is hereby amended—
