ORDINANCE No.38 OF 1955

AN ORDINANCE to amend the Business Names (Registration) Ordinance.

Enacted by the Legislature of British Guiana: —

1. This Ordinance may be cited as the Business Names short title. (Registration) (Amendment) Ordinance, 1955, and shall be construed and read as one with the Business Names (Registration) Cap. 58 Ordinance, hereinafter referred to as the Principal Ordinance, and any Ordinance amending the same.

(1) Every firm or person required under this of section Ordinance to be registered shall, not later than the 15th 5 of the Principal day of January in every year, and in the case of a firm ordinance. or person not previously registered under this Ordinance, within fourteen days after the firm or person commences business or the business in respect of which registration is required as the case may be, make application to the registrar to be registered under this

(2) Every such application shall be accompanied by a statement in writing in the prescribed form containing the following particulars -

((a) the business name;

(b) the general nature of the business;

(c) the principal place of business;

- (d) where the registration to be effected is that of a firm the present Christian name and surname, any former Christian name or surname, the nationality, (and if that nationality is not the nationality of origin, the nationality of origin), the usual residence, and the other business occupation (if any), of each of the individuals who are partners, and the corporate name and registered or principal office of every corporation which partner;
- (e) where the registration to be effected is that of an individual, the present Christian name and surname, any former Christian name or surname, the nationality, (and if that nationality is not the nationality of origin, the nationality of origin), the usual residence, and the other business occupation (if any) of that individual;

(f) where the registration to be effected is that of a corporation, its corporate name and registered or principal office;

(g) if the business is begun after the commencement of this Ordinance the date when it is

(3) Where a business is carried on under two or more business names, each of those business names must be stated.

(4) This section shall apply, in the case where registration is required in consequence of a change of name, as if for references to the date of the commencement of the business there were substituted references to the date of the change."

Section seven of the Principal Ordinance is hereby

repealed and the following substituted therefor —

- 7. Every firm or person required under this letter heads. Ordinance to be registered shall insert on all letterheads and other like stationery intended to be used in connection with the ordering of goods for the business in respect of which registration is required —
 - (a) the registered business name;

- "(2) A certificate of registration issued under this Ordinance shall, subject to the provisions of this Ordinance, remain in force until the thirty-first day of December of the year in which it was issued and shall then expire."
