BRITISH GUIANA.

ORDINANCE No.40 OF 1955.

An Ordinance to incorporate the Unevangelised Fields Mission in British Guiana, to vest therein certain property, and for purposes connected with the matters aforesaid.

Enacted by the Legislature of British Guiana:—

A.D. 1955

- 1. This Ordinance may be cited as the Unevangelised Fields short title Mission (Incorporation) Ordinance, 1955.
 - In this Ordinance "the Mission" means the Unevangelised Fields Mission in Interpre-British Guiana:
 - "the Superintendent" means the Superintendent of the Unevangelised Fields Mission in British Guiana appointed in conformity with the provisions of Ordinance.
- 3. The Superintendent for the time being in British Guiana Incorporation of the of the Unevangelised Fields Mission and the members for the time Mission. being of the Field Council established in British Guiana for the

purposes of the Mission and their successors in office, shall be a body corporate and shall have the name of the Unevangelised Fields Mission in British Guiana, (hereinafter referred to as "the Mission") with perpetual succession and a common seal, and shall have full power to purchase, take, hold, enjoy, sell, transport, mortgage, lease, invest or otherwise deal with and dispose of all property movable and immovable, of what nature or kind soever, subject, however, to the performance of any trust upon which that property has been acquired, and may sue and be sued in all courts in the Colony.

Vesting of property in the Mission.

4. All movable or immovable property in the Colony shown in the schedule hereunder which at the commencement of this Ordinance is held by or is vested in the name of James Rader Hawkins is hereby vested in the Mission.

Vesting of property bequeathed.

5. All property movable or immovable of what nature kind soever hereafter bequeathed by will or otherwise given to the Mission shall be deemed the property of the Mission.

Tenure of use of the Mission.

All property vested in or hereafter acquired by the property for Mission shall be held by it for the use and benefit of the Mission.

Holding of licence.

The Mission may hold land in the Colony without land without licence of the Governor in Council.

Exercise of Mission of powers in matters not especially provided for by Ordinance.

8. In all matters not specially provided for by this Ordinance, the Mission shall so far as may be practicable, possess and exercise the like power and authority as are possessed and exercised by the Unevangelised Fields Mission in the United States of America, and its proceedings shall be governed by the laws, regulations, processes and practice of that body in so far as they are not repugnant to, or in conflict with any Ordinance or law in force in the Colony.

Evidence of of the Superin_ tendent.

9. A statement that any person named therein has been apappointment pointed the Superintendent, purporting to be signed by the General Overseer or such other authority having the power of pointment on behalf of the Unevangelised Fields Mission in the United States of America shall be prima facie evidence of said fact.

Certain inbe signed by Superintendent.

10. All transports, mortgages, leases, transfers, and assignstruments to ments, and all contracts or other documents relating to the movable or immovable property of the Mission or in which the Mission is or becomes interested, shall be signed by the Superintendent for the time being of the Mission.

Service of process.

11. All process which is required to be served on the Mission shall be deemed to be sufficiently served at the residence in the Colony of the Superintendent for the time being of Mission and a copy thereof published in the Gazette of Colony.

12. Nothing in this Ordinance shall be deemed to affect any right of Her Majesty the Queen, Her Heirs and Successors, or of any body politic or corporate or of any other person or persons except such as are mentioned in this Ordinance and those claiming by, from, through or under them.

section 4.

- 1. Lot numbered 35 (thirty-five), and the east half of lot numbered 36 (thirty-six), east of Queen Street, Kitty, in the Kitty and Alexander-ville Village District, situate on the east sea coast of the county of Demerara and Colony of British Guiana, the said lots being laid down and defined on a plan of part of Prince Edward's Town by H. Ormonde Durham, Sworn Land Surveyor, dated 24th November, 1925, and deposited in the Deeds Registry of British Guiana on the 26th day of July, 1926, with the buildings and erections on said lot numbered 35 (thirty-five).
- 2. Lot numbered 37 (thirty-seven), and west half of lot numbered 38 (thirty-eight), east of Queen Street, Kitty, in the Kitty and Alexanderville Village District, situate on the east sea coast of the county of Demerara and Colony of British Guiana, as shown on a diagram of that portion of Kitty, formerly known as Prince Edward's Town, by H. Rainsford, Sworn Land Surveyor, dated 30th April, 1842, and deposited in the Office of the Registrar at Georgetown on the 25th July, 1847, no building thereon.

Passed by the Legislative Council this ninth day of September, nineteen hundred and fifty-five.
