1. This Act, which amends the Local Government Act, may be cited as the Local Government (Amendment) Act 2015.

Amendment of the Principal Act.

2. The provisions of the Principal Act specified in the first column of the Schedule are amended in the manner specified in the corresponding entry in the second column of the Schedule.
