AN ACT to amend the Bitters and Cordials Act. -

Enacted by the Parliament of Guyana:-

Short title. Cap. 82:23

1. This Act, which amends the Bitters and Cordials Act, may be cited as the Bitters and Cordials (Amendment) (No. 2) Act 1992.

Amendment of section 2 of the Principal Act.

- 2. Section 2 of the Principal Act is hereby amended in the following respects
 - (a) by the insertion after the words "In this Act —"
 of the following definition —
 "alcohol" means ethyl alcohol;"; and
 - (b) in the definition of "sweets", by the substitution for the words "four percent" and "twenty-six percent of proof spirit" of the words "two decimal three percent" and "fourteen decimal eight percent of alcohol", respectively.

Amendment of section 10 of the Principal Act. 3. Subsection (2) of section 10 of the Principal Act is hereby amended by the substitution for the words "liquid and proof gallons" of the words "litres and litres of alcohol".

Amendment of section 11 of the Principal Act. 4. Section 11 of the Principal Act is hereby amended by the substitution for the words "liquid gallons" of the word "litres".

Amendment of section 13 of the Principal Act. 5. Paragraph (c) of section 13 of the Principal Act is hereby amended by the substitution for the words "liquid gallons" of the word "litres".

Amendment of section 15 of the Principal Act. 6. Section 15 of the Principal Act is hereby amended by the substitution for the words beginning with "two imperial liquid gallons" and ending with "half-pint bottles" of the words "nine litres, or one dozen of seven hundred and fifty-seven millitres bottles or two dozen of three hundred and seventy-eight millilitres bottles, or four dozen of one hundred and eighty-nine millilitres bottles".

Amendment of section 16 of the Principal Act. 7. Subsection (2) of section 16 of the Principal Act is hereby amended by the substitution for the words "gallons at proof" wherever they occur of the words "litres of alcohol".

8. Section 21 of the Principal Act is hereby amended in the following respects —

Amendment of section 21 of the Principal Act.

- (a) in subsection (1)
 - (i) by the substitution for the word "Sikes" where it first appears, of the words "an approved alcohol";
 - (ii) by the substitution for the words "A Table of the strength of spirits denoted by Sikes' hydrometer" of the words "Practical Alcohol Tables, Volume 2";
- (b) in subsection (3), by the substitution for the word "Sikes" of the words "an approved alcohol".
- 9. Section 22, and the marginal note thereto, of the Principal Act are hereby amended by the substitution for the words "one gallon" and "four percent of proof spirit" of the words "four decimal five litres" and "two decimal three percent of alcohol", respectively.

EXPLANATORY MEMORANDUM

This Bill seeks to amend the Bitters and Cordials Act, Cap. 82:23, to change the mode by which the strength of any liquor is determined so as to conform with the International Organisation of Legal Metrology (OIML) system of Alcoholometry. As a result of the amendment sought to be made, all units of Imperial weights and measures pertaining to goods containing alcohol are changed to Metric Units.
