Enacted by the Parliament of Guyana:-

Short title, Cap, 99;07 1. This Act, which amends the Bakeries (Hours of Work) Act, may be cited as the Bakeries (Hours of Work) (Amendment) Act 1994.

Amendment of section 8 of the Principal Act. 2. Section 3 of the Principal Act is hereby amended by the deletion of paragraph (b).

Amendment of section 5 of the Principal Act, 3. Section 5 of the Principal Act is hereby amended by the substitution for the words "between the hour of seven in the evening of any day and the hour of five in the morning of the following day for any period not exceeding two weeks", of the words "on any Sunday".
