

REPORT OF THE DIRECTOR OF AUDIT ON THE ACCOUNTS OF  
THE NEW WIDOWS AND ORPHANS' FUND FOR THE  
YEAR ENDED 31ST DECEMBER, 1962.

The books and accounts of the New Widows and Orphans' Fund for the year ended 31st December, 1962, have been examined under my direction.

Receipts - Interest on Investments, \$241,177.16

2. This amount includes the sum of \$37,017.81, received from Government in respect of interest payable on monies employed for its purposes. Attention has been drawn to an apparent short-collection of \$4,566.35, in respect of such interest.

Payments - Refunds of Contributions -  
\$37,218.52

3. As a result of a misallocation, the amount of \$37,218.52, shown as refunds of contributions has been understated by the sum of \$95.20.

Statement of Assets and Liabilities

Assets

4. Investment - \$5,160,248.40 - This asset is shown at cost and this figure includes, in the case of cum div transactions, the accrued interest at the time of purchase. The middle market value at 31st December, 1962, was \$4,779,061.01, and for the purpose of this calculation, local issues of securities have been accepted at face value. Details are shown at Statement "C".

5. The total market value of securities of the British Guiana Government held by the Fund and sums employed at interest for the purpose of the Government as presented in the accounts at 31st December, 1962, exceeded the prescribed limit of three-eights of the total assets of the Fund under the provisions of Section 15(3), of the Widows and Orphans' Pension Ordinance (Cap. 75), by an amount of \$448,602.63.

6. Arrears of contribution at 31st December, 1962, to an undetermined amount, and amounts totalling \$59,854.34, subject to the comments at paragraph 7 below, due by the Government of British Guiana in respect of the difference between interest at the rate of 6% per annum on the cost price of investments held by the Fund and the actual interest earned by those investments, have not been reflected as assets.

7. The amount of \$59,854.34, stated in paragraph 6, above, as due by Government, would appear to have been overstated by an undetermined amount, as a result of the calculations of interest at the rate of 6% per annum having been made on a cost price which includes accrued interest at the time of purchase. The exclusion of such amounts for interest calculations is specified in Section 3(2), Cap. 75, of the Laws of British Guiana, 1953.

Balance on Deposit in respect of Rejected  
Officers - \$40,637.21.

8. As a result of a misallocation, the amount stated as being held on deposit on the Post Office Savings Bank has been overstated by the sum of \$95.20.

General

9. The accounts were submitted for audit on the 6th January, 1965, and this did not permit the laying before the Legislature by the 30th June, 1963, as required under the provisions of Section 16, of the Widows and Orphans' Pension Ordinance, Cap. 75, of the Laws of British Guiana, 1953.
