INTRODUCTION

The Ethnic Relations Commission commenced the year with much enthusiasm of fulfilling its projected work program in 2020 but these plans were inhibited by the pandemic of Covid 19. Despite the challenges of the pernicious virus, the Commission continued to function and befittingly carried out its mandate.

Early in January 2020, the Commission launched the "I AM US" Movie at the Caribbean Cinema Movie Theatre, Giftland Mall. The initiative formed part of the phase two (2) Harmony Campaign which focused on the imminent elections and pushed the message of peace and tolerance for all Guyanese during the elections period. Free admission was provided to almost 1500 Guyanese that provided overwhelming positive feedback on the film.

The run-up to the March, 2020 General Elections were also monitored by the (41) forty-one temporary elections monitors that were hired and trained by the Commission.

Following the No Confidence Motion in December, 2018 and the holding of deferred general elections in March, 2020, the Commission worked assiduously to mitigate the impact of those events. The ERC, in February, 2020, successfully obtained the agreement of the eleven Political Parties contesting the elections to sign its "Code of Conduct" to commit to clean campaigning. (See Annex A)

The Commission, for the first time since it was established in 2002, commenced legal action in 2020 against alleged violators under the Racial Hostility and Representation of the People Acts to discourage the growing, alarming trend of racial incitement, especially on social media. This was further reinforced through ERC's Persons of Interest Ad in the newspapers and on social media.

The Commission's Investigation Unit received and addressed 225 complaints during 2019 and 2020, of which approximately 170 were fully investigated and closed. Some are still pending. A public whatsapp number was established to allow the public to send complaints readily.

During the West Coast Berbice unrest, the ERC issued several press statements condemning the senseless killing of the teens at Cotton Tree and called on the Joint Services to re-establish law and order along the East Coast and West Berbice. Commissioners and staff on Thursday, September 17, 2020, visited the grieving families of the Henry cousins, Isaiah and Joel and Haresh Singh, offering prayers and words of comfort to parents and guardians of the slain youths.

In the second phase of its 'Harmony Campaign,' the Commission produced an additional five PSA's and launched the first ever Virtual "National Conversation" in December, 2020 in collaboration with the University of Guyana and the Office of the UN Resident Coordinator. The "National Conversation on improving Ethnic Relations" was held at Herdmanston Lodge, Georgetown.

The two-day event was intended to solicit the inputs from Guyanese at home and in the diaspora. It attracted over 50,000 views on social media and was viewed by thousands more on local television. Thousands tuned in to the live broadcasts on NewsTalk Radio, TVG Ch 28, HBTV Ch 9 and HGPTV Ch 67.

During the year in review, the commission engaged two consultants on developing a roadmap for a 5 year strategic plan that will better position the ERC to strengthen and develop soft and hard measures to strategically respond to events and ethnic tensions in the country.

The Commission has throughout its tenure placed much emphasis on the importance of education. To this end, in an effort to increase awareness among Guyanese children- in late December 2020 the ERC held a soft launch in front of Republic Bank for its Harmony Colouring Book titled "Colour your History and Heroes" The book depicts a number of notable historical events and figures, generally unknown to Guyanese students and even adults, it is intended for distribution to Primary School students. The Commission sees the critical need for collaborative efforts between the body and the Ministry of Education towards having the book forming part of the social studies syllabus.

THE ETHNIC RELATIONS COMMISSION ANNUAL REPORT FOR THE YEAR 2020

GENERAL

Prior to the general and regional elections, Commissioners were granted Observer Status to monitor elections on E-Day. Teams that included two (2) Commissioners were formed and fanned out to observe the electoral process in regions 3, 4, 5, 6, and 10. The Commissioners unanimously reported that they saw no major incidents involving voters and the conduct of the elections. Subsequent to E-Day Commissioners also participated in the recount process.

An internal swift response committee comprised of senior staff members and Commissioners was formed prior to elections to provide quick response/warning to political party members whose narrative during the campaign trail had violated the code of conduct or had the potential to caused ethnic instability. A colour code was used as a guide for immediate actions to be taken, a number of party leaders were written on the violation. (See Annex D for Elections report and letters disseminated)

The Commission in 2020 continued its thrust to provide the relevant equipment needed to ascertain operational efficiency departmentally and organizationally. There were twelve (12) statutory meetings held by the Commission in 2020, meetings generally occurred on the fourth Thursday of every month. The Commission also met for a number of Special Meetings throughout the year to tackle matters that required timely dialogue and decisions.

The four (4) Sub-committees continued to meet often to ensure that projects were on course and matters arising were given the required attention. More specifically, the Media and PR sub-committee met to brainstorm and submit meaningful creative proposals to the board that were congruent to ERC's mandate. There was one new addition to the Complaint Sub-Committee; Commissioner Deodat Persaud was added to the committee bringing its membership to seven (7) members. 

STAFF CONTRACTS

In order to access the approved Duty-free Concessions, the Commission approved the amendment of the Contracts for the Chief Executive Officer, the Finance Officer and the Administrative Officer to three (3) years instead of two (2). All other staff members are on two (2) year contracts.

ANNUAL LEAVE

Staff members who were at home (but were not working virtually) were required to proceed on their Annual leave with effect from June so as to prevent a buildup of persons proceeding on leave when the work of the Commission resumed.

With the exception of the new Chief Executive Officer and the Finance Officer, all other staff members were able to enjoy their vacation leave for 2020.

ATTENDANCE

During the period March 17 - 27, in light of COVID-19 pandemic and as approved by the Department of Public Service, on the Directive of President David Granger (Circular PS: $16/0^{viii}$), staff members were allowed to work on a rotational basis, with the exception of senior staff and the Cleaner (senior staffers were allowed one half day per week and the Cleaner worked every day from 8:00 hrs. to 13:00 hrs.).

From July 10 to August 1, employees of the Administrative Department and the Investigative Unit were in full attendance at the office on Mondays, Wednesdays and Fridays and whenever necessary to facilitate meetings, receiving complaints, etc.

All employees were in attendance on a rotational basis as per the PSM Circular from August 2020. Heads of Departments were not on full rotation due to the exigencies of the Commission.

PERFORMANCE

All staff members supported the Commission's activities during 2020 and performed at high standards.

For a period, it was recommended that the office be closed as a result of the COVID 19 pandemic. Notwithstanding, staff continued to display commitment in the performance of their duties through virtual connectivity.

However, the CEO, Finance Department, the Administrative Officer and other Senior staff were in office on occasions to carry out necessary financial and administrative functions.

FACILITY

All the necessary furniture are in place to ensure that staff are made comfortable to the extent that the limited accommodation allows.

COVID-19 MEASURES

In an effort the address and prevent the spread of COVID-19 in the office with the return of staff back to work, a temperature thermometer was purchased and put into use in keeping with the MOPH Guidelines for COVID-19 Measures. Additionally, a sink was installed by the entrance of the compound, for the washing of hands, along with wall dispensers around the office

COVID-19 POLICY GUIDELINE

The Commission at its 9th Statutory Meeting held on September 24, 2020 approved the following COVID-19 Policy Guideline for immediate implementation within the Commission.

COVID-19 GUIDELINES

EMPLOYEES PERSONAL OBLIGATION

Every staff member is obligated to report immediately to his/her Supervisor in the event that a member of his/her household is tested positive for COVID-19.

During this period of the pandemic, it behooves everyone to be extremely mindful of the health and well-being of their co-workers

As stated previously, the Commission embraces an open-door policy, in which all employees, **affected or not** can share his/her concerns. The Commission wants what is best for its employees and as the global pandemic continues, it will do all that is possible within its ambit to assist its employees.

ERC COMMITMENT

The Commission has committed to paying the full salary to any of its employee who contracts the coronavirus or is required to be in self-isolation, to a maximum of fourteen (14) days.

Staff will be required to furnish the Commission with a Medical Certificate indicating the number of days of isolation.

Before resuming duty, it is essential for staff to produce a Certificate of Clearance from the Ministry of Public Health.

UNIFORMS

All staff members were issued four (4) sets of uniforms to be worn from Monday to Thursday and an ERC Monogramed Shirt to be worn on Friday.

OPERATIONS

EQUIPMENT

The Commission commenced the year with all staff members having the necessary equipment to effectively execute the Commission's work.

The Media Monitoring Unit and the Office of the CEO had new Biz Fibre Internets installed in order to effectively execute the work of the Commission.

The generator was maintained but unfortunately, after a long period of power outage, the engine burnt and as such the Commission is without a GenSet which will seriously affect the work of the ERC and the Rights Commissions.

All air condition units were all maintained and worked well.

VEHICLES

The Commission's vehicles are in working condition. Both the Nissan Frontier and the Navara were serviced and are well maintained. The new vehicle, a Mini-bus, will be of great use to the Commissioners in the performance of their duties.

BUILDING

General maintenance of the building continued as a matter of priority. The building was fumigated (bi-weekly) by MOPH Vector Control.

SECURITY

The security of the premises continued at an acceptable level. There were no adverse reports from any of the other Commissions on the premises. It is hoped that there will be a continuance of this level of performance.

PUBLIC EDUCATION & AWARENESS UNIT

Summary

It must be emphasised that the execution of projects by the Unit was curtailed owing to the COVID-19 pandemic and the impasse after the March, 2020 General Elections. Face-to-face interactions were significantly less and a period of uncertainty existed over the five-month elections stalemate.

However, in January and December respectively the Unit was fully involved in two significant events of national importance; the debut of the local movie "I Am Us" at Caribbean Cinemas, GIFTLAND Mall and hosting the *fully virtual* inaugural "National Conversation" on improving ethnic relations in Guyana. The signing of the ERC "Code of Conduct" in February by the eleven contesting Political Parties was also a major highlight in the run-up to the general elections.

A number of new Public Service Advertisements (PSA's) were also produced and disseminated to promote peace and tolerance as well, despite the new challenges. No major engagements with stakeholders were organized due to the aforementioned reasons. However, other projects were executed in the area of branding, a logo competition, spreading awareness on offences and even inviting persons of interest to the Commission for infractions committed.

A major undertaking was the preparation and planning of a "Virtual National Conversation" on improving ethnic relations to which much time and effort were devoted. This report also provides a far-reaching glance of the public relations activities for the year. Despite the challenges posed by the pandemic, the year ended with the soft launch and public distribution of 200 copies of the ERC Harmony Colouring Book intended for Primary School students.

Major Events

I AM US – The Movie

In January, "I Am US", the locally produced movie adapted from the 2019 stage play of the same name was launched and shown for one week at Caribbean Cinemas, GIFTLAND Mall with free admission to cinema goers. The link to view the movie was also provided on the ERC YouTube Channel for Guyanese unable to watch "I Am Us" in the cinema or living in outlying regions. At the time of preparing this report the movie according to You Tube statistics was viewed 41,460 times. The ERC in 2020 also participated at film festival where the movie was shown at the Umana Yana. The link was also shared to the email addresses of stakeholders with whom the ERC has interactions since its re-activation in 2018.

With a cast of characters representing the country's ethnicities, the movie was also seen as a catalyst to promote tolerance in the run-up to the March, 2020 Regional and General Elections. The plot of the movie brought to the fore the hurdles faced by two neighbouring families composed of the two major ethnic groups and living in harmony, but latent suspicions and mistrust surfaced during an upcoming election.

In the story, not without typical Guyanese humour which the local audience welcomed, both families were forced to reconcile in the interest of their young offspring. Almost two thousand persons watched the movie at Caribbean Cinemas.

The ERC "Code of Conduct" for Political Parties

Following engagements with representatives of political parties for a few months prior, the eleven contesting Political Parties signed on to the ERC "Code of Conduct" at a simple ceremony in February at the Georgetown Club to register their commitment to clean elections campaigning.

The ERC "Virtual National Conversation" on Improving Ethnic Relations

With the country still reeling from the global pandemic, the Commission took a bold step to organise the first ever national discourse on improving ethnic relations in Guyana. After much brainstorming, a decision was finally made for the event to be fully-virtual to avoid a crowded but safe environment. A Logo Competition was also launched to select best logo for the "National Conversation". A logo submitted by Mr. Godis Accra was declared the winning entry from close to one hundred submissions.

The ERC in collaboration with the University of Guyana and the Office of the UN Resident Coordinator hosted the "Virtual National Conversation" on Improving Ethnic Relations at Herdmanston Lodge, Queenstown on December 14 and 15.

Mainstream media as well as the ERC social media pages were saturated with messages to promote the event. The Public Education and Awareness Unit took a lead role in the planning and execution of the two-day event. Almost 25 presenters were canvassed to give presentations from the Youth and other segments of the society representing religion, known political

affiliation, gender balance, ethnicity, etc. to reflect diversity. Guyanese were urged to participate by asking questions, offer suggestions or follow the 'conversation.'

The fully virtual format allowed for broad participation on social media while the event was broadcast on HBTV Channel 9, TVG Channel 28 and HGPTV Channel 67. The discourse enjoyed over fifty thousand views on social media alone and thousands more watched the "National Conversation" on television. A performance representing different cultures brought the curtains down on the inaugural event.

The Unit is also tasked with investigating political hostility and religious intolerance under Article 212D of the Constitution of the Cooperative Republic of Guyana,

The Legal Officer then gives her advice, and based on her advice, the file either goes back to the Investigative Unit for further action or to the Complaints Sub-Committee for deliberation before it goes to the plenary for ratification.

Staffing

In 2020 the Unit had the following staff:

- 1) Mr. Lloyd Smith Head, Investigative Unit (He retired in the month of October 2020.)
- 2) Mr. Aidan Sparman Senior Investigative Officer
- 3) Mr. Jason Samuels Investigative Officer (He was employed during the last quarter of the year 2020.

Forms

The following forms are used by the Unit:

- 1. Complaint Form This is the standard form used for making walk-in complaints.
- 2. Investigative Log Sheets This form is used by investigators to make notes when conducting investigations.
- 3. Close of Complaint Forms This form is written up when a complaint has been deemed closed. Information on the date of closure and the reason for closure is written therein.

Activity 1 - Treating with complaints

- a. Receiving complaints via letters, email, Facebook, walk-in, etc.
- b. Acknowledging receipt of letters and electronic complaints (Not applicable for walk-in complaints).
- c. Conducting Investigations This entails sending letters to the respondent and to persons/ organizations that would be of assistance with our investigations. Also, it includes visiting various locations to obtain statements and evidence from witnesses, organizations, and respondents.
- d. Compilation and submission of reports with recommendations to the Legal Officer for advice.
- e. Sending of copies of the file with advice from the Legal Officer to the Complaints Sub-Committee thru' the CEO for their information and decision.

Activity 2 - Record Keeping

- a. Recording complaints received in the 'Record-Keeping Ledger'.
- b. Recording all complaints and the relevant data needed for reporting purposes in the Investigative Unit Database.
- c. Opening and keeping files for each complaint. These files contain the official complaint, statements, and evidence. All digital evidence is stored on the computer.
- d. Scanning and converting all old files to PDF (Electronic retention of files).
- e. Keeping all documents related to investigations in special files.

Activity 3 -Facilitation of the Complaints Sub-Committee Meeting

- a. Informing the CEO of the date and time of meetings of the Sub-Committee.
- b. Printing of spreadsheets with updates on all active complaints.
- c. Printing of reports and any other documents for the meeting.
- d. Storing of all relevant images and videos on a flash drive to view with the aid of the boardroom's Smart Television if necessary.
- e. The audio recording of all meetings.
- f. Prepare minutes of meetings and print them for perusal and adoption for the next meeting.
- g. Facilitate dispute resolution activities as directed by the Sub-Committee.

Activity 4 - Reporting and Budgeting


- a. Preparation and submission of Biannual and Annual Reports.
- b. Preparation and Submission of Annual Departmental Budget.
- c. Preparation and submission of budgets for an investigation to be conducted out of the Region/District.
- d. Preparation and submission of monthly reports for Statutory Meetings.

Activity 5 - Special Duties

- a. Upon request, work along with the PE&AU on exhibitions, community outreaches, and other activities aimed at enlightening the public of the roles and functions of the Investigative Unit.
- b. Taking complaints at exhibitions and community outreaches.
- c. Assisting the Admin Department with the conducting of any internal investigation.

Investigative Unit Data Analysis

Pie Chart - Status of Complaints as of December 31, 2020



As the Pie Chart above depicts, at the end of December 2020, the Investigative Unit successfully closed 71% of the matters brought to its attention for investigation. 26% of the Unit's investigations were still active due to reasons such as non-cooperation from respondents and persons deleting their Facebook profile.

Towards the end of the year, the Complaints Sub-Committee decided to prosecute offenders which accounts for 3% of the matters investigated by the Unit.

MEDIA MONITORING UNIT <u>Annual Report (2020)</u> Period: 01/01/20 – 31/12/20

Executive Summary

In keeping with its constitutional mandate as adumbrated in the Herdmanston Accord (1998) to promote ethnic harmony and good relations between and amongst all citizens of Guyana [ref: Constitution (Amendment) (No. 2) Act 2000], the Ethnic Relations Commission (ERC) belatedly established its Media Monitoring Unit (MMU) in 2011, to boost the Commission's institutional capacity to monitor the country's mainstream print and broadcast media and all other forms of media (inclusive of the Internet), used in the communication of information likely to influence the spread of ethnic hatred and racism in the society.

The MMU, in pursuit of the Commission's mandate, scrutinizes information communicated through mainstream and social media, political speeches and the conduct of all other related activities done at political meetings during the pre-, peri- and post-elections periods in the country, for infractions of the *Racial Hostility Act* (1964) and *Representation of the People* (Amendment) Act (2001).

Operationally, the Unit is comprised collectively of two (2) sections – a media monitoring section and an elections monitoring section. The media monitoring section of the Unit operates on a permanent basis, while the elections monitoring section is temporal and is activated seasonally to coincide with General and Regional Elections (constitutionally due every 5 years) and Local Government Elections (bi-annually).

Administratively, the MMU created and maintained its own archive of media information which is used for its own research purposes, and which can also be easily accessed for reference, if and whenever complaints or allegations of ethnic discrimination/bias or racism are received from concerned members of the public, aggrieved individuals or any organization which perceives that they have been ethnically/racially profiled or harmed in a negative way through the media.

As is known, the just concluded year (2020) was an elections year in Guyana and the MMU's focus was primarily centered on implementing and completing an elections monitoring program (EMP) across 7 regions of the country on behalf of the Commission. The results indicated that

the initiative was relatively successful in keeping to minimum, instances of racial/ethnic clashes amongst the officials and supporters of the two main contesting political parties – PPP/C and APNU+AFC. In fact, the timely implementation of program went a far way in positioning the Commission to make informed interventions to mitigate and resolve numerous instances of racial/ethnic hotspots that erupted intermittently at public meetings and on social media during the run-up to the elections, held on March 2, 2020.

In summary, the MMU, as stated before, is guided by the mandate of the ERC. And in carrying out our monitoring activities in pursuit of that mandate, the Unit was critically involved in the following activities during 2020:

- The recording, monitoring and archiving of in excess of **2500** hours of television programming with political content from 11 television stations situated in Region 4.
- The monitoring and archiving of all the daily and Sunday newspapers i.e. Guyana Chronicle, Guyana Times, Stabroek News and Kaieteur News that were produced during the period 01/01/20 31/12/20.
- The implementation over an approximately 2-months period (between Jan. 3, 2020 Feb. 29, 2020) of an external Elections Monitoring Program (EMP) across 7 regions of the country (i.e., Regions 2, 3, 4, 5, 6, 7, and 10), in the lead-up to the country's general and regional elections held on March 2, 2020. This exercise included the deployment and coordination of 40 Elections Monitors to physically monitor political meetings on behalf of the ERC.
- Provision of original evidence to the ERC in the forms of audio and video files and written statements, submitted by Election Monitors of 19 instances where ethnically offensive language and/or actions was used or indulged in by politicians and/or their supporters at political meetings, during the pre-elections period.
- Submission of media analyses to the ERC supportive of the Unit's observations of 3 instances where ethnically offensive articles (in violation of the Racial Hostility Act, Chapter 23:01) were disseminated through sections of the Print Media i.e. Stabroek News and Kaieteur News.
- Brought to the attention of the ERC, 170 instances where ethnically offensive comments were posted to the websites and Facebook pages of local media houses and political parties.

Made a total of **165** interventions on behalf of the ERC in the form of 'Cautionary Statements' posted to the websites and Facebook (Fb) pages of local media houses and political parties guilty of allowing ethnically offensive comments that were in violation of the *Racial Hostility Act*, *Chapter 23:*01 and Representation *of the People (Amendment) Act (2001)*, to remain for protracted periods on their platforms.

- At the request of the ERC, the Unit played the lead role in collaboration with the Investigative Unit, in compiling a detailed **Dossier** highlighting a list of ethnic offenses committed by politicians, prominent personalities and institutions, since the Commission's installment in February, 2018 to the end of December, 2020.
- At the request of the ERC, the MMU in collaboration with the Investigative Unit, prepared a Research Proposal to aid the Commission in assessing the feasibility of engaging in a larger study of "The impact on race relations of post-elections racial hostilities and violence observed mainly between Indo-Guyanese and Afro-Guyanese in West Coast Berbice."

Objectives of the MMU

- 1. To monitor the local media for adherence to the tenets of the Racial Hostility Act 1964 and Representation of the People (Amendment) Act (2001).
- 2. To bring to the attention of the Chairman and Commissioners of the ERC, any observed infractions of the Racial Hostility Act (1964) and Representation of the People (Amendment) Act (2001), by the print and broadcast media or by any citizen using a public space to influence public opinion.
- **3.** To evaluate complaints sent to the ERC by members of public and organizations, and offer advice accordingly on the merits/demerits of same.
- **4.** To influence a high level of sensitivity and decorum as it relates to the discussion/propagation of ethnic/race issues in public spaces.
- 5. To promote the maintenance of the highest professional and ethical standards by local media practitioners in their communication of ethnic/race issues to the general public.
- **6.** To make a measurable input into the realization of a peaceful social environment, by actively contributing to the minimization of incidences of dissemination of racism (in all its forms) through the media and/or in campaign rallies/meetings during elections periods.

Television and Newspapers

Television:

The Unit's monitoring of the programs – limited to News, Talk-shows, Call-in programs, Vox Pox programs, Political parties' sponsored programs and Press briefings - aired on the country's television stations (in Region 4) during 2020, did not result in the identification of any infractions of the *Racial Hostility Act* (1964) or *Representation of the People (Amendment) Act* (2001).

Newspapers:

The MMU's monitoring of the country's mainstream daily and Sunday newspapers resulted in the identification of three (3) instances of the publication of articles which were deemed as ethnically offensive and referred to the Commission for adjudication. The 3 publications at reference are as follows:

- A Kaieteur News column, captioned "Mercury and the Russians rigged the elections for the PPP" written by Frederick Kissoon and published in the Tuesday, May 19, 2020 edition of the newspaper, which, the Unit found to be racially inciting and inflammatory.
- II. A **Cartoon** published in the Thursday, June 11, 2020 edition of the Stabroek News, which the Unit strongly felt sent a message that was racially divisive.
- III. A Cartoon published in the Sunday, October 11, 2020 edition of the Stabroek News, which the Unit consensually felt carried a dominant message that was racially divisive.

Social Media

Overview:

The MMU targets and monitors the official websites and Facebook pages of local media houses and political parties known to be domiciled and operating within the geographical boundaries of Guyana.

Monitoring of social media on behalf of the ERC is done by the MMU in an attempt to curb the increasing use of social media to foment racial divisions in the country and to advise persons posting racially inciting, stereotypical and inflammatory comments to the comments sections of the aforementioned websites and Facebook pages, of the penalties that can be leveraged against them in a competent Court-of-Law, as spelt out in the *Racial Hostility Act, Chapter 23:01* and *Representation of the People Act, Chapter 1:03*.

Findings:

During 2020, the MMU detected and brought to the attention of the ERC one-hundred and sixty nine (169) instances of ethnically offensive comments posted to the websites and Facebook pages of local media houses and political parties. Of this number, eighty (80) postings were comments found to be racially stereotypical, fifty (50) were comments deemed racially divisive/hateful, thirty-five (35) were racially inciting/inflammatory, and four (4) were religiously divisive [Appendix 4. 65. 1]. The Facebook pages of the media houses and political parties where these comments were drawn from by the Unit are as follows: HGP Nightly News, NCN News, Capitol News, News Source Guyana, Demerara Waves Online News, News Room, Kaieteur News, Kaieteur Radio, Guyana Chronicle Online News, INEWS Guyana, Guyana Times, TVG Ch 28, APNU Guyana, APNUAFC tv, and PPP/C. From this lot, twenty-eight (28) ethnically offensive comments were found on the INEWS Fb page, twenty-six (26) on the HGP Nightly News FB page, eighteen (18) on the NCN News Fb page, fifteen (15) on the Guyana Chronicle Fb page, and twelve (12) each on the News Source Guyana and APNU Guyana Fb pages, respectively [Appendix 1 fig. 1].

Social Media Analysis:

Research has shown and established beyond doubt that social media (Facebook, Twitter, Instagram etc.) is the most popular medium of communication used by the majority of the world's population. Guyana is no exception to this fact. The most popular medium of communication used by media houses and political parties in Guyana to disseminate information to the public is Facebook.

Over the past year (2020), for statistical reasons and ease of reference, the ethnically offensive comments uploaded to the Facebook pages of local media houses and political parties, which were flagged by the MMU, were compartmentalized into four (4) distinct categories: (i) racially divisive/hateful, (ii) racially inciting/inflammatory, (iii) racially stereotypical, and (iv) religiously divisive.

The information that the Unit collated with regards to the number and frequency of interventions made during 2020, to interject the ERC's approved 'Cautionary Statements' against ethnically offensive comments, showed that the greater numbers of infractions of the country's Statutory Ethnic Laws (Racial Hostility Act, Chapter 23:01 and Representation of the People Act, Chapter 1:03) occurred in the post-elections period between July and September, 2020, peaking at its highest in July [Appendix 3. fig. 1]. This observation is unsurprising, yet significant, due to the fact that this same period (July to September) coincided with the immediate pre-, peri- and post-months of the not so smooth changeover in government (on August 02, 2020). Reflectively, it was a period when there was an upsurge in racial and political animosities between the ethnic supporters of the two main political competitors in the elections, and this was reflected, most graphically, in the verbal warfare waged, almost unfettered, between the two groups on Facebook.

Another notable observation that can be drawn from the statistical information gathered from Facebook by the Unit, is that, compared to the mainstream media, where relatively strong editorial controls are in place to filter out ethnically undesirable information from reaching the general public, the comparably less regulated environment of Facebook is a magnet for those in society bent on promoting racial/ethnic divisions.

Interestingly also, the statistics show that this is probably the first time (since the tenure of the Commission began in 2018), that religiously divisive comments were observed in the assortment of ethnically offensive posts identified by the Unit during our monitoring of Facebook. And though the number of occasions when persons were derogated on religious grounds was somewhat small and infrequent (4), it is worth mentioning because, it suggests, that religion is now being targeted as a new vista for confrontation by the racial combatants on social media.

Forecast: Local Government Elections (2021)

Without question, the major event engaged in by the MMU during 2020 was our implementation, on behalf of the Commission, of the externally-based elections monitoring program (EMP) for the country's March 02, 2020, general and regional elections (GRE). The positive outcomes and interrelated results achieved through the program by the ERC were measurable from the perspective that it was the mechanism through which the Commission was able to keep abreast of all elections-related activities in the regions. Moreover, the video, audio and written reports submitted to the MMU by field operatives (Election Monitors) during the pre-elections period, served as the basis for the ERC's interventions into the myriad contentious ethnic issues which inevitably arose on the elections campaign trail.

Looking ahead this year, other elections of a different kind beckons. All things being equal, there is every likelihood of the holding of Local Government Elections (LGE) in the country before the end of 2021. Reminiscently, the last time LGE was held in Guyana was in 2018, and the ERC, in keeping with its constitutional mandate to promote harmony and good relations, had implemented a limited EMP for the elections.

Taking into account the fact that the country has not yet fully recovered from the effects of the ethnic discord spawned during the recent general and regional elections (GRE), the MMU pessimistically predicts that because the LGE is coming so quickly on the heels of the GRE, the same ethnically divisive environment that obtained during those elections will continue into the LGE version. We (the Unit), nevertheless, would be delighted to be proven wrong on this forecast, in the best interest of the nation. If, however, our forecast holds true, the

implementation of an EMP by the ERC during the elections campaign will, as proven before, be pivotal in positioning the Commission to intervene in and mitigate those ethnic issues with the potential to boil over into open ethnic warfare.

Conclusion

Year 2020 was no doubt a busy, compact one, for the ERC, in terms of the wider array of activities the organization engaged in, in comparison to the preceding years. As the media monitoring arm of the Commission, the MMU's activities also concomitantly went up a notch or two in tandem with the organization's increased workload.

Looking back at 2020, like every other department within the ERC, the MMU contributed measurably towards the many successes of the organization in its efforts to foster harmony and good relations amongst all races and ethnicities in Guyana.

During 2020, the Media Monitoring Unit was able to, under the prevailing circumstances, organize and coordinate a limited but successful elections monitoring program on behalf of the Commission which, contributed in no small measure in giving the Commission positive public visibility in a critical national event, where ethnic peace and harmony was under severe threat of unravelling.

Likewise, the Unit's robust monitoring of mainstream and social media supported the Commission's mandate to enforce the Racial Hostility Act, Chapter 23:01 and Representation of the People Act, Chapter 1:03, against those who were wont to use the media to spread ethnic hate and violence in the country.


For the New Year (2021), the MMU looks forward to providing quality support to the ERC as it carries out its plans, policies and programs in the national interest. The Unit stands at the ready to provide timely and accurate information to the Commission that positions the body to effectively counter those persons and/or organizations who will attempt to use the media (mainstream and social), or the medium of political meetings, to spread ethnic hate and disunity in the country.

FINANCE UNIT

National Assembly approved the sum of two hundred and seven million, six hundred and sixtynine thousand dollars (\$207,669,000) as 2020 current expenditure and capital expenditure of Thirteen million one hundred twenty three thousand, four hundred and twenty seven dollars (\$13,123,427) for the Commission.

The Commission expended 100% (\$207,669,000) of its entire allocation for 2020 of which one hundred thirty-nine million and eighty-five thousand, one hundred and five dollars (\$139,085,105) for Employment Cost and sixty-eight million six hundred and thirteen thousand, eight hundred and ninety-five dollars (\$68,613,895) for Other Charges. The Commission expended 100% (\$13,123,427) of its entire capital allocation for 2020.

RECOMMENDATIONS

Recommendations from the Investigative Unit

To remedy the limitations of the unit, the following is respectfully recommended:

- 1. Recruit more investigators.
- 2. The Commission should do PSA's aimed at clarifying what matters fall within the mandate of the ERC.
- 3. The public should be sensitized of the magnitude od persons that are likely to be affected by hate speech on Facebook. Given that, according to (NapoleonCat, 2020), a **social media** data management and marketing firm which specializes in analyzing and reporting on trends on Facebook, Instagram, Twitter and other social media websites, "there were 504,400 Facebook users in Guyana in December 2020, which accounted for 63.2% of its entire population".
- 4. Enlist the service of someone competent in Cyber Crime investigation to train the staff of the Unit.
- 5. Embark on a project to amend the Racial Hostility Act and Representation of the Peoples Act or create a new act "Ethnic Relation Commission Offenses Act" which could specify the following:
 - a) Definition of key terms under the Representation of the People Act, namely racial, ethnic, hatred and violence.
 - b) Meaning of "may cause racial or ethnic violence or hatred" and special provisions on the procedural aspects of prosecuting charges of this nature, for example, eliciting evidence from expert witnesses.
 - c) Removal of duplicity in investigations where it is apparent that the words or conduct of a person was made on behalf of a political party.
 - d) Section 139E of the Representation of the People Act needs to state who shall impose the fine of five hundred thousand dollars on a political party which is found culpable.
 - e) Section 139E (1) of the Representation of the People Act needs to state the legal effect of the summon which shall be issued on the leader or general secretary of

- the political party. Summon should also be defined under the interpretation section of the Act.
- f) Both the Representation of the People Act and the Racial Hostility Act are in need of provisions which give the Ethnic Relations Commission the authority to mandate the appearance of persons to meetings to assist with investigations, their non-compliance resulting in a criminal charge of failing to treat with the Ethnic Relations Commission.
- g) Key terms should be defined under the Racial Hostility Act, particularly excite, hostility, ill-will, race and attempt.
- h) The Racial Hostility Act needs to include a provision setting out who imposes the penalty of disqualification from office under section 3.
- i) The Racial Hostility Act under section 2 fails to make it an offence for persons to be guilty of exciting hostility or ill will by their conduct. It only governs the words of the person.
- j) Both the Representation of the People Act and the Racial Hostility Act lack provisions which explicitly empower the Ethnic Relations Commission to institute proceedings and authorize prosecutions.

Recommendations from the Media Monitoring Unit

Reflecting on the MMU's work program during 2020 and the outcomes that were achieved, the Unit, as a Collective, felt that the sub-optimal results in some aspects of our work could be overcome if certain steps are taken to address identified weak areas. Going forward, the Unit offers the following proposals/recommendations for consideration by the Commission, in an effort to improve on the effectiveness of the MMU's work in 2021:

• The administrators/editors in control of media houses and political parties Facebook pages should be held accountable by the ERC for not addressing (editing/removing) ethnically offensive material uploaded to their mediums, the same way that individuals are prosecuted in the courts by the Commission for uploading racially hateful and inciting material to social media. The Racial Hostility Act, Chapter 23:01, states at Section 2 (4): "For the purpose of this section the proprietor, printer, publisher or editor of any newspaper, or the printer of any other printed document, in which any particular matter has been published, shall be presumed himself to have so published that mater unless he

proves that such publication was made without his authority, consent or knowledge and did not arise from want of due care on his part." The reading and understanding of this section of the Law is very clear. Hence, all should be held to the same standard – meaning, subscribers who violate the rules, as well as the administrators/editors who facilitate their commentary on their Facebook pages. In this regard, the ERC should, as a first step, inform the administrators of the Facebook pages of all media houses and political parties of their responsibilities and obligations under the relevant statutory laws to prevent the use of their mediums to foment ethnic hate, incitement and violence. Thereafter, media houses and political parties found in breach of the Law should be censored accordingly by the Commission. This recommendation, if pursued by the ERC, should go a far way in minimizing the instances of ethnically divisive comments being posted to the Facebook pages of local media houses and political parties, for interminable periods. It would also serve the dual purpose of making the MMU's interventions on Facebook, on behalf of the ERC, more impacting.

- The Racial Hostility Act, Chapter 23:01 and Representation of the People Act, Chapter 1:03, clearly and unambiguously prescribe penalties for engaging in acts of racial hatred,
- Incitement and discrimination. In recognition of the new trend emerging on social media, whereby religion has been added to the arsenal of weapons being used by racial combatants on social media and on the hustings, the MMU proposes to the Commission that it seeks Parliament's approval for the enactment of legislation with attendant penalties to dissuade the weaponizing of religion for the express purpose of spreading ethnic discord in the society.
- In order to keep abreast of the new and advanced technologies driving the use of social media, the MMU recommends to the Commission that, arrangements be put in place during 2021, for Media Monitors be given appropriate training in cyber tracking and user-identification techniques, to supplement current knowledge in those areas. This proposal is intended to build capacity within the Unit to carry out Facebook tracking and identification tasks more efficiently and effectively.

CONCLUSION

The year 2020 certainly presented a number of external challenges that resulted in the Commission honing its workplan. It is reasonable to deduce that Covid 19 and the political impasse further generated high ethnic tension in the country and the Commission did its best given the circumstances to engage key leaders to stymie and quell ethnic instability at a national level.

Key in the Commissions quest to bring about healing and reconciliation was its thrust to have a virtual national conversation for all to participate and have honest and frank conversations on solutions to mend the apparent ethnic divide and improve race relations among all Guyanese.

The Commission would like to express sincere gratitude to everyone who participated in its programme of activities and provided logistic support to our team to make our regional engagements fruitful and safe. Your commitment to avail yourself to meet with commissioners and staff to discuss ways to collectively achieve a more socially inclusive and cohesive country for all Guyanese is appreciated.

THE ETHNIC RELATIONS COMMISSION CODE OF CONDUCT FOR POLITICAL PARTIES CONTESTING THE GENERAL AND REGIONAL ELECTIONS 2020

The Leadership and membership of the *undersigned parties* agree to uphold the provisions of the Constitution of the Cooperative Republic of Guyana, with specific reference to the following articles and Acts:-

- 38 G Public Service to be free from political influence,
- 146 Protection of the freedom of expression,
- 147 Protection of freedom of assembly, association and demonstration,
- 149 Protection from discrimination on the grounds of race etc,
- 160 A Political parties prohibited from causing ethnic division,
- The Racial Hostility Act and
- The Representation of the People Act

and recognises that peace and public order, freedom of political campaigning, and compliance with the Guyana Constitution, electoral laws and regulations are essential and of paramount importance to the conduct of free, fair and peaceful elections.

In furtherance of the objectives, we, the leadership and membership of the *parties* declare and affirm:

Our Party opposes and rejects the use of violence and intimidation or plans of this
nature during the campaign, on election day and after the results are announced,

- Forbids the use of threats, harassment or tendency to violence that might cause disruption whether at political rallies, meetings, gatherings or elsewhere, or any other form of intimidation, including the use of violence and intimidation while political parties are announcing their activities, holding their meetings, gatherings and rallies.
- Forbids the use of threatening language, or language which incites people of one group to violence against any Candidate, Agent, member or supporter of any other group
- Forbids all actions aimed at removing, defacing, besmirching, obscuring, destroying, damaging or altering any flag, banner, poster, notice or other campaign materials of other Political Parties.
- Forbids the use of intimidating behavior or violence on Election Day to frighten
 people from going to the polls to vote, or whilst they are in the polling stations or
 leaving the polling stations.
- Our Party respects the rights of each Political Party, its Candidates, Agents, members and supporters to express and demonstrate their political views and to conduct lawful, non-violent activities in support of their objectives.
- 3. Our Party opposes and rejects any intimidation of media personnel while maintaining our Party's right to respond, in a factual manner, to any obvious and evident media transgressions.
- 4. Our Party will insist that its candidate, Agents, members and supporters avoid behavior, including making speeches or statements that promote racial or ethnic

tension or incite people to violence, and to uphold the Racial Hostility Act and the Representation of the People Act.

- 5. Our Party members and supporters will be encouraged by senior party officials, both directly and indirectly, to refrain from any expression or action that may constitute hate speech or any form of racial or ethnic discrimination.
- 6. Our party will immediately condemn any form of hate speech by their own members or supporters and institute necessary sanctions.
- 7. Moderators of our party will remove immediately any form of hate speech, whether in shape of posts or comments of social media accounts used by the political party.
- 8. Our party will, individually and together, issue public service announcements condemning any form of hate speech.

In doing so we shall observe this Code of Conduct and report and bring to the attention of the *Ethnic Relations Commission* any such acts.

The Leadership and membership of *our parties* agrees that our failure to abide by any of the provisions of this Code of Conduct will render *our parties* liable for breach of Agreement and necessary actions and sanctions may be implemented against *our parties* by the Ethnic Relations Commission in the said circumstances.

We anticipate in good faith that the ERC in keeping with its constitutional mandate will act with alacrity and investigate with speed and intervene to prevent such acts, protect the citizens and ensure that the 2020 General and Regional Elections are safe, peaceful and free from fear.

PRESS STATEMENT

As the campaigns for the various Political Parties continue in the run-up to the March 02 General and Regional Elections, the Ethnic Relations Commission (ERC) remains concerned over reported incidents of intimidation and abuse meted out to Party Officials while they were engaged in activities to sensitize on political messages reflective of the Parties they represent.

The Commission is also concerned about the use of language that can be considered as combative and disrespectful to the point of even being threatening in some instances.

The ERC firmly believes that those actions and utterances are counter-productive to the valiant efforts being made to foster unity and harmony. Those have no place in our society and restraint from all sides is urged while tolerance and respect for each other are encouraged.

The call for the upcoming elections to be transparent, free of hate, violence and racial or any other forms of incitement, is firmly reiterated.

The Commission, through its Monitoring Unit, will continue to the best of its ability, to monitor public meetings and related media coverage. It wishes to remind that some actions and utterances can constitute offences under the Representation of the People Act and the Racial Hostility Act. Given what has transpired in some instances in the campaign thus far, the Commission sees the need to re-engage the political leadership with the intent to derive a collective effort for respectful and incident-free elections' periods; pre, polling and post. It therefore calls on all involved to endeavor for positive campaigns which can inspire national harmony and good relations amongst all of our peoples.

The Commission wishes to remind that our freedoms are enshrined and allow each and every Guyanese the democratic right to freely associate and support a Political Party of his/her choice. That must be respected.

The ERC, during interactions with various Political Parties, proposed the signing of a Code of Conduct relevant to the elections period. A draft was shared with the Parties for suggested inputs. The Commission remains optimistic for a public signing in the near future. The Commission also anticipates a similar Code of Conduct from the Guyana Elections Commission (GECOM). It is hopeful that upon signing, the content of both would be honoured.

In an effort to encourage tolerance and mutual respect, the Commission continues its sensitization campaign through the media, both traditional and non-traditional. This follows numerous engagements with residents in areas across the ten Regions of Guyana.


That has been augmented by the conversion of the play, "I Am Us", into a movie which was launched on January 15 with public screenings scheduled from January 17-24 at Caribbean Cinemas, Giftland Mall.

The Commission encourages attendance and seeks the assistance of the media for continual airings of its harmony song, "Let Harmony Come In". It firmly believes that incidents of

harassment and incitement, including what is very noticeable on social media, are most unhelpful to building and sustaining a cohesive nation. All are encouraged to work in the best interest of Guyana and Guyanese, and to ensure that the elections are not mechanisms for division.

The Commission will, in the near future, embark on education initiatives to examine inherent causes which have led to current suspicions and stereotypes and explore possible mitigating measures. It remains convinced that education is the key to help change mindsets for the removal of stereotypes. To this end, the Commission will continue to prioritize educational programs in 2020.

Through its investigative arm, the Commission dealt with sixty-one (61) complaints during the year 2019 of which forty-four (44) have been brought to a closure; twelve (12) to be reviewed and five (5) remain active. The complaints received were of racial/ethnic and religious discrimination.



The Commission remains accessible to members of the general public through all means of communication.

The ERC will continue in its endeavours, through available resources, to deliver its constitutional mandate. With inherent challenges, the realization of that mandate necessitates the collective efforts of all stakeholders. It wishes to commend those who have demonstrated unwavering support and encourage others to join in its efforts.

ERC CONDEMNS BEHAVIOUR OF POLITICAL SUPPORTERS ON CAMPAIGN TRAIL

The Ethnic Relations Commission, (ERC), condemns the unacceptable conduct of purported supporters of contesting political parties over the past few days, which have resulted in heated confrontations in different parts of the country, such as at Wismar and Non Pariel.

The Commission calls on political leaders to urge their supporters to immediately stop and reject any inclination by their supporters to taunt, confront and intimidate others of opposing sides. The ERC is engaging political leaders on those developments and its proposed **Code of Conduct** as well.

The ERC wishes to remind that under the Laws of Guyana, campaigning by political parties during the elections period is allowed, but wants citizens and supporters to reject outright all attempts at provocation, and instead concentrate on issues being put forward by the candidates.

The ERC will continue to monitor the political campaigns with vigilance and play its role in promoting harmony, good relations and peace in our society.

A MESSAGE FROM THE CHAIRMAN, ETHNIC RELATIONS COMMISSION (ERC) ON THE UPCOMING MARCH 02, 2020 GENERAL & REGIONAL ELECTIONS

My dear brothers and sisters of Guyana, as we head to the polls on March 02, the Ethnic Relations Commission reiterates its call for peaceful, fair and transparent elections. For this to be realized, it will take the collective effort of all of us regardless of preference.

Voting is a democratic right which enshrines choice. As we exercise the right to choose, we must respect the rights of others to do so. In the process, we must also remain cognizant of the need to be tolerant and respectful of each other, now, during and after March 02.

As we traverse what is historically a sensitive period, all are urged to work in the best interest of Guyana and Guyanese and not be engaged in activities, in any shape or form, that are counterproductive to the fostering of harmony and good relations.

Let us also strive to strengthen the bonds of brotherhood and sisterhood and to ensure that the will of the Guyanese people is respected following the elections.

On behalf of the Commissioners and Staff of the ERC, I extend best wishes to all involved and remind that peace, during and after the process, is in the hands of all of us.

PRESS STATEMENT

The Ethnic Relations Commission, (ERC), has concluded its investigation into the complaints made by the Private Sector Commission of Guyana and Captain Gerald Gouveia. The complaints stemmed from a July 24, 2019, letter which was written by Mr. Desmond Trotman to Captain Gouveia, in his capacity as Chairman of the Private Sector Commission.

The Commission appointed a special Sub-Committee on November 8th, 2019 to investigate the said complaints. Spearheaded by Retired Justice Stanley Moore, as Chairman, the Sub-Committee was mandated to "establish the facts of what transpired and why?"

Both parties to the investigation (Captain Gouveia and Mr. Trotman) have arrived at an amicable settlement.

The peaceful settlement of this dispute illustrates that when complaints are made to the ERC, the Commission has the mechanisms and capability of working for the restoring of harmony and peace where discord and disagreement formerly existed.

ERC WRITES POLITICAL PARTIES & MEDIA ENTITIES ON ELECTION RELATED ISSUES, 2020-02-27

The Ethnic Relations Commission (ERC), as of February 25, 2020, has officially written to a few political Parties contesting the upcoming March 02 General and Regional Elections to cite them for public utterances, behaviors and advertisements deemed unhelpful to the process of promoting harmony and tolerance.


Through its Elections Monitors, whom have so far monitored a high percentage of the public meetings of all the political Parties, it has been observed that the use of ethnically divisive language and the use of religion to disparage, racial and political profiling/stereotyping and disruption, were generally found to be used on various occasions.

From the numerous incidents flagged, twenty-one (21) warranted official responses; eleven (11) to Lt. Col. (Ret'd) Joseph Harmon, General Secretary of APNU (for both APNU+AFC) and eight (8) to Dr. Bharrat Jagdeo, General Secretary of the PPPC. In addition, two (2) incidents are under active investigation.

The Commission through its Media Monitoring Unit, (MMU), monitored the Facebook Pages of various News Agencies, print media and television programmes. It was found that numerous persons made ethnically offensive comments under the posts made by the various news agencies. The Commission, in response, cautioned those persons for making such comments and has called on the Editors-in-Chief of INEWS, Demerara Waves, HGP TV Nightly News and NCN News to stringently monitor their Facebook Pages so as to ensure ethnically offensive comments are removed in a timely manner.

In addition, A New and United Guyana, (ANUG), has been written to regarding one of its advertisements that was deemed to be unhelpful to ongoing efforts to eliminate inherited racial stereotypes.

In all of the cases that necessitated a response, the Commission reiterated the need for a more responsible approach by all Parties and the need for collective effort to aid the process of fostering national harmony. In January this year, the Commission established a temporary Swift Response Committee, specifically mandated to review the findings of our Elections Monitors and the Media Monitoring Unit. To date the Swift Response Committee dealt with thirty-four incidents. Please see graph below.

Electoral process free and fair – results must be respected

The Ethnic Relations Commission, (ERC), having observed the electoral process in some Polling Stations in parts of Regions 3, 4, 5, 6, and 10, has found it, despite some minor hiccups in a few instances, to be free, fair and transparent.

Overall, voters were able to cast their ballots in an atmosphere of peace while few instances which necessitated the intervention of law enforcement, were timely resolved.

The Commission commends the collective efforts of all involved for ensuring that democracy was safeguarded and prevailed during the electoral process. This is heartening and vital to the promotion of harmony and good relations.

As the country awaits the final results, the Commission remains mindful of prevailing anxieties. It fervently hopes that the results will be announced within the shortest possible time and that it will be respected.

The Commission is also mindful of racially inciting exchanges on social media. Such posts are extremely harmful to the process of building harmony and tolerance which are crucial during this sensitive period.

All are therefore urged to act in a responsible manner and to be reminded of consequences that can be brought to bear through the Racial Hostility and The Representation of the People Acts. The rejection of hatred and intolerance take the collective efforts of all. The Commission encourages all, especially during this period, to do the best we can to ensure that peace and harmony prevail.

CREDIBLE ELECTIONS VITAL TO PEACE AND HARMONY

The Ethnic Relations Commission, (ERC), wishes to state that the holding of free, fair and transparent elections is a vital tenet of democracy and for the promotion of unity, harmony and good relations. The credibility of the elections is therefore paramount.

The Commission, having observed the voting process in some Polling Stations in 5 Administrative Regions, found it to be free, fair, transparent and conducted in an atmosphere of peace.

However, the declaration of results for Region 4, after an incomplete verification process, has now cast doubts over the credibility of the March 02 General and Regional Elections.

Having delivered a credible voting process, the Guyana Elections Commission (GECOM) is urged, in the best interest of peace and harmony, to safeguard the integrity of the elections by ensuring that the verification and tabulation process, as reflected in The Representation of the People Act, is followed. Transparency of this process becomes foremost.

The historical lessons and the inevitable consequences over elections, must guide during this sensitive period. All stakeholders therefore have a responsibility to work assiduously to ensure that the prevailing tension does not escalate.

The Commission also urges political Leaders to work in the best interest of the country by endeavouring to diffuse tension and not to encourage behavior that is counterproductive to peace and unity. The need for responsible utterances and actions by all, is reiterated as peace and unity are in our hands.

The Commission will continue to work to the best of its ability to aid the promotion of harmony and good relations especially during this period. All are therefore urged to meaningfully do his/her part.

In fact, the Commission wishes to point out that persons can be prosecuted for offences under the Racial Hostility and Representation of the People Acts, as well as the country's Cyber Crime Laws. The ERC continues to monitor Facebook and the various social media platforms.

The body is pleading to all Guyanese to exercise tolerance and respect for each other throughout their daily lives.

<u>LET PEACE PREVAIL AS GECOM PREPARES TO MAKE SIGNIFICANT ANNOUNCEMENT ON MARCH 02 ELECTIONS, June 14, 2020</u>

The Ethnic Relations Commission (ERC), like all Guyanese, is mindful of the extended period it has taken thus far for the results of the March 02, 2020, General and Regional elections to be declared. The Commission is also mindful of the discontent the wait for the declaration has inevitably precipitated among our people and concerns that eventually led to a national recount of ballots cast.

As a Commission birthed out of political discord and which is constitutionally mandated to foster harmony and good relations, it was extremely heartened when H.E. President David Granger and Leader of the Opposition, Dr. Bharrat Jagdeo, agreed to the national recount of ballots under the auspices of CARICOM.

Despite challenges, the recount has ended, the obligatory report by the Chief Elections Officer has been submitted and the nation awaits an announcement by the Chairperson of the Guyana Elections Commission (GECOM). The Commission therefore wishes to take this opportunity to urge all Guyanese to remain calm and to demonstrate a profound sense of tolerance and respect in view of the significant announcement expected from GECOM.

This crucial call for calm and peace comes within the historical context of what unfortunately transpired during elections; the vitriol, divisive and inciting rhetoric on social media; undesirable public pronouncements by some involved and in keeping with the Commission's own call prior to and immediately after March 02.

The Commission in a press statement on March 04, 2020, which alluded to its initial findings having observed the electoral process in some Polling Stations in parts of Regions, 3, 4, 5, 6, and 10, commended the collective efforts of all involved for ensuring that democracy was safeguarded and prevailed during the said process.

In addition, the Commission, having pointed out that overall on elections day voters were able to freely cast their ballots in an atmosphere of peace and that the few instances which necessitated the intervention of law enforcement, were timely resolved, the voting and counting processes observed, were found, despite some minor hiccups, to be free, fair and transparent.

The adherence of those processes to the basic tenets of democracy is vital to the promotion of unity, national harmony and good relations. While anxieties unavoidably prevail over the impending announcement and what it can possibly derive, the Commission calls upon the leaders and members of all political parties, civil society organizations, constitutional bodies and Guyanese in general, to act in a responsible manner in an effort to safeguard the interest of Guyana and all of its citizens.

The ERC also urges that the results, when announced, be respected and reiterates its call for the implementation of a necessary collective effort from all national stakeholders endeavouring to build a cohesive and prosperous nation. All are encouraged to do his/her best to ensure that peace and harmony prevail and that the interest of Guyana and Guyanese is placed foremost.

ETHNIC RELATIONS COMMISSION MEETS WITH "GUYANESE CRITIC" ON RACIAL STATEMENTS MADE.

The Ethnic Relations Commission (ERC), having received a number of complaints, today met with Mr. Mikhail Rodrigues popularly known as Guyanese Critic regarding statements made by him on 15 June, 2020 during his live Facebook program. Those statements were viewed as insensitive, unethical and anti- Guyanese and caused outrage among the Christian and Black communities. It was an attack on the religious beliefs of the Christian community and insulted the intellectual intelligence of Afro-Guyanese. Such conduct is an affront against the bedrock of a unified Guyana.

Mr. Rodrigues has accepted his wrongdoings and it is in light of this that he offered a public apology. He has also made an undertaking to the Commission to do all that is necessary under his platform to promote amity. One of the mandates of the Commission is to encourage mediation in amicably resolving disputes whenever necessary. One of the purposes for punishment is to foster the rehabilitation of offenders. Restitution is not always of paramount concern, and it is in these circumstances that Mr. Rodrigues has been sternly cautioned that any recurrence of his irresponsible remarks will warrant prosecutions against him by the Commission for his conduct.

The Commission reminds all and sundry that it is a criminal offence under the Representation of the People Act, Chapter 1:03 and the Racial Hostility Act, Chapter 23:01 for anyone to incite racial hatred or violence against any person or against any segment of a society. Racial prejudice is not merely a wrongdoing against morality but it is conduct contrary to the laws which were instituted to abolish and eradicate the antiquated, disruptive, divisive weapon of racism. Anyone convicted of an offence under the Representation of the People Act shall be fined a sum of one hundred thousand dollars together with two years of imprisonment. Anyone convicted of an offence under the Racial Hostility Act shall be fined the sum of five hundred thousand dollars and seven years of imprisonment.

It is imperative that Guyanese understand the seriousness of exciting any form of hate. The Ethnic Relations Commission encourages the understanding and acceptance of diversity in all aspects of national life as we aim to eliminate the issue of racial and religious profanity. Irrespective of the differences in our beliefs, ethos and culture we are and continue to be "One People, One Nation and One Destiny".

The Ethnic Relations Commission, (ERC), undeniably supports an articulate and free press which contributes to the good tenets of a democratic nation. It embraces the right to criticise persons in public office; however, that freedom of expression is not an unfettered right. It should not be exercised with a level of disparagement which exceeds criticising the conduct of those in public office and amounts to statements grounded in absolute falsehoods.

The Commission takes umbrage in individuals making libellous statements in their personal bid to generate confusion in the interplay of politics and against the good will of the Commission. Mr. Lenox Shuman on 25 June, 2020 during a live Facebook stream of the Kaieteur Radio show made damning imputations of corruption by the Chairman of the Ethnic Relations Commission and by extension, the Commission in its entirety.

His utterances have been reposted via social media numerous times and have exposed the ERC to hatred, contempt and ridicule. Such an attack against the Commission is defamatory in nature. Any reasonable person hearing the words uttered by Shuman would come to the conclusion that his proclamations have brought the integrity of the Commission into disrepute.

The statements directed towards the Commission are not only an untruth but it is the type of sensationalism which, during this tense election period has had damaging repercussions against the execution of the constitutional mandate of the Commission.

The Commission assures the public that it takes pride in operating in the interest of what is just and fair and it is a reflection of safeguarding the concerns of all Guyanese. Its standard operational procedures exemplify impartiality and transparency.

The Investigative sub-committee of the Commission embodies a mixed panel of professionals representing diversity of race, religion, gender, age and even political affiliation. Decisions made on behalf of the Commission are done collectively by the members of this panel and are not at the discretion of the Chairman of the Commission. Any unwarranted attack against the functions of the Commission is viewed as an attack against the restoration of peace and stability for our people.

Press Release

The Ethnic Relations Commission, (ERC), has been diligently conducting investigations into complaints received and has been adopting measures to bring amicable resolutions to racial and ethnic issues in the execution of its constitutional mandate.

The Commission, through its Investigative Sub-Committee arm, has conducted mediation sessions touching and concerning adversities surrounding racism in the work force and racial conflicts in land occupation and land allocation. A mediation exercise was completed at the Fort Wellington Dental Department, WCB, where accusations were made of racial partiality in the performance of professional duties and discriminatory discipline of staff on the basis of race. During the mediation, the health officials gave an undertaking to work in unison and emotional apologies were made.

The Commission, through that exercise has made recommendations for departmental changes which include effective systems of record keeping and human and social development of staff through counselling and training.

A team recently mediated in the community of Mon Repos, ECD, where land conflict evolved into racial tensions. In addition to the mediation session, the Commission has been working in conjunction with the Lands and Surveys Commission to settle allegations of land encroachment, a matter in which the ERC expects an imminent resolution.

Racial allegations have also been made surrounding the unlawful repossession and allocation of land under the control of a co-operative society. The investigative team of the Commission worked closely with the Co-operative Development and Societies Department in addressing the concerns of the members. This matter is currently still under investigation as the Commission awaits the submission of important documents in the case.

Anonymous complaints have been made to the Commission involving state entities. In particular, an anonymous complaint was made citing racially prejudiced promotion practices of the Guyana Police Force. However, during the course of the investigations, that matter has since resolved itself. An anonymous complaint was also made against the recruitment practices of the Bureau of Statistics.

Nevertheless, though the Commission is committed to treating certain information as confidential, there has been little progress in that investigation as persons are not coming forward with information.

A majority percentage (87.2%) of the complaints received by the ERC regard incidents on social media, more specifically Facebook with a total of 89 complaints out of 102. The Commission's capacity to productively investigate those complaints is limited by factors such as the use of fake profiles to make racially insensitive posts or comments and in the case of active profiles, there are challenges such as private user profiles or the unavailability of the accused person's legal

name, address or contact information, or the accused residing out of Guyana, making jurisdiction an issue.

As a result of those limitations, the Commission has adopted two courses. First, it has published the posts and faces of persons whom complaints have been made against through social media in the "Persons of Interest" initiative. This has generated positive feedback with the public's assistance and in some cases the co-operation of the accused.

Individuals such as Chaitram Goberdhan aka Bounty, Lucra Adams, Lashana Chester, Mollyann Moonsammy, Marcel Haymer and Tifany Greene have contacted the Commission. The practice of publishing persons of interest will be done periodically and the Commission is relying on the public's assistance in identifying offenders.

Secondly, the Commission met with the Criminal Investigations Department, Cyber Crimes Unit and the two agencies are on a productive path of working together. Some of the complaints received by the Commission do not offend against the Racial Hostility Act nor the Representation of the People Act but instead are criminal offences to be investigated by the police. Those complaints have been referred to the police for necessary action. Eight Facebook incidents fall in that category (7.8%).

One complaint of an incident in the real world fell under the jurisdiction of the police and evoked summary court proceedings (0.98%). Furthermore, one complaint (0.98%) falls outside of the ambit of the ERC but is a matter to be investigated by the Women and Gender Equality Commission.

The Commission has also investigated complaints made against public officials, for instance, the Mayor of Bartica is currently under investigation. Since the publication of his name in the" Persons of Interest", he has undertaken to co-operate with us.

Despite the many impediments, some beyond the control of the ERC, the Commission has been tirelessly working to promote harmony and good relations in our ten administrative regions.

ERC CONDEMNS SENSELESS KILLINGS OF TEENS AT COTTON TREE, WCB

-calls for swift action by the Police

The Ethnic Relations Commission, (ERC), strongly condemns the senseless killings of the two teens, Joel Henry and Isaiah Henry at Cotton Tree, West Coast Berbice over the weekend and calls for swift action by the police to apprehend those responsible. The Commission is pleading with Guyanese, especially those residing in the West Coast Berbice and nearby communities to remain calm and allow the Police to do their work.

The ERC remains firm that, first and foremost, the law must take its course. The Commission therefore, appeals to Guyanese to desist from any activity which can contribute to unnecessary tension as it is hopeful that those responsible will be brought to justice.

The Commission also strongly urges leaders, both nationally and at the community levels, to demonstrate responsible behaviour and to not use the pain of this tragedy to heighten racial tension. The ERC extends condolences to the relatives and friends of the young men whose lives were cut short in a heinous manner.

The ERC remains committed entirely, which it is fully empowered to do, to taking whatever course of action it deems necessary to assist in the de-escalation of tensions and the mending of fractured relations among citizens. The ERC reiterates that investigations by the Police must first take precedence before the ERC acts to defuse any unwanted developments resulting from the tragic occurrences a few days ago.

ERC CALLS ON JOINT SERVICES TO RE-ESTABLISH LAW AND ORDER ALONG EAST COAST AND WEST BERBICE

The Ethnic Relations Commission, (ERC), cognizant of the challenges and complexities that resulted in protest actions which erupted following the deaths of Isaiah and Joel Henry, Haresh Singh and Prittipaul Hargobin, and having recognized the ongoing efforts of law enforcement to bring the situation under control, is calling on the Joint Services to ensure the East Coast and West Berbice corridors are sanitized, blockades removed and law and order restored.

The Commission congratulates the Joint Services for exercising considerable restraint while encountering rising adversity in its efforts to restore normalcy. However, the ERC remains deeply concerned at the atrocities being committed during those protests which have been unhelpful to efforts of improving race relations in Guyana.

The Commission notes that, worthy of praise are the public appeals made by both President Dr. Irfaan Ali and Ms. Volda Lawerence, Chairman of the PNCR and, even the father of one of the victims against the spiraling cycle of violence and destruction which have claimed more lives.

The ERC believes the efforts of the Joint Services can reassure citizens of their safety and wellbeing while serving to reduce tensions and hindrances to the Police conducting investigations. The Commission also calls on the hardworking men and women in uniform to urgently conduct more effective patrols along the affected roadways including aerial reconnaissance of the situation on the ground.

The Commission empathizes with the grieving families in their calls for justice and reiterates that it will take the necessary course of action, within the confines of its constitutional mandate, to assist in the de-escalation of tensions. The body also remains committed to taking whatever course of action it deems necessary to promote ethnic harmony and good relations throughout Guyana.

The ERC, being a non-political body, reminds all to demonstrate tolerance and appreciation towards their fellow citizens, regardless of ethnic background in this very challenging period.

The Commission remains very concerned over the proliferation of race hate and incitement on social media and believes that President Ali's announcement is therefore most timely and invaluable to improve race relations among our people.

The Commission is available and stands ready in support wherever it can.

ERC VISITS WEST COAST BERBICE FAMILIES

ERC Chairman, General Bishop, Reverend John Oswald Smith, Commissioners and staff on Thursday, September 17, 2020, visited the grieving families of the Henry cousins, Isaiah and Joel and Haresh Singh, offering prayers and words of comfort to parents and guardians of the slain youths.

The team visited the homes, still overwhelmed by complete sadness as parents and relatives repeated their on-going plea for justice to be served. The murdered young men all lived a short distance away from each other in the closely-knit community.

The ERC team witnessed first-hand the Henry families are of mixed ancestry and relatives are from both major ethnic groups. The adult relatives were vocal and expressed shock that the murders were being promoted as crimes of race hate. They suggested that residents in the community are not pre-occupied with racial intolerance.

During the visit, relatives informed the team that the Police were still in the backlands of the community conducting investigations. The ERC Chairman told the grieving families to remain hopeful of the outcome of the investigations.

The ERC, as a non-political body, remains entirely committed to fostering peace and unity in the Guyanese multi-ethnic society, while the recent tragedies have brought to the fore the importance of tolerance and understanding among all.

ERC INVESTIGATING DANGEROUS SOCIAL MEDIA POST ALLEGEDLY ATTRIBUTED TO CATHY HUGHES

The Ethnic Relations Commission, (ERC), has immediately commenced an investigation, having been made aware of a social media post calling for an undesirable and dangerous action which can potentially impact negatively on ethnic relations. The post purportedly emanated from former Minister of Communications and current Member of Parliament for the APNU/AFC coalition, Mrs. Cathy Hughes.

As part of the process, Mrs. Hughes was asked to provide an explanation. She disassociated herself from the post in question and indicated that her social media comments on another matter were doctored to derive the post that led to much concern.

The Commission will continue its investigation to first ascertain the authenticity of the post and then decide on any action that may be deemed necessary.

Having only yesterday (December 15) concluded the first round of a national conversation on how ethnic relations can be improved, the Commission reiterates that any form of incitement or race hate, has no place in our society and encourages all to refrain and be responsible when making public comments.

ERC COMMENCES LEGAL ACTION AGAINST DEFAULTERS

The Ethnic Relations Commission, (ERC), has commenced legal action against three individuals who had separately committed offences capable of resulting in racial or ethnic violence or hatred among the Guyanese people. The Commission, through its lawyer Mr. Stanley Moore, SC filed the complaints in the Georgetown Magistrates Court earlier this month.

The three defendants- John Gobin, Steve Anthony Barakat and Lashona Chester were arraigned before city Magistrate Rhondel Weever on December 9. Based on the specific nature of their conduct and words, the charges against the defendants included causing ethnic/racial violence or hatred and exciting hostility or ill-will on the basis of race.

Gobin pleaded guilty and was fined \$20,000. The Magistrate warned him not to repeat the offence or publish any similar material in the future. Barakat pleaded not guilty and was placed on \$30,000 bail. He was represented by Attorney -at-Law Latchmie Rahamat and his matter was adjourned to January 20, 2021 for trial.

The complaint against Lashona Chester could not be served despite vigorous attempts to locate her. The Magistrate ordered that steps be taken to summon her again and adjourned Chester's matter to January 20, 2021 as well.

Elections Report (2020)

Period: Jan. 3, 2020 – Feb. 29, 2020

Summary

Following the public announcement of the holding of General and Regional Elections on March 02, 2020, the ERC in pursuit of its constitutional mandate [ref. Constitution (Amendment) (No.2) Act 2000] to promote harmony and good relations between and amongst the country's citizens, officially launched a dedicated elections monitoring program (EMP) over an approximately 8 weeks period between **January 03, 2020 to February 29, 2020**. It was initiated primarily to ensure that electioneering activities engaged in by the contesting political parties in the run-up to the elections was done within the parameters of the country's ethnic Laws as spelt out in the Racial Hostility Act (Cap 23:01) and the Representation of the People (Amendment) Act No. 1 of 2000.

Notably, the Constitution (Amendment) (No.2) Act 2000 at 212D (c) gives the ERC the power to: "make recommendations on penalties, including prevention of any political party or any person from participating in elections for a specified period, to be imposed for any breach of the provisions of this Constitution or any law dealing with ethnicity."

In a bold attempt to operationalize the constitutional authority vested in the organization to influence conformity to the country's ethnic Laws by all citizens, the ERC implemented its elections monitoring program as a mechanism to minimize in the least, or eliminate at the most, ethnic tensions, which, sadly, tend to rise up and proliferate throughout the country during elections periods.

The ERC's elections monitoring program was done on two (2) levels – i.e. elections monitoring (field exercise) and media monitoring (in-house). The elections monitoring aspect of the program was specifically designed to gather information from political meetings – in the forms of posters, handbills, flyers, audio-recordings of speeches, etc. – and to evaluate same for conformity to the

aforementioned extant ethnic Laws of the country. On the other hand, the media monitoring portfolio encompassed the monitoring and analysis of the traditional broadcast media (television), print media (newspaper), on-line radio stations, and social media, for similar adherence.

In order to accomplish its main objective of promoting harmony and good relations during the period leading up to the elections, the ERC through its Media Monitoring Unit (MMU) trained and deployed forty (40) Elections Monitors (EMs) to gather and supply information on the environments at political meetings relative to the content of political speeches delivered and literature distributed, and crowd reactions/behaviors, so that the Commission could be kept abreast of what was happening on the ground, and where to make timely interventions to deescalate political and ethnic tensions. By the end of their stint (on Feb. 29, 2020), the EMs had monitored on behalf of the Commission some 425 meetings, spread across 7 of the 10 regions of the country.

Administratively, the ERC's entire elections monitoring program was coordinated by an internal sub-committee established by the Commission, called the Swift Response Committee (SRC). The SRC came into being on Feb. 3, 2020, and was chaired by Commissioner Neaz Subhan, and included Commissioners Barrington Braithwaite and Roshan Khan, Mr. Remington Eastman (Head, Media Monitoring Unit), Mr. Lloyd Smith (Head, Investigative Unit), Mr. Renee Chester (Head, Public Education and Awareness Unit), Mr. Aidan Sparman (Senior Investigative Officer) and Ms Kimberly Yearwood (Legal Officer). During the approximately 4 weeks of its sojourn (from Feb. 3, 2020 to Feb. 28, 2020) the SRC continuously met as a group to discuss and act swiftly on reports that came to it from the MMU for adjudication. On a daily basis, the MMU compiled reports on matters to be addressed by the SRC. These reports were culled from the daily field reports the Unit received from the ERC's election monitors, and its own monitoring of the print, broadcast and social media.

In a nutshell, the results achieved from the Commission's implementation of its elections monitoring program are as follows: at the level of monitoring of the political meetings, the EMs identified 16 instances where ethnically offensive comments were made by speakers; 3 instances

where inflammatory language was used; and 4 instances where political meetings were disrupted/truncated due to politically partisan behavior from the spectators. And at the level of its media monitoring operations, the MMU, on behalf of the ERC, made 12 interventions on the websites and Facebook pages of prominent media houses and one (1) political party to dissuade bloggers from posting ethnically offensive comments. Moreover, based on the information it was provided, the SRC made 18 interventions on behalf of the Commission by way of letters dispatched to political parties and on-line media houses found not to be applying editorial restraint over ethnically offensive comments posted by contributors to their websites and Facebook pages.

2.0 Elections Monitoring Program (Field exercise)

The field exercise aspect of the Commission's Elections Monitoring Program (EMP) was underpinned by the training and deployment of Election Monitors (EMs) across the country during the pre-elections period to achieve the following objectives:

- To gather first-hand information of what is being communicated to citizens by politicians offering themselves for election to the country's parliament and regional councils.
- To provide the ERC with the necessary documented evidence and witness validation that
 would allow the organization to leverage its constitutional authority against those who
 may seek to use ethnicity/race as a means of inciting and/or exciting audiences in order to
 achieve political power.
- To influence through their presence, self-regulation (or self-control) in speeches made by politicians at political rallies/meetings etc. [In other words, the Election Monitor's presence is intended to induce a high level of decorum and responsibility by politicians as it relates to the way they treat with ethnic/race issues].

In total, three (3) training workshops were held (between Dec. 7, 2019 and Jan. 25, 2020) for potential Election Monitors, out of which fifty-three (53) persons were trained by the MMU to perform the duties associated with the position. However, due to attrition, by the end of the pre-election period (i.e. Feb. 29, 2020) only 40 persons were actually still working as Election Monitors. During the training process, Election Monitors were given knowledge of the ERC's constitutional functions and authority and further sensitized to the tenets of the country' ethnic Laws and what to look for in speeches, literature and behaviors at political meetings.

Although it was initially proposed by the MMU to monitor political meetings throughout the entire country, due to financial and logistical reasons, the field exercise component of the EMP was limited to just 7 of the country's 10 regions – i.e. Regions 2, 3, 4, 5, 6, 7 and 10. Operationally, for administrative purposes and to establish clear lines of supervision and the direction of information flows, each region was supervised by a Lead Monitor, who, in turn, reported to the Head of the MMU (or Lead Elections Coordinator). The Head of the MMU provided all pertinent information received from the Lead Monitors to the SRC for discussion/adjudication [see Appendix 1].

2.1 EMP (field exercise) - Findings

As stated before, the ERC's election monitors were marshalled in 7 of the country's 10 regions and managed to monitor exactly 425 meetings over an approximately two (2) months period. During the course of their monitoring activities on behalf of the Commission, the EMs provided information to the Commission identifying 19 instances where ethnically offensive language was either used or similar actions indulged in at political meetings by politicians and/or their supporters. From the audio recordings and written reports sent to the Commission by the EMs as corroborating evidence of their observations, it showed that the language used or actions indulged in by some politicians (and/or their supporters) fell into one of the following categories: inflammatory; racially divisive/inciting; religiously divisive; and, ethnic stereotyping/profiling. For the record, there were 3 reported instances where, what can be logically considered as inflammatory language, was used as a means of mobilizing political support by speakers at meetings; 7 reported instances of the usage of racially divisive/inciting language; 4 instances where the language used was religiously divisive; and, 5 instances where politicians and/or their supporters used language or indulged in behaviors that amounted to racial profiling/stereotyping. In addition to the foregoing, there were 4 reported incidents where political meetings were disrupted, with one (1) being aborted due to hostile crowd behavior.

2.1.1 EMP (field exercise) - Challenges

There were a few challenges encountered in the implementation of the field component of the program that, to some extent, negatively affected maximum output of some deliverables. In this regard, some of the constricting issues that readily come to mind are:

- Audio recordings quality It was anticipated that the EMs would have been outfitted by the ERC with digital recorders to record the speeches delivered at meetings. However, due to an internal office snafu this did not happen. The result is that EMs had to use their mobile phones to do recordings. Most of the recordings submitted to the MMU by the EMs were of a good quality, but, in many instances, the recordings were also of a poor play-back quality due to the high levels of peripheral noises (such as vehicles passing) that intruded and drowned out the speeches being recorded. If digital recorders were used instead, this drawback would have been eliminated because of a feature called the "Noise Cut" that comes with the device, which, when engaged, filters out intrusive sounds from the recording being made.
- Attrition In preparation for the March 2, 2020 general and regional elections, fifty-three (53) persons were trained by the MMU to perform the roles of EMs on behalf of the ERC. However, over the 4 weeks duration of the exercise, 13 persons (representing approx. 25% of those trained) discontinued their participation. This high drop-out rate amongst the EMs was due to many factors such as sickness, migration and conflict of interest situations that arose between some persons' working hours and the timings of meetings. Quite noticeable however, was that the greater portion of those that left (8 persons) did so even before the exercise got fully on stream (from Jan. 18, 2020) due to disinterest occasioned by the relatively late roll-out of the program.
- Monitor bias There were a few occasions when Lead Monitors reported to the Lead Elections Coordinator that EMs outrightly refused to be assigned to, or offered lame excuses for their refusals to cover meetings held by either the APNU+AFC or the PPP/C, resulting in some scheduled meetings going unmonitored. Instances of this happening weren't numerous, but warrants mention because it impacted negatively on the overall

number of meetings that could have been done during the period of the exercise. From the information provided by the Lead Monitors, it would seem that the refusals by EMs to cover certain meetings arose from feelings of racial insecurity in going into areas dominated by another ethnic group not of one's own race; and, the assumption (by some EMs) that their presence at political meetings of certain parties may be interpreted by their kith and kin in a negative way.

2.1.2 EMP (field exercise) – Achievements

Despite the many challenges encountered during the implementation phase of the field exercise component of the EMP, there were also some positive outcomes (or achievements) that served to somewhat mitigate the earlier identified negative developments which threatened to overwhelm at times. In this regard, three (3) outcomes merit mention, since they all center on the objectives the exercise was designed to achieve.

Relative to the exercise's first objective: "to gather first-hand information..." Forty (40) EMs were able to monitor 425 meetings on behalf of the ERC. On average, this worked out to each EM monitoring approximately 11 meetings during the period of the exercise, which, though not spectacular in terms of numbers, allowed the ERC to gain first-hand information on just about 75% of the meetings held in some of the regions where monitoring activities were carried out.

In connection with the second objective: "to provide the ERC with the necessary documented evidence..." The records show that through the efforts of the EMs, the ERC was supplied on a daily basis with timely, verbatim information of what was being said and done on the campaign trail. This direct channeling of pertinent information positioned the Commission to respond swiftly and in measured ways to situations (most times of an racial/ethnic nature) that required interventions to maintain harmony and good relations amongst the country's citizens. Hard evidence of these interventions can be gauged from the number of cautionary/advisory letters dispatched at the behest of the SRC to political parties, relating to incidents that took place at their meetings.

Last, but not least, with reference to the third objective: "to influence through their presence, self-regulation..." The MMU has in its possession audio recordings of political meetings where

speakers can clearly be heard advising those present that they (the speakers) have to be careful what they say, since they suspect that the ERC is monitoring the meeting. For the MMU, this represented tangible and indisputable evidence that the presence of our EMs at some meetings induced appreciable levels of self-control in what was communicated to audiences by politicians in their speeches. Also, it served to show without doubt, that the EMs, through their presence, positively influenced the tone and content of the public discourses engaged in by the contesting political parties.

2.1.3 EMP (field exercise): Observations

Coming out from the field exercise component of the ERC's elections monitoring program, the MMU made two (2) notable observations:

First, a casual trawl of the reports and audio recordings submitted by the EMs revealed that this is perhaps the first time since the ERC began doing elections monitoring (in 2011) that the ethnic characteristic of religion has been so pervasively used on the campaign trail as a tool for political mobilization. Though by comparison, race, true to form, dominated the public discourses of the two (2) main political formations (APNU+AFC and PPP/C) which contested the elections, this is the first time, in the elections monitoring history of the ERC that politicians have openly used religion to criticize and disparage political opponents in attempts at swaying voters to their cause.

Second, this is definitely the first time since the ERC began doing these exercises that EMs have reported being singled out at meetings by speakers or spectators as being "spies" and/or belonging to "the other side", simply because, being of a different race, they stood out conspicuously from the rest of the crowd. This kind of subtle racial profiling which some of the EMs were subject to, led understandably to feelings, on their part, of uneasiness and vulnerability, and brought to the fore, in a very real way, the predominance of the racial factor in the elections contest. However, a caveat is in order here: this observation is limited to the two (2) main big parties (APNU+AFC and PPP/C), since there were no such similar reports from our EMs who attended the meetings of the smaller political parties.

3.0 Report: Media Monitoring

The media monitoring part of the EMP was done by staff of the MMU and focused mainly, but not solely, on elections-related content disseminated to the general public through television, online radio, newspapers, and social media, to ensure that all information communicated via these channels conformed to the tenets of the Racial Hostility Act (Cap 23:01) and the Representation of the People (Amendment) Act No. 1 of 2000.

3.1 Television and On-Line Radio

For the duration of the pre-elections season starting with the first political rally held on Jan. 3, 2020, the MMU prioritized the monitoring of those programs streamed on live television that had elections-related content such as: newscasts, talk-shows, political-party sponsored discussion programs, re-plays of political meetings/rallies, Call-in programs, etc.. In excess of 1500 hours of television programming with elections related material taken from 11 television stations scattered across Region 4, were monitored by staff of the MMU, but nothing ethnically offensive was found in the content. Ditto for the on-line radio channels – limited to Kaieteur Radio, Demerarawaves News-Talk-Radio, Benschop Radio, and HJ Boom FM.

3.2 Print Media (Newspapers)

The MMU's robust monitoring of the print media (newspapers) – Stabroek News, Kaieteur News, Guyana Chronicle and Guyana Times – did not turn up any violations of the aforementioned Statutes. However, the Unit's monitoring activities did result in an elections-related ethnic issue with the potential for escalation, which was highlighted in the letter column of the Guyana Chronicle newspaper ("Dark ages political culture should be condemned" GC 07-02-2020), being referred to the SRC. Based on the SRC's recommendation, an in-depth investigation was carried out into the matter by the ERC's Investigations Unit and a report was submitted to the Commission.

3.3 Social Media

Outside of the major rallies held almost exclusively by the main political parties in the run-up to the March 2, 2020 general and regional elections, the major arena resorted to by the two (2) big

parties and their supporters, and the smaller parties, to proselytize the electorate to their cause was social media, or more precisely, **Facebook**.

In anticipation that social media would be aggressively utilized by all the political parties contesting the elections, the MMU set about keeping an 'eagle-eye' on what was being disseminated from the websites and Facebook (Fb) pages of the established local media houses and all the political parties contesting the elections.

In the course of monitoring the social media landscape, the MMU zeroed-in on 13 instances where ethnically offensive material was found on the Facebook pages of 6 media houses and 2 political parties. Generally, the ethnically offensive material took the forms of racially divisive/inciting and/or inflammatory comments being posted to the pages of the media houses and political parties. Normally, the MMU allowed up to one (1) week for these comments to be removed, failing which, the Unit posted 'Cautionary Messages' to the Fb pages advising the contributors who made the comments that it was an offense under the Representation of the People (Amendment) Act No. 1 of 2000, and further advising the media house or political party where the comments were posted, that it was their responsibility to edit or completely remove such comments whenever they appear on their pages. In the execution of this exercise, the MMU posted 12 cautionary messages to the Fb pages of the following media houses and one (1) political party: HGP Nightly News (2), NCN News (2), Demerarawaves (2), INews Guyana (3), Guyana Chronicle (1), Guyana Times (1), APNU+AFC (1). In addition, ethnically offensive material in the form of an elections campaign advertisement that was racially stereotypical was put up by the A New and United Guyana (ANUG) party on their Fb page. This matter was brought to the attention of the SRC and an advisory/cautionary letter was recommended to be sent to the party on the issue by the ERC.

4.0 Conclusion

The Elections Monitoring Program – comprising elections monitoring and media monitoring - embarked on by the ERC during the just concluded elections, proved to be a worthwhile exercise, since it provided the Commission with valid, timely information which helped it during the pre-elections period to make informed decisions on issues with negative ethnic implications.

Some of these issues, if left unresolved, had the potential to escalate at the national level into open ethnic conflict. In so doing, the ERC demonstrably performed its constitutional mandate to promote harmony and good relations amongst the country's citizens.

Additionally, from an ethnic perspective, the EMP field-exercise elicited valuable information which the ERC may do well to incorporate into its future Strategic Plans to address the country's ethnic issues. For example, the observation made earlier about the exploitation of religion by some politicians for political gain, as was done during the elections campaigning, is perhaps a novelty in this country's elections annals which, should be seen for what it really is: a future flashpoint for ethnic conflict. In fact, it should be cause for concern by the ERC that a pattern was traced from the EMs reports which clearly showed that religion is now overtly being injected by irresponsible politicians into the boiling brew of racial division and animosity that envelopes the nation (especially during elections periods). Indeed, as much as the reports submitted to the MMU by the EMs have, after being objectively analyzed, served as the basis for alerting the ERC to the insidious manipulation of religion during the elections campaigning, they (the reports) also serendipitously revealed a potentially new area for ethnic conflict in the country that is being exploitatively stoked by politicians.

Finally, the elections monitoring program implemented by the ERC for the March 2, 2020 general and regional elections was successful in many regards, but the greatest success of the exercise is that its timely implementation specifically to garner information that would allow the Commission to objectively respond to electoral matters from informed positions, also fortuitously served to re-establish into the consciousness of the nation, the pivotal role of the ERC as a neutral arbiter of ethnic issues in Guyana.


5.0 Recommendations


(1) With an eye to Local Government Elections due to be held sometime this year, particular reference is made to the random acts of racial profiling/stereotyping reported by our EMs who covered meetings of the two (2) major political parties during the just concluded elections. In order to lessen the prevalence, or altogether prevent instances of this happening again in future elections, the MMU **recommends** to the Commission that in future whenever they are assigned


to do official elections monitoring duties on behalf of the ERC, our EMs are outfitted beforehand with appropriate attire (such as jerseys), which clearly identifies them as ERC Election Monitors. The MMU believes that this recommendation, if implemented, will go a long way in allaying suspicions by politicians and their supporters of the presence and intent of our EMs, especially in politically/racially-charged meeting environments where, because of their race, they are conspicuous.

- (2) From the ERC's previous engagements in elections monitoring, it has been recognized that the cooperation of the Guyana Police Force (GPF) is a sine qua non for successful outcomes to be achieved, since they provide the Secretariat with the Schedules of political meetings and, of late, provided security for our EMs in the performance of their duties. However, during the just concluded elections, a kink emerged in the usually open lines of communication between the Commission and the GPF. This had to do with senior Police Officers in charge of some districts refusing to assist our Lead Monitors (LMs) in accessing Schedules of political meetings to be held in areas under their command, even though the LMs produced official letters from the ERC which identified them and requested the Police's assistance in furnishing the bearer with the requisite information. The Officers' refusals were on the grounds that they were never informed by their hierarchy of any arrangements between the ERC and the GPF. This happened in Leguan and Essequibo. It is against this background that the MMU recommends to the Commission that for future elections, a Liaison Officer is identified by each organization (ERC and GPF) through whom information can be channeled in respect to any issues that may arise during the implementation of the EMP. If such an arrangement was in place during the just concluded elections, the problems experienced in Leguan and Essequibo would have been easily resolved via a telephone call.
- (3) The just concluded elections period brought out in a very stark way the deep animus that exists between the two (2) major races (Africans and Indians) in the country. Not unexpectedly, this antipathy between the two races was vented in unrestrained ways on social media. In recognition of the maximal role social media played and continues to play as the first choice for news and information by a large section of the population, it is imperative that by the time the next elections are held in another 5 years, the ERC establishes a stronger deterring presence on


social media. The Constitution (Amendment) (No. 2) Act No. 11of 2000 [212D (w)] predisposes the ERC to "make recommendations on penalties...to be imposed for any breach...of any law dealing with ethnicity" This elections has pellucidly shown how social media can be harnessed in real time to execute non-physical racial warfare. To effectively counter the viral spread of racism via social media platforms, the MMU recommends that the Commission considers as a matter of priority, making recommendations to the National Assembly for legislation to be enacted specifically targeting the use of social media to promote racism and other forms of ethnic bigotry. The legislation should be crafted in such a way that it constitutionally empowers the ERC to hold media houses, political parties and other social organizations accountable for managing the content of comments posted to their websites and Fb pages. Whenever organizations are found guilty of leaving ethnically offensive comments on their social media platforms for specified periods of time without editorial intervention, the legislation should further empower the Commission to leverage hefty fines against those organizations found to be in violation of the legislation. The MMU sincerely believes that this recommendation if fructified can go a long way in containing the use of social media to promote ethnic divisions in the country, not only during elections periods, but, year-round.








Types and number of offenses recorded from Social Media



Bishop Edghill was recorded by our Election monitors as using race to excite the crowd. Edghill is recorded as saying "...this young woman is a medical doctor for six years. You know what that means, she is one of Jagdeo Scholars. She is one of those 1000 plus young people that was sent to Cuba when we didn't look at colour, race or religion. You just had to be

bright. We send you to Cuba to give you a future. She is Afro Guyanese. Yes, she black. I say she Black. The PNC aint own black people...they ain't own no blackman...they ain't own the black people in Georgetown. People getting conscious and coming to the PPP".

The Commission finds the use of such language inappropriate and asks that party speakers at meetings be urged to use more responsible, professional language to their audience. The Commission cannot effectively function without your support. You have the ears of the Guyanese people and we ask that you use your platform to stress the need for unity and peace among our people.

You are therefore respectfully reminded to be cautious of your words and conduct in public and the damaging influence they may have on those who have received them. The Commission urges you to be an emissary of peace, especially during this very tense election season and asks that the Party refrains from advancing, disseminating or communicating any idea which can cause racial or ethnic division.

The Commission wishes to bring to your attention the viral recording on Facebook and social media of what appears to be a group of APNU/AFC supporters disrupting a PPP/C meeting at Linden on 30 January, 2020. Persons were observed beating buckets, dragging cans on the streets and issuing indecent language at the speakers. A fire cracker was also thrown some distance away from Mr. Sam Hinds while he was addressing the crowd forcing him to be escorted by

security. The Commission asks that you remind your supporters of their role to respect the right of peaceful assembly of other political parties and to refrain from conducting themselves in a disorderly manner in public.

A second incident which was monitored by the Commission involves Mr. Tacoma Ogunseye who on 17 January, 2020 at an APNU/AFC Meeting at East Ruimveldt, Black Circle, while addressing the crowd, used words to the effect "As I speak to you brothers and sisters, if you are to look at the Guyanese economy, African and Amerindian probably own only 10% of the economy. The 90% of the economy is owned by Indian and Portuguese and people outside the African community and that is a lopside arrangement......we got nothing, 300 years sisters of slavery and colonialism and nothing free the African got...". The Commission finds the use of such language inappropriate and asks that party speakers at meetings be urged to use more responsible, professional language to their audience. It is our recommendation that speakers use an all-inclusive tone and not present themselves as acting in the interest of one or two ethnic groupings while neglecting the others.

A third incident which the Commission found worrying were the remarks of Mr. Harmon at Buxton, East Coast Demerara on 08 January, 2020 where he stated to a cheering crowd ""It is really a contemptuous act on the part of the PPP that says 'look once you put up a black face deh, Black people are going to vote for you'...No way, no way, I say no way..." Historically race has been associated with politics in Guyana and we as public figures have a duty eliminate that stereotype, not to feed into it.

The Commission cannot effectively function without your support. You have the ears of the Guyanese people and we ask that you use your platform to stress the need for unity and peace among our people.

In keeping with its mandate, the Commission hereby brings to your attention the following incidents:

- It was reported by one of the Commission's Election Monitors that at a PPP/C meeting held on January 8, 2020 at Central Mahaicony was noisily interrupted by APNU/AFC supporters.
- At the APNU/AFC meeting held on February 10, 2020 at Belle West Masjid Street, Canal No. 2, West Bank Demerara, the Elections Monitor observed that your party's speaker, Pandit Deodat Tillack made insensitive comments that have the potential to divide the populace along religious lines. His words were "Speaking to the Hindu community, how do you feel as a Hindu to know that in 2011, at GuyExpo, the man, Irfraud Ali in the company of his friends at the Hindu booth, opened a beer and threw it on the image of Maha Lakshmi, the personification of wealth, threw it on the image of Maha Lakshmi. How do you feel? Aren't you ashamed to be supporting such an individual? No wonder you are suffering because you are supporting the wickedness. In 2013, when our beloved Pandits, one of his relatives went to the man's home under the influence and acted out of character, and when he was admonished what happened to that Pandit, what happened to him? Just imagine if the man was simply a Minister and he allowed his family and friends to do these things to Hindus just imagine...Aren't you ashamed to be supporting such an individual and placing your 'X' next to be PPP/C and the cup, the cup done bend up...".
- Pursuant to a complaint to the Commission of a Facebook post titled "Late Night Gaff" hosted by APNU / AFC members Minister Tabitha Sarabo-Halley and her husband, Clayton Halley, the Commission has since perused the said posted video and observed that Mr. Halley mentioned "If you look at what happens at election time, there is a branding, a serious branding campaign that the opposition takes on during election time and that is so to keep their base in order, which the largest support group for them is Indo-Guyanese...And in order to keep them in tact they throw a lot of branding on Afro-Guyanese. When you hear a lot about thugs...hooligans... and then at the bottom house meetings they drive fear into them to telling them that they gon come and beat them up...all sorts of things going to happen If they go into power... So what they do indirectly they would drive fear in their own supporters as it relate to Afro-Guyanese, and therein lies the major issue because it then becomes difficult for me as an Afro-Guyanese, even if I decide to walk through an Indo community and talk to people just to share information, it becomes a battle because they already got this branding in their minds...".

The Ethnic Relations Commission hereby advises that in keeping with Guyana being a secular state, statements which have the potential to create tensions between different religions should be avoided as much as possible. Also, the words spoken by Mr. Halley have the potential to create racial division and should be avoided at all times.

The Commission appreciates your continued support in promoting harmony and good relations.

- At an APNU/AFC meeting held at the junction of Middle and Church Streets McDoom on 12 February, 2020 during his address to the gathering Mr. Seivewright Benjamin remarked ""...Before I close I want to say that I have been looking at the statistics and one of the things that it reveals is that black people from 1985 up to 2015 have been voting at an average...and at its highest peak was in 2015 when it was 78%, that is unacceptable because we giving other people a chance to kill us...so we have to bring out everybody on March 2nd vote for the hand and the key..."
- At the APNU/AFC meeting held on February 13, 2020 at Manawarin Creek, Essequibo Coast, our Election Monitor observed that your party's speaker, Mr. Naitram stated to the crowd of supporters in his speech ".. I know on de coast they had a programme where they give old age people free electricity and free water but how many of you how many of your parent benefitted out of that programme? It was done because the coastland which is dominated by Indo- Guyanese those were the ones who benefitted from it. You the residents of this community never benefitted out of that programme. Did you benefit from that programme? No! Because they did not have you at heart, the residents of the hinterland communities..."
- Mr. Tacoma Ogunseye in his address to the crowd at an APNU/AFC meeting held on 10 February, 2020 at the Health Centre between B and C Field Sophia stated "Anyone looking at the Guyanese economy as it stands today and I have been making this point over and over and they haven't challenged me. At present Africans and Amerindians only control together, the African stakes and the Amerindian stakes in the economy is 10%. It therefore means that 90% of the economy is outside our hands, it is controlled either by Indians, Portuguese and now we have the Chinese. This is a structural injustice and a lot of this happened historically but it got worse under the 23 years of the PPP deliberate policy of economic apartheid in which they set out systematically to impoverish African communities because they vote for the PNC and because they vote for the APNU/AFC and so forth. So it was deliberate policy that impoverished us." He went on further to say "...You remember when they get in in 1992; in Guyana we had little capacity to build roads. The first thing the PPP did, they went to Trinidad, recruit their Indian friends and the first contractors that began to build roads in Guyana was Indian Trinidadians working with local Indians and three years after that you don't see Trinidadians. They have empowered their own people and their friends and a lot of the road contracts are done by non-African people - non-Amerindian people..."

The Commission urges party members and executives to respect the signed Code of Conduct and to refrain from using any language which has the potential to cause division or violence on the ground of race. Please be reminded of the penalty clause in the Code of Conduct. The Commission finds that the use of divisive language is not only inappropriate but contrary to our laws and asks that party speakers at meetings be urged to use more responsible, professional language to their audience.

The Commission appreciates your continued support in promoting harmony and good relations.

In keeping with its mandate, the Commission hereby brings to your attention the following incident:

• At a PPP/C meeting held on 10 February, 2020 at Kuru Kururu Market Square, one of the PPP/C speakers, Ms. Joan Da Silva, in her address to the crowd, was recorded by our election monitor as saying "....but I can speak to you. I had a vision and I speak on behalf of what God said to me, and I is not a false prophet you know. Hear what I tell you. God spoke to me about that election. Hear what he said to me. APNU did not win the election. He said they did not win the election but listen to this conversation na man. He said I permitted them to be in office. He further said I permitted them to be in office because blood was going to fill the land. You understand what I just said? Blood was going to fill the land. It means that APNU was prepared to kill everybody that look like they supporting PPP. Innocent blood was going to fill the land and God in his infinite wisdom said No. Mercy says no."

Ms. Da Silva went on further to say "I want to say to Kuru Kururu people this is a Christian Community. I never see Christian punish so much. Granger seh he is a Christian. He needs to become a Christian because let me tell you something, if you was gonna kill innocent people, you na Christian, you're not no Christian, you is a murderer. And ah telling you, the PPP is the party that cares for everybody..."

The Ethnic Relations Commission believes that the statements made by Ms. Da Silva have the potential to cause unrest in the religious community since they can be easily viewed as offensive to Christianity. They are inflammatory and are the kind of remarks that should be strongly and unequivocally condemned by your Party leaders and executives.

The Commission finds that the use of divisive language is not only imppropriate but contrary to our laws and asks that party speakers at meetings be arged to use more responsible, professional language to their audience. We ask that party leaders and executives homour their obligations under the signed Code of Conduct and be reminded of the penalty clause in the said Agreement. With regard to the meeting at Good Hope, the Commission strongly believes that in the context of the meeting, the ERC monitor who is of Afre Guyanese heritage, felt a sense of unexhiness since there was unnecessary and immediane attention directed to her from sections of the crowd. Hence, the Commission advises ogainst the use of satements at meetings which are likely to be negatively received by party supporters.

The Commission appreciates your continued support in promoting harmony and good relations.






Our mandate revolves around the bleak spectre haunting our differences, where fears real and unreal compete to divide us.


