REPORT OF THE SPECIAL SELECT COMMITTEE OF THE NATIONAL ASSEMBLY ON THE INVESTMENT BILL 2003.

Publication of Bill

The Investment Bill 2003, which provides for the rendering into law of the principles and practices that inform our present approach to investment, was published on Wednesday, 30th July, 2003.

Introduction and First Reading in the National Assembly

2. The Bill was introduced in the National Assembly and read the first time on 4th August, 2003.

Debate and Second Reading in the National Assembly

3. The Bill was debated in the National Assembly and was read the second time on 18th August, 2003.

Committal to Select Committee

4. Following its second reading the Bill was committed by the Assembly for consideration by a Special Select Committee.

Nomination of the Members of the Committee

5. At a meeting held on 13th August, 2003 the Committee of Selection nominated the following Members of the National Assembly to comprise the Special Select Committee to consider the Investment Bill 2003.

- 12. At its meeting on 11th February, 2004 the Special Select Committee on the Bill agreed that this Report on the Bill should be presented to the National Assembly.
