## I. EXISTING CONSTITUTION

- 1. The Guyana Independence Act 1966 which was enacted by the British Parliament provided for the attainment by British Guiana of fully responsible status within the Commonwealth from 26th May, 1966. The Act also empowered Her Majesty by Order in Council to provide a Constitution for Guyana to come into effect that same day.
- 2. On 16th May, 1966, Her Majesty in Council made the Guyana Independence Order 1966 and established a Constitution for Guyana.

## II. NEED FOR NEW CONSTITUTION

- 3. Guyana is a developing country and is desirous of reconstructing its society and its economy on socialist principles so that the right to enjoy the highest possible standard of living and quality of life consistent with the work and the development of the country's resources, to which the people of Guyana are entitled can be assured.
- 4. The existing Constitution is the standard Westminster. type of Constitution and is not a suitable vehicle for effecting the necessary reconstruction of the society and the economy.
- 5. A new socialist type of Constitution designed to ensure social and economic justice for all of the people of Guyana is needed.

## III. ESTABLISHMENT OF CONSTITUENT ASSEMBLY TO PREPARE NEW CONSTITUTION

6. On 21st July, 1978, the National Assembly approved of the establishment of a Constituent Assembly to prepare a new Constitution for the Co-operative Republic of Guyana.

#### IV. RESOLUTION OF THE NATIONAL ASSEMBLY

- 7. The motion providing for the establishment of the Constituent Assembly was moved in the National Assembly by the Prime Minister, Cde. L.F.S. Burnham, O.E., S.C., M.P.
  - 8. It was considered, debated and passed as followe:-

"WHEREAS the people of Guyana are entitled as of right to enjoy the highest possible standard of living and quality of life consistent with their work and the development of the country's resources;

AND WHEREAS the aforesaid right cannot be assured unless the society and the economy are reconstructed on socialist principles;

AND WHEREAS the existing Constitution is not a suitable vehicle for effecting the necessary reconstruction of the society and the economy of the State;

AND WHEREAS it is necessary to adopt a new Constitution designed to ensure social and economic justice for all of the people of Guyana:

RESOLVED, That this National Assembly resolve itself into a Committee consisting of all the members of the Assembly (including the Speaker) to be known as a Constituent Assembly for the purpose of preparing a new Constitution for the Republic of Guyana provided that members of the National Assembly who are not elected members of the National Assembly shall be entitled to participate in the proceedings of the Constituent Assembly but without the right to vote thereat;

AND FURTHER RESOLVED, That the Constituent Assembly shall have power -

- (a) to elect its Chairman and a Deputy Chairman from among persons who are members of the Constituent Assembly;
- (b) to appoint the Secretary of the Constituent Assembly and such other staff which may be considered requisite by the Constituent Assembly for the carrying out of its functions;
- (c) to delegate to the Chairman the powers conferred by paragraph (b), other than the power to appoint the Secretary:

- (d) to co-opt permanent advisory delegations representing other groups of persons in the society, in particular, the Guyana Association of Local Authorities, the Trades Union Congress and religious organisations, to assist the Constituent Assembly in its deliberations in the preparation of the new Constitution for the Republic of Guyana;
- (e) to invite and receive memoranda from members of the public or from organisations and to take evidence from persons desiring to testify before it;
- (f) to hold meetings in any part of Guyana; and
- (g) to regulate its own procedure."

10. At itsfirst meeting on 6th November, 1978, the Constituent Assembly unanimously elected Cde. Sase Narain, O.R., J.P., M.P., Speaker of the National Assembly, to be Chairman of the Constituent Assembly.

#### Deputy Chairman of the Constituent Assembly

11. The Constituent Assembly, also at its first meeting on 6th November, 1978, unanimously elected Cde. Philip Duncan, J.P., M.P., Minister of State, Ministry of Economic Development and Co-operatives, to be Deputy Chairman of the Constituent Assembly.

## Deathsof Members

12. The Constituent Assembly lost by death two Members from the People's National Congress - Cde. Vincent R. Teekah, Minister of Education, Social Development and Culture, and Cde. Leonard A. Durant, Minister of State - Regional (North West), who died on 25th October, 1979, and on 1st November, 1979, respectively.

#### VI ADVISORY PANEL

#### Establishment

- 16. In its Resolution of 21st July, 1978, the National Assembly empowered the Constituent Assembly to co-opt permanent advisory delegations representing other groups in the society, in particular, the Guyana Association of Local Authorities, the Trades Union Congress and Religious Organisations, to assist it in its deliberations.
- 17. In its Rules, the Constituent Assembly made provision for the establishment of a body to be known as the Advisory Panel of the Assembly to assist the Assembly in am advisory capacity in its deliberations, and to consist of -
  - (i) Two Representatives of the Christian Religion
  - (ii) Two Representatives of the Hindu Religion
  - (iii) Two Representatives of the Muslim Religion
  - (iv) Three Representatives of the Guyana Trades Union Congress
  - (v) Three Representatives of the Guyana Association of Local Authorities
  - (vi) Two Representatives of the Guyana Co-operative Union
  - (vii) One Representative of the Guyana Assembly of Youth
  - (viii) One Representative of the Council for the Affairs and Status of Women in Guyana
- 18. ## VII. DUTY OF CONSTITUENT ASSEMBLY

27. The duty of the Constituent Assembly was to prepare a new Constitution for the Co-operative Republic of Guyana.

## VIII. PRELIMINARY MEETINGS OF CONSTITUENT ASSEMBLY

- 28. The Constituent Assembly held three Preliminary Meetings on 6th November, 1978, 8th February, 1979, and 23rd March, 1979.
- 29. At these Meetings, a Chairman and a Deputy Chairman were elected, a Secretary was appointed, Rules regulating the procedure of the Assembly were made, and the question of the Advisory Panel was settled.

## IX. PROCEDURE ON WORK OF CONSTITUENT ASSEMBLY

- 30. At its First Meeting on 6th November, 1978, the Constituent Assembly made Rules to regulate its procedure.
- 31. It decided that for the purpose of assisting it in its deliberations, the public should participate in its work and should be invited either as individuals or as organisations to submit memoranda with proposals for the new Constitution for the consideration of the Assembly.
- 32. It was also decided that those who wished to appear before the Assembly to give oral evidence only or in support of any memorandum submitted to the Assembly should be invited to do so.
- 33. At that same Meeting the Constituent Assembly also decided that its Meetings would be held in public and throughout Guyana and that the quorum should consist of eleven Members.

#### X. INAUGURAL MEETING OF CONSTITUENT ASSEMBLY

- 34. Following its three Preliminary Meetings and the establishment of the Advisory Panel, the Constituent Assembly held its Inaugural Meeting on Monday, 4th June, 1979, in the Parliament Chamber, Public Buildings, Georgetown.

## XI. MEMORANDA

- 36. As empowered by the National Assembly in its Resolution establishing the Constituent Assembly, the Constituent Assembly, when it first met agreed that members of the public and organisations should be involved in its work and decided that invitations should be extended to the public to submit proposals for the new Constitution for the Assembly's consideration.
- 37. It was also decided that individuals and organisations who desired to appear before the Constituent Assembly to give oral evidence should be invited to testify before it.
  - 38. Memoranda were to be submitted not later than 31st January, 1979.
- 39. Following the above decisions, the following notice was published on several occasions during December, 1978, and January, 1979, in the Official Gazette and in the newspapers:-

#### "NOTICE

#### CONSTITUENT ASSEMBLY

Invitation to Submit Memoranda and to give Oral Evidence

A Constituent Assembly consisting of all the Members of the National Assembly has been established by the National Assembly to prepare for the Republic of Guyana, a new Constitution designed to ensure social and economic justice for all of the people of Guyana.

To assist it in its deliberations, the Constituent Assembly will consider views submitted by members of the public and organisations.

All members of the public and organisations who are therefore interested in submitting views for the Constituent Assembly's consideration are hereby invited to do so. Memoranda must be submitted to reach the Secretary not later than 31st January, 1979.

Those who wish to appear before the Constituent Assembly to give oral evidence only or in support of any memorandum submitted must convey their request in writing to the Secretary to reach him not later than 31st January, 1979.

40. Announcements were also made regularly over the broadcasting stations and reminders appeared on several occasions in the newspapers.

#### Memoranda Received

- 41. In response to its public invitation, the Constituent Assembly received 139 submissions. These came from 97 individuals and 42 organisations who included lawyers, doctors, nurses, teachers, politicians, public officers, police, prison and fire officers, constables, watchmen, and security officers, farmers, manufacturers, trade unions, religious organisations, municipal workers, women's organisations and co-operatives.
- 42. Sixty individuals and 16 organisations in their submissions, also made requests to appear before the Constituent Assembly to give oral evidence.
- 43. Three of the individuals and 4 of the organisations who submitted memoranda indicated their willingness to give oral evidence in support of their memoranda, if required by the Constituent Assembly.
- 44. Submissions came from all over Guyana; one came from overseas Canada.

#### Publication of Memoranda

- 46. All the memoranda received were reproduced in the Secretariat and were numbered and paged in continuous series. The 139 submissions were published in a volume covering 376 pages. Thirty-four additional pages comprising tables of indexes and statistical information on the memoranda were also prepared and published with the memoranda.
- 47. Copies of the memoranda and the indexes as reproduced, were circulated to the Members of the Constituent Assembly and to the Representatives and Alternates on the Advisory Panel. Copies were also made available to the Press.

## XII. ORAL EVIDENCE

- 48. The Constituent Assembly held Meetings throughout Guyana travelling hundreds of miles to hear the views and proposals of those
  individuals and organisations who made requests to appear before it to give
  oral evidence.
- Assembly included the for reaches of the Interior of Guyana. In the Rupununi, the Constituent Assembly held Meetings at Aishalton, Lethem and Karasabai. In the North West Region, Meetings were held at Mabaruma and at Matthews Ridge. In the Upper Mazaruni, a Meeting was held at Kamarang. Up the Demerara River, a Meeting was held at the mining town of Linden. Up the Essequibo River, a Meeting was held at Bartica. Meetings were also held on the Coast. On the Essequibo Coast, the Constituent Assembly met at Charity and at Anna Regina, and on the Berbice Coast, Meetings were held at Corriverton and at New Amsterdam.
- 50. In Georgetown, oral evidence was given at 20 Meetings by
  13 individuals and 10 organisations. At the 12 Meetings which were held in
  other places, 44 individuals and 4 organisations appeared before the
  Constituent Assembly and gave oral evidence.
- 51. Wherever the Constituent Assembly went, it received a rousing welcome by all and great interest was shown by the residents who turned out in large numbers, attended Meetings, and gave their support to the work of the Constituent Assembly.

- 53. In some cases individuals were accompanied by others who supported them and who also joined in giving oral evidence.
- 54. Organisations were represented by Delegations which comprised their senior officials.

#### XIII. NATURE OF MAMORANDA AND ORAL EVIDENCE

- 55. The memoranda received and the oral evidence given contained several proposals for the new Constitution.
- of guiding principles and objectives land to the tiller, personal property, right of inheritance, right and duty to work, right to leisure, right to education, equality for women, equality for children born out of wedlock, etc. There were proposals dealing with various fundamental rights; proposals were made for the retention of acknowledgement of reverence for the Deity.
- 57. Proposals were in respect of the Presidency, the composition of the Cabinet, of the National Assembly, and of the Service Commissions.
  - 58. There were proposals on Local Government.
- 59. There were proposals for the establishment of a new Congress of the People as one of the supreme organs of democratic power.
- 60. There were proposals on matters on which legislation already existed. There were also some proposals which the Constituent Assembly did not feel were matters to be included in a Constitution.
- 61. Among the memoranda submitted, only one complete draft of an entire Constitution was received. That draft was prepared and submitted by the People's National Congress.

## XIV. CONSIDERATION OF MEMORANDA AND ORAL EVIDENCE

- 62. All the Members of the Constituent Assembly and of the Advisory Panel had in their possession copies of all the memoranda received, and were supplied with copies of the evidence given as they were reproduced by the Secretariat and became available.
- 63. Members of the Constituent Assembly and of the Advisory Panel were therefore able to examine and to study the memoranda received and the oral evidence given and the various proposals made therein.
- 64. After the Constituent Assembly completed the taking of oral evidence, it examined the memoranda and the oral evidence and spent some time discussing and deliberating the various proposals which should be included in the new Constitution.
- 65. The Advisory Panel assisted the Constituent Assembly in an Advisory capacity in its deliberations.

#### XV. APPOINTMENT OF SUB-COMMITTEE TO DRAFT CONSTITUTION

- 66. At its Meeting on 7th November, 1979, the Constituent Assembly appointed a Sub-Committee to consider the discussions and proposals made by it during its deliberations on the various matters, and to prepare a Draft of the new Constitution.

## XVI. WORK OF SUB-COMMITTEE

- 68. The Sub-Committee met on 5 occasions 26th and 30th November, and 3rd, 5th and 28th December, 1979 in the Committee Room of the National Assembly, Public Buildings, Georgetown.
- 69. It examined the deliberations of the Constituent Assembly and the proposals, siggestions and intructions made and given by the Assembly, referred to memoranda received and oral evidence given, as found necessary, discussed these, and drafted articles to comprise a new Constitution.

# XVII. DRAFT OF CONSTITUTION FROM SUB-COMMITTEE

70. The Draft of the Constitution as prepared by the Sub-Committee was presented to the Constituent Assembly by the Chairman at a Meeting of the Constituent Assembly held on 14th January, 1980.

## XVIII. CONSIDERATION OF DRAFT CONSTITUTION FROM SUB-COMMITTEE

- 71. The Constituent Assembly spent some time considering and discussing the Draft of the Constitution which was prepared by the Sub-Committee.
- 72. Again the Advisory Panel assisted the Constituent Assembly in an advisory capacity in its deliberations.

## XIX. CONSTITUTION TO BE SUBMITTED TO THE NATIONAL ASSEMBLY

73. After consideration and discussion, the Constituent Assembly adopted the Draft Constitution prepared by the Sub-Committee, and at its Meeting on 18th January, 1980, the Assembly agreed that the Draft as adopted should be the Constitution which the Constituent Assembly should present to the National Assembly for its consideration, in pursuance of the National Assembly's Resolution which was passed on 21st July, 1978.

#### XX. FINAL MEETING OF CONSTITUENT ASSEMBLY

- 74. Following agreement on a Draft Constitution for the Co-operative Republic of Guyana, the Constituent Assembly held its 44th and Final Meeting to formally close its proceedings, on 28th January, 1970, in the Parliament Chamber, Public Buildings, Georgetown.

### XXIII. CONCLUSION

- 82. This is the first time in the history of Guyana that the people have been given the opportunity of participating in the preparation of a Constitution for the Country. The Constitution prepared embodies the ideas which have come from the people. It is a Constitution by the People of Guyana.
- 83. Few would wish to dispute that it was a privilege for Guyanese to have been allowed the unique opportunity of reaching a consensus of what should be the draft of a new Constitution for their country for submission to Parliament.
- 84. It is a matter of joy and satisfaction that whis task now stands fulfilled.
- 85. Many responded whole-heartedly and at great personal inconvience in an exacting exercise, which demanded intensive work, painstaking effort and mature deliberation.
- 86. The deep implications of the assignment behaved all responsible and representative elements within our Society to lend their full co-operation to arrive at conscientious conclusions which would best serve the national interest of Guyana.
- 87. Those who deliberately abstained from discharging this duty rendered a signal disservice to their country; betrayed the trust reposed in them by those sections of the community whom they represented; and abdicated the responsibility of debating whatever viewpoints might have been held, within the relevant enclave. Those who saw fit to wage a campaign of criticism, disparagement and abuse from outside, might still

one day regret that the opportunity was not embraced to be constructive, where it mattered, instead of being destructive for the sake of trying to impress certain sectors, which have long ceased to believe from past experience that tangible results could be obtained through the form of a 'beycott'. Default or ommission could hardly provide a realistic substitute for participation.

- 88. The Constitution of Guyana is and will be for all the people of Guyana not for one section or class. It is for all to uphold and accept as our Supreme Law. The Constituent Assembly has always been sufficiently careful to bear this in mind. In time the people of Guyana and posterity will be the final arbiter and Judge.
- 89. At this juncture of our history, discipline, unity and co-operation are indispensable factors. Recriminations or confrontations should be strenuously avoided. Our objective is to fight the war of want the removal of Social and economic injustices. This can only be done if we all join hands together.
