ORAL QUESTIONS WITHOUT NOTICE

Mr. Speaker: Hon. Member Mr. Khemraj Ramjattan, you have the floor.

Mr. Ramjattan: Mr. Speaker, in view of the ugly developments concerning the Venezuelan fighter jets flying over the Essequibo, other developments in Venezuela and the public rejection by the Venezuelan Government (inaudible), is the Government of Guyana, via the Prime Minister or the Minister of Foreign Affairs and International Cooperation, going to update the Parliament on this very important national matter?

Mr. Speaker: Hon. Minister of Foreign Affairs and International Cooperation, you have the floor.

Minister of Foreign Affairs and International Cooperation [Mr. Todd]: Mr. Speaker, in responding to the Hon. Member, I wish to read a statement that was issued yesterday. Following the statement, I also summoned the Venezuelan Ambassador, who is resident here in Georgetown, and I communicated to him the actions of the Venezuelan military. I would also give him a protest note to transmit to Caracas. For the House, I will proceed with reading the statement which was issued yesterday:

"The Ministry of Foreign Affairs of the Cooperative Republic of Guyana wishes to inform that on Tuesday, March 2, 2021 at approximately 13:20 hrs., two Venezuelan army Sukhoi SU 30 fighter jets, overflew the community of Eteringbang and the air strip at a very low altitude of 1500 feet. The fighter jets circled the location once before proceeding in an easterly direction.

The Government of Guyana condemns this latest act of aggression by the Venezuelan armed forces as a violation of the sovereignty of Guyana over the air above its territory.

The Government wishes to remind that this latest hostility follows closely on the heels of:

- a Decree recently issued by President Nicolas (i) Maduro which purports to establish maritime territory for Venezuela which encompasses Guyana's territorial waters, Exclusive Economic Zone (EEZ) and continental shelf, as well as its land territory west of the Essequibo River;
- the illegal interception and detention of two (ii) Guyanese fishing vessels and their crew in Guyana's waters; and
- the resolutions of the Special Commission for the (iii) Defence of the "Guyana Esequiba" and Territorial Sovereignty which recommended the convening a session of this Special Commission with Essequibo with the assistance of the Venezuelan armed forces.

The incursion of our territory of the two Venezuelan fighter jets is a clear indication that the Government of Venezuela is prepared to use aggression and intimidation to accomplish what cannot be accomplished by legal means - the surrender by Guyana of its patrimony. The Government of Guyana exhorts the Government of Venezuela, and its agents, to behave in a manner consistent with international law and good neighbourly behaviour and relations.

The international community will be kept informed of all actions undertaken by Venezuela to undermine the sovereignty and territorial integrity of Guyana and threaten the peace and security of the region".

Mr. Speaker: Thank you, Hon. Minister. Hon. Member Mr. Ramjattan, you have the floor.

Mr. Ramjattan: In view of the fact that the statement is about 12 hours old and new developments would have occurred, would the Hon. Minister be coming to Parliament with a motion, which the Opposition would also support, in relation to this extremely important national issue?

Mr. Todd: Mr. Speaker, the Government will pursue all avenues that are consistent with good governance practices. As such, as is necessary, we will be coming back to Parliament.

Mr. Speaker: Thank you very much, Hon. Minister.

BUDGET FOR 2021 - MOTION FOR THE APPROVAL OF THE ESTIMATES OF EXPENDITURE FOR 2021

WHEREAS the Constitution of the Cooperative Republic of Guyana requires that Estimates of the Revenue and Expenditure of the Cooperative Republic of Guyana for any financial year should be laid before the National Assembly;

AND WHEREAS the Constitution also provides that when the Estimates of Expenditure have been approved by the Assembly an Appropriation Bill shall be introduced in the Assembly providing for the issue from the Consolidated Fund of the sums necessary to meet that expenditure;

AND WHEREAS the Estimates of Revenue and Expenditure of the Cooperative Republic of Guyana for the financial year 2021 have been prepared and laid before the Assembly on 2021-02-12.

NOW, THEREFORE BE IT RESOLVED:

That this National Assembly approves the Estimates of Expenditure for the financial year 2021, of a total sum of three hundred and fifty three billion, eight hundred and thirty three million, six hundred and twelve thousand dollars (\$353,833,612,000), excluding twenty nine billion, two hundred and forty seven million, and seven hundred and forty six thousand dollars (\$29,247,746,000) which is chargeable by law, as detailed therein and summarised in the undermentioned schedule, and agree that it is expedient to amend the law and to make further provision in respect of finance.

Mr. Speaker: Hon. Members, the House will now resolve itself into Committee...

Opposition Chief Whip [Mr. Jones]: Mr. Speaker...

Mr. Speaker: Hon. Member, Mr. Jones, proceed.

Mr. Jones: Thank you, Sir. I do not know if the Item 'Personal Explanations' would be appropriate, but I would be so guided. Cde. Speaker, in light of the incident...

Mr. Speaker: Just one second, Hon. Member.

[Mr. Speaker in aside with the Clerk.]

Mr. Speaker: Hon. Members, we have passed that, but I would allow the Hon. Member to take the floor on 'Personal Explanations'.

Mr. Jones: Sir, I stood at that time, but you did not notice me.

Mr. Speaker: Sorry. I did not notice you.

Mr. Jones: Thank you. Sir, in light of the incident that occurred yesterday, which involved Members of Parliament, Ms. Tabitha Sarabo-Halley and Mr. Kwame Mc Coy, the A Partnership for National Unity/Alliance For Change (APNU/AFC) is requesting that Mr. Kwame Mc Coy be removed from the precincts of the National Assembly in order for us to proceed with these Estimates. Sir, might I add that, in the consideration of these Estimates, the Hon. Member, Mr. Kwame Mc Coy, is not listed as a Minister to represent any of the Ministries or the Government agencies to come.

Mr. Speaker: Thank you, Hon. Mr. Jones. Hon. Member Ms. Teixeira, you have the floor.

Minister of Parliamentary Affairs and Governance and Government Chief Whip [Ms. Teixeira]: Mr. Speaker, this is not a personal explanation and, therefore, it is totally out of order. If the Members wish to bring a motion, they could at an appropriate time and in accordance with the appropriate procedures. This should be totally rejected. The other side cannot ask for the removal of a Member, especially when there is a lot of doubt or questions about what happened yesterday. You announced there was an investigation ongoing.

Mr. Speaker: Thank you, Hon. Minister. Hon. Opposition Chief Whip, personal explanations would be a matter to which one of the Members wants to offer an explanation.

Mr. Jones: I am so guided...

Mr. Speaker: Hon. Chief Whip, we spoke about Hon. Members standing while the Speaker is speaking. You are standing while the Speaker is speaking. Do you want to hold the Speaker to a Point of Order?

Mr. Jones: No, Sir. So...

Mr. Speaker: Okay. Under Personal Explanations, it is quite explicit in terms of the rules, including the fact that we should at least inform the Speaker, through a note to the Clerk of the National Assembly at a required time before, that a Member would want to make a personal explanation.

We are all still being challenged by the times and so we would have to continue examining how we operate, including the examinations of the Standing Orders, which I promised earlier during this debate. I agree with the Hon. Minister that what you are asking would require a debate and an appropriate motion could come to the House. Thank you. Hon. Member Mr. Jones, proceed.

Mr. Jones: Cde. Speaker, so noted. As I mentioned before and just to reinforce the point, the APNU/AFC's female Members of Parliament (MPs) are uncomfortable with Mr. Kwame Mc Coy's presence. As I mentioned before, we will not proceed with the consideration of these Estimates unless Mr. Mc Coy is removed from the precincts of the Parliament.

Mr. Speaker: Hon. Opposition Chief Whip, I cannot order or tell any Member how to conduct him or herself within the confines of the Standing Order. We are all here representing the people and if some persons feel that it is an appropriate response that they would like to engage in, then they could. However, Hon. Member, your point is noted. Hon. Members, we shall revert to the Committee of Supply, unless the Hon. Member wants to...

[Interruption]

[Members of the APNU/AFC hammered on the desks and chanted, "Kwame must go!"]

[Mr. Speaker hit the gavel.]

[Members of the APNU/AFC stood in their place.]

"An act to provide for the issue from the Consolidated Fund of the sums necessary to meet the expenditure (not otherwise lawfully changed on the Consolidated Fund) of the Cooperative Republic of Guyana for the fiscal year ending 31st December, 2021, estimates whereof have been approved by the National Assembly, and for the appropriation of those sums for the specified purposes, in conformity with the Constitution."

(1) CAPITAL GAINS TAX (AMENDMENT) BILL 2021 – Bill No. 5/2021

A Bill intituled:

"An Act to amend the Capital Gains Tax Act."

Mr. Speaker: Hon. Members, we have the supplementary business for this sitting, which has been approved. I now call on the Senior Minister in the Office of the President with

Responsibility for Finance to move the second reading of the Capital Gains Tax (Amendment) Bill 2020, Bill No. 5/2021.

Dr. Singh: Thank you very much, Mr. Speaker. The Capital Gains Tax (Amendment) Bill 2020, Bill No. 5/2021 is, in fact, a very simple Bill. It is a Bill intended to bring into law one of the many measures announced in Budget 2021, intended to bring relief to the people of Guyana and, in this particular instance, to reverse one of the many draconian measures that have been implemented by the A Partnership for National Unity/ Alliance For Change (APNU/AFC) Government while they were in Office. In particular, the Capital Gains Tax (Amendment) Bill addresses a particular stipulation that had been in place regarding capital gains tax when the People's Progressive Party/ Civic Government (PPP/C) demitted Office in 2015. It was stipulated, at the time, that capital gains tax would not be payable on disposal of assets where the asset or assets concerned had been in the ownership of the person doing the disposal for more than 25 years. In other words, if someone owned a piece of property, and had owned that property for 25 years or more, then disposed of the property, that transaction would not be subject to capital gains tax.

It could be recalled – having left that situation in place, that legislative provision that exempted ownership beyond 25 years from the imposition of capital gains tax – that during the course of their tenure in office, the APNU/AFC removed that 25-year exemption. This meant that irrespective of how long someone owned the asset, even if it was for 40 or 50 years, when the asset would be eventually disposed of it, the disposal would be subjected to capital gains tax. It could be recalled, at the time when the APNU/AFC brought that particular provision to remove this 25-year exemption, that grave reservations were expressed by PPP/C Members of Parliament. In particular, the then Leader of the Opposition, now the Vice-President, had indicated, very clearly, a strong reservation that the removal of the 25-year exemption was going to result in many elderly Guyanese, who had owned their property for a very long time, to have to bear the burden of paying capital gains tax when they eventually disposed of their property. As we committed, with so many of the other punitive tax measures that the APNU/AFC Government had put in place, to reverse these punitive and draconian measures, we are now delivering, once again, on that promise – our promise to reverse and remove the punitive measures that have been introduced by the APNU/AFC during their time in Office.

With those few words, I rise to move that the Capital Gains Tax (Amendment) Bill 2021, Bill No. 5/2021, published on 1st March, 2021, be now read a second time.

Question put and carried.

Bill read a second time.

Assembly in Committee.

Bill considered and approved.

Assembly resumed.

Bill reported without amendments, read the third time and passed.

MOTION

Confirmation of the Customs (Amendment of First Schedule) Order 2021 – No. 5/2021

BE IT RESOLVED:

That this National Assembly, in accordance with Sections 8 and 9 of the Customs Act, Chapter 82:01, confirm the Customs (Amendment of First Schedule) Order 2021 (No. 5/2021) which was made on 26th February, 2021, under Section 8 of the Customs Act, Chapter 82:01 and published in the Official Gazette dated 1st March, 2021.

Dr. Singh: Mr. Speaker. I rise now on the matter of the Confirmation of the Customs (Amendment of First Schedule) Order 2021, Order No. 5/2021, which is an Order that gives

legal effect, that brings into law, two of the critical measures that are announced in the Budget speech.

It could be recalled that, amongst the wide range of measures we announced in the Budget were measures intended to reduce the cost of construction materials, in particular, a measure proposing to reduce the duty on industrial-grade cement from 15% to 5%, with the intention of reducing construction cost in our economy along with several other measures. It could be recalled that we instituted measures to reduce taxation on other construction materials as well. Still, on the matter of customs duty, we had also announced the intention to reduce the cost of transportation in the hinterland by removing customs duty on all-terrain vehicles (ATVs) for use in the hinterland. The first of those measures is to help with reducing the cost of construction and, therefore, the cost of both doing business and the cost of living broadly. The second is to reduce the cost of transportation in the hinterland.

Most of those measures are required to be executed by way of amendment of the first schedule to the Customs Act. That is the background to this Customs (Amendment of Fist Schedule) Order 2021. Given that this is the last item required to bring into legal force the measures announced in the Budget, it would be remiss of me not to avail myself of the opportunity to place on record the very strong and compelling arguments made by my Colleagues, on this side of the House, throughout the last two weeks, in support of *Budget 2021*. They elaborated and articulated how *Budget 2021* is going to help to deliver better development outcomes to all of the people of Guyana.

First of all, I would like to place on record, my thanks, to all of my Colleagues on this side of the House. I believe it would be equally remiss of me if I were not to place on record my grave disappointment that my Colleagues on that side of the House, with the notable and consistent exception of the distinguished Deputy Speaker to whom thanks is also due. Deputy Speaker, my apologies for not, perhaps, explicitly including you when I thanked Colleagues on this side of the House. But, indeed, I was thanking Colleagues on this side of the House and your distinguished self as well.

Might I also place on record my grave disappointment at our Colleagues on that side of the House, with the exception of the Deputy Speaker, who chose to absent themselves at this critical stage of the conclusion of consideration of *Budget 2021*. They opted not to add their voices of support to these very important legislative initiatives that are so critical to

both the cost of doing business and the cost of living in Guyana; that are intended to stimulate economic activity, to contribute to growth in the economy; and that are to contribute to the wellbeing of the people of Guyana. I thought it would be remiss of me if I did not place that on record.

With those words, I would like to move that this National Assembly, in accordance with sections 8 and 9 of the Customs Act, Chapter 82:01, confirm the Customs (Amendment of First Schedule) Order 2021, Order No. 5/2021 which was made on the 26th February, 2021 and which was published in the *Official Gazette* on 1st March, 2021. Thank you very much, Sir. [*Applause*]

Ms. Teixeira: We call on the House to adopt the second report of the Standing Committee on Appointments in relation to appointment of a member of the Local Government Commission and to address matters relating to the appointment of members of the Local Government Commission and signify to the President that Mr. Carville Duncan (AA) of the Guyana Labour Union has been nominated in accordance with the Local Government Commission Act, No. 18/2013, clause 4, sub-clause (1) (c) be appointed to the Local Government Commission. Thank you, Sir.
