OATH Cde. Frank Ulan August Campboll

The Speaker informed the Assembly that Cde. He stated that before Cde. Campbell could take part in the proceedings of the Assembly, he would have to make and subscribe the Oath of Office as required by article 76 of the Constitution.

Cde. Campbell thereupon made and subscribed the Oath of Office.

BUDGET FOR 1979

In accordance with article 80(2) of the Constitution the Minister of Economic Development and Co⊷operatives signified that Cabinet had recommended that the Assembly should proceed upon the motion for the approval of the Estimates of Expenditure for the financial year 1979 of a total sum of \$620,270,952, net of appropriation-in-aid, and excluding \$248,393,517, which is chargeable by law. The Minister of Economic Development and Co-operatives then moved the motion for the approval of the estimates of expenditure for 1979, and read the Budget Speech.

Thereafter, the Minister named Thursday, 15th March, 1979, as the day for the resumption of the debate on the motion.

AFPENDIX

MOTION BY THE MINISTER OF ECONOMIC DEVELOPMENT AND CO-OPERATIVES

WHEREAS the Constitution of Guyana requires that estimates of the revenue and expenditure of Guyana for any financial year should be liad before the National Assembly;

AND WHEREAS the Constitution also provides that when the estimates of expenditure have been approved by the Assembly an Appropriation Bill shall be introduced in the Assembly providing for the issue from the Consolidated Fund of the sums necessary to meet that expenditure;

AND WHEREAS estimates of revenue and expenditure of Guyana for the financial year 1979 have been prepared and laid before the Assembly on 12th March, 1979:

NOW, THEREFORE BE IT RESOLVED:

That this National Assembly approve the estimates of expenditure for the financial year 1979, of a total sum of six hundred and twenty-million, two hundred and seventy thousand, nine hundred and fifty-two dollars, net of appropriation-in-aid, and excluding two hundred and forty-eight million, three hundred and nine-three thousand, five hundred and seventeen dollars, which is chargeable by law, as detailed therein and summarized in the undermentioned schedule, and agree that it is expedient to amend the law and to make further provision in respect of finance.
