# 4. <u>Death of former Members of Parliament - Mr. Mooneer Ahamad Khan and Mr. Simon Hilton Ng-See-Quan</u>

(i) "Honourable Members, I was informed of the death of Mr. Mooneer Ahmad Khan, a former Member of Parliament, who died on the 14<sup>th</sup> September, 2017, in the United States of America. He was 87 years having been born on the 15<sup>th</sup> December, 1930. Mr. Khan came from the People's Progressive Party. From 1961 to 1964, the Chamber was called the Legislative Assembly and Senate. Elections were held on 21<sup>st</sup> August, 1961. Mr. Khan became a Member of the Senate from 5<sup>th</sup> October, 1961 to 24<sup>th</sup> September, 1964.

From 1964 to 1966 the Chamber was called the House of Assembly. Mr. Khan was also a Member of the House of Assembly in that period.

From 1966 to 1968 the Chamber was called the National Assembly of the First Parliament. Elections were held for the first time under the system of proportional representation.

Mr. Khan became a Member of the National Assembly of the first Parliament of Guyana on the 9<sup>th</sup> July, 1965. He served until 4<sup>th</sup> November, 1968. Mr. Khan ceased to be a Parliamentarian from 5<sup>th</sup> November, 1968".

(ii) "Honourable Members, I was also informed of the death of Mr. Simon Hilton Ng-See-Quan, a former Member of Parliament, who died on the 21<sup>st</sup> October, 2017, after a brief illness at the Diamond Diagnostic Centre in the Emergency Unit. He was 79 years old having born on the 2<sup>nd</sup> February, 1938. Mr. Ng-See-Quan came from the People's National Congress.

Elections were held on the 5<sup>th</sup> October, 1992. The Sixth Parliament commenced when the National Assembly first met on 17<sup>th</sup> December, 1992. Mr. Ng-See-Quan first became an ordinary Member of Parliament in the Sixth Parliament on the 24<sup>th</sup> November, 1992.

Mr. Ng-See-Quan worked from that date continuously until the Sixth Parliament was dissolved on the 29<sup>th</sup> October, 1997. Mr. Ng-See-Quan ceased to be a Parliamentarian from 28<sup>th</sup> October, 1997.
