# <u>Item 4 - GEORGETOWN TOWN COUNCIL (AMENDMENT NO. 3) BILL. 1956 - Bill No. 52/1956.</u>

On a motion by the Member for Local Government, Social Welfare and Co-operative Development seconded by Mr. Gajraj, the BILL intituled AN ORDINANCE FURTHER TO AMEND THE GEORGE-TOWN TOWN COUNCIL ORDINANCE was read a second time, and was thereafter taken through its remaining stages and passed as printed.

# MOTION FOR ADJOURNMENT

The Chief Secretary moved the adjournment.

Miss Collins took the opportunity to refer to a Press announcement to the effect that the Estate Authorities required their land in the South La Penitence area and had therefore served tenants with notices to remove their houses by the 30th November.

Mr. P.A. Cummings, Member for Labour, Health and Housing, stated that the Press announcement was inaccurate as the notice did not require tenants to remove their buildings by the 30th November but to communicate with the Housing Officer on or before that date in order to make arrangements for removal of their houses to alternative sites.

Mr. Cummings added that the Estate Authorities had given an assurance that the tenants would be granted reasonable time to remove their houses.

He assured Members that Government had been giving this matter urgent consideration for some time and in fact a survey of the housing needs of the persons to be rehoused had already been completed and a site of 10 acres in the Government Estate at La Penitence had been allocated for this purpose.

The next step would be to meet the Company as arranged to discuss further implementation of the proposals and at that meeting the question of compensation and details of the procedure for removal would be discussed.

At 3.55 p.m. the Speaker adjourned Council to 2.00 p.m. on Friday, the 30th of November, 1956.
