## ORAL ASKING AND ANSWERING OF QUESTIONS

Mr. Dey, on behalf of Rev. Bobb, asked the Chief Secretary the following question:

QUESTION: Is the Honourable Member for Education aware that a circular issued by the Director of Education forbids the admission of children who have attained the age of five years to primary schools (except those in riverain and remote areas) in which accommodation exceeds enrolment; and if so, will the Honourable Member inform this Honourable Council what is the Government's view on the circular?

The Chief Secretary gave the following reply:

#### ANSWER:

The Circular to which the Honourable Member refers was issued by the Director of Education with the approval of the Member for Education.

The Primary School population within the compulsory age group, which is from 6 years to 14 years, is increasing rapidly and many Primary Schools are already severely overcrowded. Overcrowding seriously impairs the efficiency of the teachers and the capacity of the children It has therefore been decided to learn. that until further notice no child under the compulsory age of 6 years shall be enrolled in a Primary School, except in those schools in which present accommodation exceeds enrolment, in order to ensure that children within the compulsory school age group are provided with as efficient educational facilities as possible. Children between the ages of 5 and 6 who have already been enrolled and have been attending schools will be allowed to continue in school.

## INTRODUCTION OF BILLS

The <u>Chief Secretary</u> gave notice of the introduction and first reading of the following Bill:

## Receipt of letter re Marriage (Amendment) Bill, 1957.

The Speaker informed members that he had received a letter signed by several persons who were preparing to enter a protest against the amendments proposed to the Marriage Bill.

He expressed the view that as the proposed legislation affected a large number of persons, including Hindus and Muslims, every opportunity should be afforded them to submit representations.

He added that he would inform the signatories to the letter that representations in the matter should be made to the Honourable Chief Secretary who was the Member in charge of the Bill.

#### MONEYLENDERS BILL, 1957 - Bill No. 11/1956.

Before proceeding with the Order of the Day, the Speaker referred to the Moneylenders Bill (No. 11 of 1956) passed by Council on the 17th of April, 1957, and informed members that there were certain minor imperfections in the Bill which it was desirable should be corrected.

He therefore invited Council to approve of the following corrections in the Bill, copies of which had been circulated to members:-

# Clause 6 - Sub-clause (1) - Paragraph (c):

The word "from" to be substituted for the word "for" in the last line.

# Clause 8 - Sub-clause (1) - Paragraph (b):

The word "from" to be substituted for the word "for" in the fourth line.

## Clause 10 - Sub-clause (2):

The word "from" to be substituted for the word "for" in the penultimate line.

# Item 3 - CRIMINAL JUSTICE BILL, 1957 - Bill No. 13/1957.

On a motion by the Attorney General seconded by the Chief Secretary the BILL intituled AN ORDINANCE TO ABOLISH PENAL SERVITUDE AND IMPRISONMENT WITH HARD LABOUR was read a second time and was thereafter taken through the Committee stage and passed with the undermentioned amendments:-

#### Clause 3 - New sub-clause (3):

The following was inserted as sub-clause (3):

"(3) Where any person is at the commencement of this Ordinance the holder of a licence granted under the Convicts' Licences Ordinance which has not been forfeited or revoked, he shall be treated as if his sentence had expired."

## New Clause 5:

The following was inserted as Clause 5:

"Repeal of 5. The Convicts' Licences Cap. 79. Ordinance is hereby repealed."
