RAISING OF A MATTER OF PRIVILEGE

Inaccurate Press Report

The Honourable Janet Jagan, Minister of Labour, Health and Housing, referred to an inaccurate press report published in the Daily Argosy of the 30th of October, 1958, concerning her remarks in the Legislative Council on Mr. Jai Narine Singh's motion recommending the appointment of a Committee to revise the Greater Georgetown Plan.

The Minister stated that neither had a letter written to the Editor of the Press concerned been published, nor a correction of her remarks been made.

Mrs. Jagan added that if the Press continued to misquote her she would be obliged to take further action.

Item 3 - MUNICIPAL COUNCILS (POSTPONEMENT OF ELECTIONS) BILL, 1958 - Bill No. 28/1958.

On a motion by the Minister of Community Development and Education seconded by the Attorney-General, the BILL intituled AN ORDINANCE TO PROVIDE FOR THE POSTPONEMENT OF EIECTIONS TO THE TOWN COUNCILS OF GEORGETOWN AND NEW AMSTERDAM AND FOR PURPOSES CONNECTED THEREWITH was read a second time and was thereafter taken through its remaining stages and passed as printed.

Item 4 - SHOPS (CONSOLIDATION) BILL, 1958 - Bill No. 30/1958.

With Council's consent in terms of Standing Order No. 48, the Minister of Labour, Health and Housing moved and the Minister of Communications and Works seconded that the BILL intituled AN ORDINANCE TO CONSOLIDATE AND AMEND THE LAW TO REGULATE THE OPENING AND CLOSING HOURS OF CERTAIN SHOPS AND THE HOURS OF WORK OF SHOP ASSISTANTS; TO PROVIDE FOR THE WELFARE OF SHOP ASSISTANTS; AND TO PROVIDE FOR OTHER MATTERS CONNECTED THEREWITH be read a second time.
