That this Council approves of the Estimates of Development Expenditure for the year 1959 which have been laid on the Table, with the amendments recommended in the Report of the Finance Committee of the Legislative Council dated 7th February, 1959, totalling TWENTY-ONE MILLION, FOUR HUNDRED AND FIFTY-FOUR THOUSAND SIX HUNDRED AND SIXTEEN DOLLARS as detailed by Heads in the undermentioned Schedule and of the projects therein being financed from the Development Fund Ordinance, 1954.
