To the new Parliamentarians, first, I congratulate you on your respective appointments. The responsibilities that come with membership of the Honourable House require dedication, unbiased dialogue, integrity and most importantly, acting in the best interest of the people of Guyana, without whom, we all would not have been here today. When an individual is nominated by a list of electors on nomination's day, he/she does so with the understanding that your constituents are entrusting you with their lives, their future and will rely on you to represent them by speaking on their behalf. As you took your oaths today, I urge you therefore to always be accessible to your constituents and to uphold your vows to the people of Guyana.

To those who have returned to continue your sterling contributions to your country, I say welcome back and let us continue in our resolve to make betterment for our people.

As we embark on the commencement of the agenda of the assembly, I am enthusiastic and dedicated to making this Twelfth Parliament, one that will positively impact on pertinent issues such as constitutional reform, legislative reform, and the implementation of new laws/ Acts that caters for our changing realities.
