1. Death of Mr. Michael Anthony Abraham

"Honourable Members, I was informed of the death of Mr. Michael Anthony Abraham a former Member of Parliament who died on the 7th May, 2019 at his residence, Diamond, East Bank Demerara, after a period of illness. He was 70 years old having been born on the 26th September, 1948. Mr. Abraham came from the United Force.

Elections were held on Monday, 16th July, 1973, under the system of proportional representation for 53 Members of the National Assembly.

The Third Parliament of Guyana commenced when the National Assembly first met on the 26th July, 1973. During the latter part of the Third Parliament, Mr. Michael Anthony Abraham was appointed an ordinary Member of the National Assembly on the 3rd April, 1978.

He made and subscribed the oath of Office on that date. Mr. Abraham served in the Third Parliament until it was dissolved on the 25th October, 1980. On the 15th December, 1980, Elections were held under the system of proportional representation for 65 Members of the National Assembly.

The Fourth Parliament of Guyana commenced when the National Assembly first met on the 30th January, 1981. Mr. Abraham was again declared to be an ordinary Member of the National Assembly by the Elections Commission on the 28th December, 1980, and served in the Fourth Parliament until it was dissolved on the 31st October, 1985. Elections were held on Monday, 9th December, 1985.

The Fifth Parliament of Guyana commenced when the National Assembly first met on the 3rd February,1986. Mr. Abraham was again declared to be an ordinary Member of the National Assembly by the Elections Commission on the 24th December, 1985.

Mr. Abraham served in the Fifth Parliament until it was dissolved on the 29th August, 1992. Mr. Abraham ceased to be a Member of the National Assembly on that date.
