ANNOUNCEMENTS BY THE SPEAKER-

The Speaker made the following announcements:

TREATMENT OF OPPOSITION MEMBERS OF PARLIAMENT

"Late last evening I received an email containing a letter re. Treatment of Opposition Members of Parliament from the Honourable Leader of the Opposition, making a number of serious allegations. He declared that he and other Hon. Members were locked out on allegations of being instructed by the Speaker. He also made several other allegations against the Speaker. These will be dealt with subsequently; he calls for an apology.

He asserts "We understand that they were acting upon your instructions", when referring to the alleged "Treatment of Opposition Members of Parliament by members of the Guyana Police Force. I am disheartened, disappointed but not distressed, that the Honourable Member, holding such an important title in the National Assembly, while being a practicing Attorney-at-Law in Guyana would intentionally traverse this route of basing allegations on mere hearsay. Further, not only is he an Attorney-at-Law but has been a Member of the said House for over ten (10) years.

To make such irresponsible and damning allegations against the Speaker of the National Assembly is highly condemnable. It ought to be within his basic knowledge that not only is his assertions based on hearsay, but also, that the Speaker of the National Assembly has no jurisdiction over the operations of the Guyana Police Force.

Further, his allegations of alleged 'Orders' by the Speaker simultaneously while he is presiding over the house is ludicrous.

I add that the allegations of the Honourable Members being locked out and shut-in warrants a response. The 18th Sitting began with A Partnership for National Unity & Alliance for Change Members in the House. I note that the Honourable Vincent Henry was the last to leave. I also note Members from all sides partaking in the fare in the Members of Parliament lounge.

In addition, Members of the APNU-AFC greeted H.E. President Dr. Mohamed Irfaan Ali with much enthusiasm and loudness. What happened outside the compound of the Arthur Chung Conference Centre remains a matter for inquiry and the police".

The Senior Minister in the Office of the President with Responsibility for Finance then moved the motion for the approval of the Estimates of Expenditure for the financial year 2021 of the total sum of \$353,833,612,000 excluding \$29,247,746,000 which is chargeable by law (See Appendix).
