I met with the Lok Sabha Speaker of India, Hon. Om Birla, and we discussed the benefits of both our Parliaments working together. I also met with H.E. 8. <u>DEATH OF MR. SEWDIAL PERSAUD WHILE IN POLICE CUSTODY ON 17<sup>TH</sup></u>
<u>JUNE, 2021</u>

The death of Mr. Sewdial Persaud, 45, of Number 58 Village, Corentyne, Berbice, while in police custody on 17<sup>th</sup> June, 2021, has triggered serious concerns and calls for justice by his family and members of the community in which Mr. Persaud resided.

- 2) Could the Hon. Minister say whether all required Standard Operations Procedures were followed before, during and after the arrest of Mr. Persaud?
