- D. For the period 1st August 2020 to 1st April 2021, can the Honourable Minister inform the National Assembly, how many persons were apprehended and charged for cocaine trafficking/possession of amounts more than five pounds in Guyana and the number of incidences?
- E. For the period 1st August 2020 to 1st April 2021, can the Honourable Minister further inform the National Assembly, how many persons in Guyana were apprehended and charged for cocaine trafficking of amounts more than five pounds and the number of incidences, when cocaine was intercepted in a second country, but was trafficked from Guyana?

ANSWERS

- A. "During the period 1st August, 2020 to 1st April, 2021, 19.066 pounds were found. Three times cocaine was allegedly shipped from Guyana to a second country.
- B. During the period 1st August, 2015 to 1st January, 2016, 99.173 pounds of cocaine were found:
 - Seven (7) times, Cocaine allegedly shipped from Guyana to a second country. On four (4) occasions the information was passed to counterparts from Guyana.
- C. For the period 1st August, 2020 to 1st April 2021, (2) males were charged for Trafficking in Narcotics to wit 7.26 pounds.

D. During the period 1st August, 2020 to 1st April 2021, (2) males were charged for Trafficking in Narcotics to wit 7.26 pounds.

Additionally, three (3) incidences of cocaine were intercepted overseas that was allegedly shipped from Guyana.

- ➤ On 26th May, 2020, 1.5 tonnes of cocaine were allegedly shipped from Guyana to Hamburg, Germany. It was intercepted in August, 2020.
- ➤ On 25th September, 2020, 11.5 tonnes of cocaine were allegedly shipped from Guyana to Antwerp, Belgium. It was intercepted in October, 2020.
- ➤ On 24th February, 2021, 307. 324 pounds of Cocaine were allegedly shipped from Guyana to Jamaica. It was intercepted on 2nd March, 2021."

- 7. The Vetting process reviewed by the Ministry for persons employed and authorized to carry firearms in companies includes the submission of a medical report, Police Clearance, background check done by the Special Branch and Criminal Investigations Department, observance of Supernumerary Status, completion of two weeks training conducted by the Tactical Service Unit and a report submitted to the Commissioner of Police indicating whether the person/s would have met the criteria.
- 8. No, there was no advertisement for tenders.

- 11. Due to the sensitive nature of the security concerns, confidentially and trust, the Ministry opted to use the single source method of procurement. In addition, the contracts are less than 1.5 million.

6. FIRE AT THE PSYCHIATRIC HOSPITAL ON 5TH JUNE, 2021

Member Asking: Ms. Geeta Chandan-Edmond, M.P.

Minister Answering: The Minister of Health

- (1) Could the Honourable Minister indicate to the House, the causes, circumstances, and conditions that led to the fire on Saturday, 5th June, 2021, whereby several patients at the Psychiatric Hospital, East Canjie/Berbice, were badly burnt during the said fire, and further whereby it was widely reported in the media that one patient named Wewoushi Akenty King died from his injuries?
- (2) Can the Hon. Minister state the nature of all the injuries sustained by the affected patients, on the date aforementioned, and the cause of death of Wewoushi Akenty King?
- (3) Could the Hon. Minister state whether the conduct of the staff of the Psychiatric Institution, who were on duty on 5th June, 2021, and thereafter was in conformity with existing Standard Operating Procedures?
- (4) Could the Hon. Minister state base on the conclusion of any investigation report, whether the death of the aforementioned patient and the patients who were burnt, was a result of any negligence, abandonment of duty, disregard of instructions, inaction of the staff, who were on duty on 5th June, 2021, and thereafter?

- (5) Could the Hon. Minister indicate based on any initial report(s), what recommendations were made:
 - (i) To improve the physical infrastructure of the Institution?
 - (ii) The existing security, safety, and other arrangements in respect of the custody, management, and control of patients?
 - (iii) That the appropriate treatment of patients is in compliance with legal and other requirements, to prevent a recurrence of any such disturbance(s)?

(Notice Paper No. 136 (Q106 Opp.106) published on 2021-09-22)

ANSWERS

- 1. "On the evening of the 5th June 2021, there was a fight among three patients in Chalet 4. The staff on duty spoke to the patients, and eventually, the fighting subsided. A patient subsequently lit a mattress which resulted in the partial burning of the Chalet 4. At 7.51 pm, the supervisor raised an alarm about a fire in Chalet 4. The staff immediately contacted the Guyana Fire Service and the Guyana Police Force. The Guyana Fire Service responded promptly and extinguished the fire.
- 2. Ten patients housed in Chalet 4 sustained varying degrees of burn injury.
 - Four patients were initially admitted to the New Amsterdam Hospital, one was discharged. At the same time, three were transferred to the Georgetown Public Hospital Burns Unit for further care on the 8th of June, 2021.
 - While at GPHC, two of the patients were subsequently discharged and sent back to the Psychiatry Hospital.
 - Patient Wewousi King was admitted to GPHC on the 8th of June 2021, with a diagnosis of burns, and pneumonitis/ pneumonia due to smoke inhalation. At

GPHC he was managed by a team of doctors from the Burns unit, the Internal Medicine Department and the Psychiatry Department. Despite the Medical treatment Mr. King succumbed on the 18th June, 2021. The postmortem confirmed that he died from pneumonia and burns injury.

- Six patients were admitted to Port Mourant Hospital with minor burn injuries; these patients were discharged within 48hrs.
- 3. The Standard Operating Procedures were adhered to, and the relevant actions were taken promptly.
- 4. None of the investigations concluded that there was any negligence, abandonment of duty, disregard of instructions or inaction of the staff.
- 5. To improve the physical infrastructure of the Institution:
 - Nonflammable ceiling materials.
 - Rubberized tiles on the floor o Window grills that are easily accessible to staff o Single rooms for aggressive patients.
 - (ii) The existing security, safety, and other arrangements in respect of the custody, management, and control of patients:
 - In the reconstruction of Chalet 4 single rooms were added; these would be used to house aggressive patients.
 - A security hut was placed next to the male admission ward.
 - Cameras will be installed to allow for observations of patients.

- Work has started to arrange inpatient and outpatient services. Once
 patients have been stabilized, they can be discharged and followed
 up through outpatient clinics.
- Legislation governing psychiatric care is outdated. New legislation to govern psychiatric services will be laid in the near future.
- The government is also working with several international partners to improve the quality of care."

INTRODUCTION OF BILLS-

Presentation and First Readings

1. <u>HUMAN ORGAN AND TISSUE TRANSPLANT BILL 2021 – Bill No. 19/</u> 2021

The Minister of Health, on behalf of the Government, presented the following Bill, which was read the first time:

A BILL intituled AN ACT to make provision for the donation and removal of human organs, tissues, cells and biofluids for transplantation and blood for transfusion, for their use for regenerative medicine including cell therapy, gene therapy and stem cell therapy, and other therapeutic purposes, for medical education and for scientific research purposes including stem cell research, cell explant research and cell line research, and for connected matters.

2. NATURAL RESOURCE FUND BILL 2021 – Bill No. 20/2021

The Senior Minister in the Office the President with Responsibility for Finance, on behalf of the Government, presented the following Bill, which was read the first time: A BILL intituled AN ACT to establish the Natural Resource Fund to manage the natural resource wealth of Guyana for the present and future benefit of the people and for the sustainable development of the country, and for connected matters.

3. **LOCAL CONTENT BILL 2021 – Bill No. 21/2021**

The Minister of Natural Resources, on behalf of the Government, presented the following Bill, which was read the first time:
