ITEM 1 - LOCAL CONTENT BILL 2021 - Bill No. 21/2021 published on 2021-12-15

The Minister of Natural Resources moved the second reading of the following Bill:

A BILL intituled AN ACT to provide for the implementation of local content obligations on persons engaged in petroleum operations or related activities in the petroleum sector; to prioritise Guyanese nationals and Guyanese companies in the procurement of goods and services for the enhancement of the value chain of the petroleum sector; to enable local capacity development; to provide for the investigation, supervision, co-ordination, monitoring and evaluation of, and participation in, local content in Guyana; to promote competitiveness and encourage the creation of related industries that will sustain the social and economic development of Guyana; and for other related matters.

 - (b) any partnership between Guyanese nationals and a company constituted under subclause
 - (a) in accordance with the Partnership Act."

(ii) Mr. David Patterson, M.P., seconded by Mr. Shurwayne Holder, M.P., moved the following amendment which was **put** and **negatived**:

"Guyanese national" means a citizen of Guyana; by birth"

Clause 2 was then passed as amended.

<u>Clauses 3, 4 and 5</u> were <u>passed</u> as <u>printed</u>.

Clause 6

- (i) Mr. David Patterson, M.P., seconded by Mr. Shurwayne Holder, M.P., moved the following amendments which were **put** and **negatived**:
 - "New Clause 6 (2) (a) Any Guyanese national or Guyanese company, whose application has been refused has the right to appeal to an independent review panel appointed by the Minister, comprising of not less than three persons, one of whom must be from civil society".
 - "New Clause 6 (9) The Secretariat shall cause to be published on the website of the Ministry responsible for petroleum or any other media in wide circulation the Local Content Register, which shall be updated quarterly".
- (ii) The Minister of Natural Resources moved the following amendment which was **<u>put</u>** and **<u>carried</u>**:

By the insertion, immediately after subclause (8), of the following -

"(9) The Secretariat shall cause the Local Content Registers to be published on the website of the Ministry responsible for petroleum or any other media of wide circulation.".

<u>Clause 6</u> was then <u>passed</u> as <u>amended</u>.

Clauses 7, 8, 9, 10, 11 and 12 were passed as printed.

Clause 13

Mr. David Patterson, M.P., seconded by Mr. Shurwayne Holder, M.P., moved the following amendment which was **put** and **negatived**:

"New Clause 13 (7) A Contractor, sub-Contractor or Licensee without the written permission of the Minister acting on the advice of the Secretariat and the Local Content Oversight Committee, shall not enter into any contract in excess of (3) three years."

<u>Clause 13</u> was then <u>passed</u> as <u>printed</u>.

<u>Clauses 14, 15, 16, 17, 18 and 19 were passed as printed.</u>

 - (h) Guyana Association of Professional Engineers
 - (i) Transparency International Guyana Inc.
 - (j) Representative from local Petroleum Organisations
