1. <u>CONTRACT SIGNED BY THE MINISTRY OF HOME AFFAIRS FOR THE CONSTRUCTION OF THE GUYANA FIRE SERVICE HEAD QUARTERS AT HOMESTRETCH AVENUE, GEORGETOWN.</u>

Member Asking: Ms. Geeta Chandan-Edmond, M.P.

Minister Answering: The Minister of Home Affairs

"It has been reported in the Guyana Chronicle of November 24, 2021, that the Ministry of Home Affairs signed a \$600,000,000.00 contract for the construction of the Guyana Fire Service Head Quarters at Homestretch Avenue Georgetown".

1. Can the Honourable Minister state whether there was a public bidding process for the award of the contract? If yes, when, and where?

- 2. Can the Hon. Minister state whether the awardee/s was/were prequalified?
- 3. Can the Hon. Minister state the precise grounds under which the other bidders were disqualified?
- 4. Can the Hon. Minister provide the name of the Contractor(s) who was/were awarded the contract? Further, can the Minister state what experience this/these company/s has/have in the construction or reconstruction of Fire Head Quarters? Further, can the Minister state in detail the experience the company has in similar projects?
- 5. Can the Minister state whether the company that was awarded the contract for the construction of the Head Quarters was previously awarded any other contract by the Ministry of Home Affairs? If yes, can the Minister indicate the nature and status of such contract?
- 6. Regarding (1) and (2), could the Hon. Minister state which entity was responsible for the evaluation and recommendation of the awards of the contract?
- 7. Can the Hon. Minister state what criteria was used in the pre-qualification and qualification process?
- 8. Can the Minister confirm whether this contract was awarded to the lowest bidder? If not, can the Minister state why the contract was not awarded to the lowest bidder?
- 9. Can the Hon. Minister state whether the Principal/s of any of the companies, which were awarded contracts, have any pending litigation against the Government of Guyana, or whether the Government of Guyana has any pending litigation against the Principal/s of these companies?

- 10. Can the Minister provide the National Assembly with a copy of the assessment and evaluation report justifying the awarding of the contract to the awardee(s)?
- 11. Can the Hon. Minister state what percentage of the total budgeted allocations for 2020 has been expended on the award of this contract?

(Notice Paper No. 154 (Q119 Opp.119) published on 2022-01-19)

ANSWERS

- 1. Yes, there was a public bidding process. Solicitation of bids were done in the Guyana Chronicle, Stabroek News, Kaieteur News and Guyana Times Newspapers from the 6th to 24th October, 2021.
- 2. No, the awardee was not prequalified by the Ministry of Home Affairs.
- 3. The Ministry of Home Affairs was not part of the Evaluation Committee nor in anyway involved in the evaluation process. Hence, I cannot answer on which grounds the other bidders were disqualified.
- 4. Mohamed's Enterprise was awarded the Contract for the construction of the Headquarters for Guyana Fire Service. Matters of experience from part of the evaluation criteria of which I am not privy to, and as such I would not be able to comment on this.
- Yes. Mohamed's Enterprise was awarded the Contract for the construction of the Lusignan Prison – Lot 1 by the National Procurement and Tender Administration Board (NPTAB). This project is approximately 80% completed.
- 6. The National Procurement and Tender Administration Board was responsible for appointing Evaluation Committee, and it was that Committee that made its recommendation for the award of the contract.

7. The Ministry is not aware of any pre-qualification process. Evaluation was done by an

Evaluation Committee appointed by (NPTAB), and that Committee determined

qualification of bidders.

8. No, I cannot confirm whether this contract was awarded to the lowest bidder as the

Ministry was not part of the evaluation process.

9. No, I cannot state whether the Principal/s of any of the companies which were awarded

contracts have any pending litigation against the Government of Guyana or vice versa.

10. No, the Evaluation Report is in the possession of the National Procurement and Tender

Administration Board (NPTAB).

11. 2.5% of the total budgeted allocation for 2021 (Agency Level) and 14.1% of the 2021

capital budgeted allocation.

with the aim of having in place a comprehensive legislation?

ANSWER

The Guyana Fire Service Act would have been in existence for over sixty-five (65) years. In the view of the past and present commercial, economical and fire related conditions in Guyana, the Guyana Fire Service Act is somewhat antiquated, giving urgent need for amendments to be made to few chapters of the act.

3. PRELIMINARY OR FINAL REPORT FROM THE GUYANA FIRE SERVICE IN RELATION TO THE FIRE AT THE BRICKDAM POLICE STATION.

Member Asking: Ms. Geeta Chandan-Edmond, M.P.

Minister Answering: The Minister of Home Affairs

- B. Can the Minister say how was the said report generated and what was the methodology used to determine the findings of the said report?
- C. Can the Minister indicate if a Board of Inquiry was established to inquire into the circumstances surrounding the fire and can the Minister share the terms of reference of the said Board of Inquiry with the Assembly?
- D. Apart from any investigations conducted by the Guyana Fire Service, can the Hon. Minister indicate whether the government has any intentions to have this fire investigated independently or seek international assistance?

- E. If yes, have you established any team to investigate this fire at the level mentioned above?
- F. Additionally, can the Hon. Minister state what are the intended terms of reference for any such independent Inquiry, and do you plan to solicit international assistance in any regard?
- G. Can the Hon. Minister state whether the government has any intentions to consult with civil society, Parliamentarians, or any other non- governmental organization to be a part of the process?
- H. Can the Minister state in relation to (d), if the process has not begun, can he indicate the reason for the delay?
- I. Is there any intention or consideration by Cabinet to establish a Commission of Inquiry into this major national disaster?

- A. Yes, there is a final report on the incident. The matter is receiving attention at the Courts and the finalized report will be eventually made available to the National Assembly.

4. FIRE HYDRANTS IN GUYANA AND THEIR LOCATIONS.

Member Asking: Ms. Geeta Chandan-Edmond, M.P.

Minister Answering: The Minister of Home Affairs

"It was widely reported at a Press Conference on the 3rd October, 2021, hosted by the Hon. Minister of Home Affairs along with members of the Disciplined Forces, that at least 80 % of the Brickdam Police Station was destroyed by fire".

- (a) Can the Minister provide a list of all fire hydrants in Guyana and their locations? Can the Minister indicate what percentage of these are functional?
- (b) Can the Minister indicate how long fire hydrants that are not functional have been in this state? Can the Minister list all actions that have been taken to fix these fire hydrants?
- (c) Can the Minister indicate what percentage of public buildings in the country do not have access to a fire hydrant due to their absence or as a result of the hydrants not being functional?
- (d) Can the Minister indicate whether an assessment was conducted to determine whether there is a need for additional fire hydrants? If yes, can the Minister indicate the locations that are in need for additional fire hydrants.
- (e) Can the Minister indicate whether all fire hydrants within the country have ready access to water? If not, can the Minister indicate the locations of those fire hydrants that do not have ready access to water and the steps taken by the Ministry to ensure that all fire hydrants have a ready access to water?

(Notice Paper No. 157 (Q122 Opp.122) published on 2022-01-19)

ANSWERS

- (a) It must be noted that of the seven hundred and seventy-seven hydrants that are available country wide only 33% are fully functional. See **Appendix I**.
- (b) In the city of Georgetown hydrants were inoperable for a number of years where the city developed, and the hydrants were left behind. A total of 471 fire hydrants were found to be inoperable in Georgetown following an assessment by the Guyana Fire Service. Several actions were taken to fix Fire Hydrants in and around the city. This was done in conjunction with Brass Aluminum Cast Iron Foundry to fabricate new hydrants using compatible moldings and 151 hydrants were repaired by Compass Industrial Services.
- (c) A definite answer is not available. However, the Guyana Fire Service has an ongoing campaign, with direct focus on the implementation of new Fire Hydrants at specific Key Points (KP's) and Vulnerable Points (VP's), rehabilitation of existing ones and the upgrading of other Fire Hydrants around the country.
- (d) An assessment was conducted to determine whether or not there is need for more Fire Hydrants in and around the Capital City and by extension within the other Administrative Regions and as a consequence it was observed that there is need for Fire Hydrants in Vreed-en-Hoop, Parika, Charity, Diamond, Dairy, Rosehall, Corentyne, Canje, Linden, Port Kaituma, Lethem, Bartica, Anna Regina and Mabaruma.
- (e) Not all fire hydrants have access to water, in the country only a few hydrants are disconnected from the main due to vehicular accidents. These hydrants are deemed to be needing major repairs and will be repaired with the remainder of the inoperable hydrants.

The Senior Minister within the Office of the President with Responsibility for Finance reported that the Committee of Supply had considered the Estimates of Expenditure for the financial year 2022 and had approved of them as printed.

NOW, THEREFORE BE IT RESOLVED:

That this National Assembly approves the Estimates of Expenditure for the financial year 2022, of a total sum of five hundred and one billion, six hundred and seventy-eight million, two hundred and ninety-eight thousand dollars (\$501,678,298,000), excluding fifty one billion, two hundred and fifty-five million, and four hundred and twenty thousand dollars (\$51,255,420,000) which is chargeable by law, as a detailed therein and summarized in Schedule 1, and agree that it is expedient to amend the law and to make further provision in respect of finance;

BE IT FURTHER RESOLVED:

That the National Assembly approves the recommended lump sum subvention for each Constitutional Agency for the financial year 2022 as stated in Schedule 2, amounting to a total sum of eleven billion, seven hundred and twenty-nine million, eight hundred and forty thousand dollars (\$11,729,840,000) which is charged upon the Consolidated Fund by the Constitution and for the sums voted for the Constitutional Agencies to form part of the Estimates of Revenue and Expenditures of Guyana for the financial year 2022.

BE IT FURTHER RESOLVED:

That this National Assembly approves the sum of \$126,694,310,000, equivalent to US\$607,646,570.98, to be withdrawn from the Natural Resources Fund for the financial year 2022 in accordance with the Natural Resource Fund Act 2021.

Thereafter, the motion for the approval of the Estimates of Expenditure for the financial year 2022 was <u>put</u> and <u>carried</u>.

ITEM 1 – APPROPRIATION BILL 2022 – Bill No. 1/2022 published on 2022-09-10

Hon. Khemraj Ramjattan, M.P., spoke to the motion.

Thereafter, the Senior Minister in the Office of the President with Responsibility for Finance replied.

The Bill was then read a second time.

Assembly resolved itself into Committee to consider the Bill clause by clause.

In Committee

<u>Clauses 1 and 2</u> were <u>passed</u> as <u>printed</u>.

The Schedule was passed as printed.

Assembly resumed

On a motion by the Senior Minister in the Office of the President with Responsibility for Finance, the Fiscal Enactments (Amendment) Bill 2022 was read a third time and <u>passed</u> as <u>printed</u>.

ADJOURNMENT

At 4.28 p.m., on a motion by the Prime Minister, the Assembly was adjourned to a date to be fixed.
