# Clause 4

The Attorney General and Minister of Legal Affairs made the following amendments which were <u>put</u> and <u>carried</u>:

Amendment of section 4 of the Principal Act Sub-Clause (2B).

Deletion of "and (4)" after "sections 3(2)" in the last paragraph of the subclause.

Clause 4 was then passed as amended.

<u>Clause 5</u> was <u>passed</u> as <u>printed</u>.

# Clause 6

The Attorney General and Minister of Legal Affairs made the following amendments which were <u>put</u> and <u>carried</u>:

Amendment of section 12 of the Principal Act Sub-Clause (1A).

"Deletion of "and (4)" after "sections 3(2)" in the third to last line of the sub-clause".

Amendment of section 12 of the Principal Act Sub-Clause (2A), paragraph (b).

"Deletion of "and (4)" after "sections 3(2)" in the last paragraph of the sub-clause".

Clause 6 was then passed as amended.

# Clauses 7 was passed as printed.

# Clause 8

The Attorney General and Minister of Legal Affairs made the following amendments which were <u>put</u> and <u>carried</u>:

Amendment of section 73 of the Principal Act.

"Deletion of sub-section (9) of section 73 of the Principal Act".

Clause 8 was then passed as amended.

# **Assembly resumed**

On a motion by the Attorney General and Minister of Legal Affairs, the Narcotic Drugs and Psychotropic Substances (Control) (Amendment) Bill 2021 was read a third time and <u>passed</u> as <u>amended</u>.
