Added to this, the Government has embarked on the development of the Agro-Processing industry to enhance exports and reduce the country's import dependence by creating an enabling environment for an efficient and competitive local manufacturing sector, establishing 13 processing facilities across Guyana, benefiting approximately 2,500 farmers".
