In Committee

Clauses 1 to 16 were passed as printed.

Clause 17

The Attorney General and Minister of Legal Affairs moved the following amendments which were put and carried:

"Delete Clause 17 which seeks to amend Section 37A of the Principal Act".

Clause 17 was then deleted.

Clauses 18 to 49 were passed as printed.

Assembly resumed.

On a motion by the Attorney General and Minister of Legal Affairs, the Anti-Money Laundering and Countering the Financing of Terrorism (Amendment) Bill 2023 was read a third time and **passed** as **amended**.
