I commented on that. Sometimes, one wants to question the type and level of life of Members of Parliament. That afternoon at the People's Parliament at Stabroek Market, the Hon. Member, Ms. Catherine Hughes, said, 'so imagine today in Parliament we had brought what we call a motion which was just two pieces of paper saying the things we wanted to discuss. And believe it or not, once again, the Speaker decided we must not even have a discussion. Now what is the point of having Parliament?

I will say again, as Speaker Ralph Ramkaran has stated, if you have a criticism of the Ruling of the Speaker, bring a motion. I will repeat, again, in particular with parliaments from which most of the Westminster system parliaments derive their standing orders and rules, if the Speaker gets angry with you, he does not allow you to speak period outside of the other remedies within the Standing Orders. So, I urge, again, Hon. Members, to please be careful as you comment on decisions that the Speaker makes".
