The Clerk invited Members to elect a person to be the Speaker of the National Assembly in accordance with Article 56(1) of the Constitution and Standing Order No. 2 of the Standing Orders of the National Assembly.

The Hon. Brigadier (Ret'd) Mark Anthony Phillips, M.S.S., proposed and the Hon. Gail Teixeira seconded the nomination of Mr. Manzoor Nadir.

As there was no other nomination, the Clerk declared Mr. Manzoor Nadir duly elected Speaker of the National Assembly.
