QUESTIONS TO MINISTERS -

For Oral Replies

No. 1 - SOLAR WATER PUMP SYSTEM AT PARAMAKATOI

Mrs. Sheila Holder asked the Minister of Housing and Water the following questions:

- *Could the Minister say why the newly installed solar water pump system at Paramakatoi (PK) is not supplying water at its installed capacity, six four hundred gallon plastic overhead tanks to the PK community or even at 30% of its installed capacity?
- *Could the Minister say when PK residents could expect to reap the benefits of the potable solar water system that is not functioning to date?
- *Would the Minister indicate the cost of the solar water pump system installed at **PK**?

- *Was the solar water system at PK contracted out or installed by GUYWA?
- *If so, to whom was the contract given, and what is the sum paid to the contractor for the installation of the system?

Oral replies by the Minister of Housing and Water

- (i) "The yield of the well was significantly reduced due to the prolonged dry season and this is not confined to Paramakatoi. There are several other locations in Regions 7 and 8 where this had occurred. The solar pump will operate as long as there is water in the well. So, it is the question of source of supply and not a problem with the malfunctioning of the solar water system which switches itself off under low water conditions, under a self protection mechanism."
- "Under the Hinterland Strategy which will be implemented this year, and for which GWI will be presenting a document, Paramakatoi and other villages in Regions 7 and 8 will come for special consideration for improvement of water supply. The main problem is the source of supply. During 2000 and 2001, many wells were drilled in Regions 7 and 8 and many of them failed. So we have to utilise new technology and to conduct a hydrocensus in these areas which will be done during the year 2003 and 2004, to ensure that we have sources of supply of water. Funds are available for this purpose."

- (iii) "In terms of the cost of the Paramakatoi water supply system, the cost of \$7.5 million are as follows:
 - The Solar Water Pump Unit \$2.5 million;
 - Installation of the Pump unit and fencing \$500,000
 - Supply and installation of 2.5 kilometers of pipes and rehabilitation works
 \$4.5 million.
- (iv) "The Installation of the Solar Water pump system was contracted out."
- (v) "The name of the contractor is Mohamed Ayube and the sum paid was \$300,000, which includes the cost to charter an aircraft to Paramakatoi."

No.2 - GRANT OF GUYWA MANAGEMENT CONTRACT TO SEVERN TRENT

Mrs. Sheila Holder asked the Minister of Housing and Water the following question:

*Could the Minister say what informed the decision to grant Severn Trent the GUYWA management contract when their bid was over US\$600,000 more than the other bids at a time when the government of Trinidad & Tobago, a sister CARICOM state, terminated a similar contract with Severn Trent because of unsatisfactory performance in managing the Trinidad & Tobago water utility?

Oral reply by the Minister of Housing and Water

"The contract document required two envelopes to be returned by each bidder, a technical response and a financial response. These were to be evaluated independently and points awarded for each response. In order to place emphasis on the technical qualities necessary to address the complex task of modernising the new utility and its services provision throughout Guyana, the scoring rated seventy percent for technical merit and thirty percent for price.

There were two compliance bids which were received from two firms, Bywater and Severn Trent.

Severn Trent scored better than Bywater in each of the criteria evaluated and overall their bid was scored significantly higher on technical merits."

No. 3 - PORTABLE WATER FOR RESIDENTS OF BAMBOO CREEK

Mrs. Sheila Holder asked the Minister of Housing and Water the following question:

*Bamboo Creek in Region 8 that has a population of approximately 500 people has been experiencing severe problems in accessing water for drinking and domestic purposes.

Would the Minister say what his Ministry could do to alleviate this desperate situation where there is no available water from springs and creeks during the dry season?

Oral reply by the Minister of Housing and Water

"The Ministry, under the Hinterland strategy, which will come on stream this year, will be drilling a number of wells. Before this is done, a feasibility study will be carried out, utilising new technology. Some donor support is expected for this, because it is very, very expensive."

At the request of the Minister of Parliamentary Affairs, and with the leave of the Assembly, consideration of the following motion was deferred:

WHEREAS the Revised Treaty of Chaguaramas Establishing the Caribbean Community including the CARICOM Single Market and Economy was signed on behalf of the Government of Guyana by His Excellency Bharrat Jagdeo, President of Guyana on the 5th July, 2001, at the Twenty-First Meeting of the Conference of Heads of Government of the Caribbean Community.

WHEREAS the Revised Treaty of Chaguaramas addresses specific areas of concern to the Caribbean Community including the Free Movement of Goods, Services and Capital, Rights of Establishment, Supporting and Facilitating Measures and Policies, Private Sector Participation and External Interface and Decision Making, Institutional and Administrative Structures.

AND WHEREAS Article 233 of the said Revised Treaty states that "This Treaty and any amendments thereto shall be subject to ratification by Signatory States in accordance with their respective constitutional procedures."

BE IT RESOLVED that the National Assembly hereby agrees to the Secretary General of the Caribbean Community being informed of Guyana's intention to ratify the said Revised Treaty of Chaguaramas Establishing the Caribbean Community including the CARICOM Single Market and Economy by the deposit of an appropriate Instrument of Ratification.
