QUESTIONS TO MINISTERS

For Oral Replies

No. 1 - USE OF BAGASSE TO GENERATE ELECTRICITY

Mrs. Sheila Holder asked the Minister responsible for Agriculture the following question:-

*Would the Minister of Agriculture say whether the policy makers of GUYSUCO have studied the benefits to be derived from the use of Bagasse for generating electricity to supply to the national grid and the the production of power alcohol as employed by countries such as Cuba, Brazil, Mauritius and more recently Belize?

No. 2 - CO-GENERATION AND POWER ALCOHOL PRODUCTION

Mrs. Sheila Holder asked the Minister responsible for Agriculture the following question:-

*Would the Minister of Agriculture say if co-generation and power alcohol production are being considered in efforts being employed by GUYSUCO to make Guyana's sugar industry viable and, if not, why?

Oral replies to questions 1 and 2 by the Minister responsible for Agriculture

"Mr. Speaker, I seek your permission to answer both questions together."

"Mr. Speaker, the answer to both of these questions is, yes. Generation of electricity from bagasse has been considered for a number of years. Recent improvements in technology especially in countries like India have encouraged us to focus on this technology as has been relevant to GUYSUCO and to Guyana.

In-house studies on co-generation are being reviewed. Recently a high powered technical delegation of experts from India visited several of our factories and presented a preliminary report on the potential of generating 2.5 megawatt of electricity from the Albion Factory and also recommended that power alcohol production be considered for the industry. We are awaiting the completion of this final report."

No. 3 - BAMBOO CREEK PRIMARY SCHOOL

Mrs. Sheila Holder asked the Minister of Education the following question:-

*The Primary School at Bamboo Creek in Region 8 was built to accommodate a maximum population of 60 children. It now has a school population of 129 children. Could the Minister say what arrangements are in place to extend the school during this year?

Oral reply by the Minister of Education

"Mr. Speaker, this question states that the Primary School at Bamboo Creek in Region 8 was built to accommodate the maximum population of sixty children. It now has a school population of one hundred and twenty-nine.

Mr. Speaker, as of July of this year, that is not a true statement. The population of the school is eighty-six. Nonetheless, the school was indeed built in 1997, to alleviate the difficulties of children walking miles to Paramakatoi to attend classes. The present state of overcrowding, that is, children over sixty that are there, is due to the introduction of a nursery class. This year, the Region intends to erect a building for the nursery school."

No. 4 - PROCUREMENT SUPPLIES FOR GUYSUCO

Mrs. Sheila Holder asked the Minister responsible for Agriculture the following question:

Please list which companies/firms/agencies have won tenders or have been suppliers for the procurement of GUYSUCO factory equipment, agriculture machinery, vehicles, spare parts, fertilizers, drugs and other purchases as well as the related cost thereof per company/firm for the period since the beginning of the Booker/Tate management contract to the present time.

Written reply by the Minister responsible for Agriculture

"Such records are kept for a statutory period of seven (7) years. It should be noted that Guysuco processes over four hundred (400) orders per month covering a range of forty-five thousand (45,000) stock items. To provide this information will utilize a considerable amount of time.

Guysuco does have well regulated procurement procedures that are audited regularly.

There are two levels at which tender awards are made. One is at the estate senior management level, while the other is at the Board of Directors level. No significant breaches of procedures have been reported by Guysuco's auditors".

that a quorum shall consist of the Chairman and two Members, one of whom was nominated by the President and one of whom was nominated by the Leader of the Opposition.
