ANNOUNCEMENTS BY THE SPEAKER

(i) Defects in the Fourth Report of the Appointive Committee

The Speaker made the following announcement:

"At the last sitting of the National Assembly on the 24th November, 2003, the Honourable Member Ms. Gail Tiexiera alleged that mischief was responsible for the defects in the Fourth Report of the Appointive Committee which was approved for presentation to the National Assembly. Substantial amendments were made to the Report in order to correct the errors.

My investigations revealed that instructions were given for the draft Report approved by the Appointive Committee with two minor amendments to be prepared for distribution to Members of the National Assembly. There appeared to be no necessity to check the Report upon completion as the final draft had already been closely perused and the amendments were minor. In addition the staff involved had other urgent responsibilities to discharge in relation to the business of the National Assembly.

Due to an error the two minor amendments were made to an earlier draft of the Report, rather than to the final draft. As a result, it was the earlier draft, amended as instructed, which was circulated to Members of Parliament.

The staff of the Parliament Office would like me to convey their regret at the error and the resulting inconvenience caused to Members of Parliament.

I have already ruled in the past that accusations of wrongdoing by Members of Parliament against persons, particularly those who are not in a position to answer, are unacceptable. In the circumstances I now direct the Clerk to expunge from the record the accusation of mischief made in the National Assembly by Hon. Member Ms Gail Tiexiera and adopted by Hon. Member Mr. James Mc Allister.

I wish to reiterate my fully confidence in the integrity of the staff of the Parliament Office which I expressed on the 24th November, 2003, and I take this opportunity to express my personal gratitude to these dedicated public servants who serve the National Assembly and the people of Guyana far, far beyond the normal call of duty particularly at this time when experienced staff are having to bear the main burden of the vastly expanded work of the recently elected Committees. ²²

STATEMENTS BY MINISTERS-

The FTAA 8th Ministerial Meeting held in Miami on November 20-21, 2003

The Minister of Foreign Trade and International Co-operation made the following statement:

"The Eight Ministerial Meeting of the Free Trade Area of the Americas (FTAA) was convened from November 20 - 21 in Miami, USA. That meeting marked the commencement of the final year of the FTAA negotiations, scheduled to be completed in January, 2005.

At Miami, the Trade Ministers appraised the current state of play in the FTAA negotiations and agreed on modalities for the final phase of the negotiations toward January, 2005. In this regard the Ministers discussed the overall scope or vision of the negotiations in the context of the hemispheric SOA process (Vision of the FTAA); the integration of the smaller economies in the hemispheric arrangements (including technical assistance and financing mechanisms); and the location of the permanent site for the FTAA Secretariat.

In the run-up to the Miami Ministerial and especially following the failure of the WTO Cancun Ministerial Conference in September, the general sense among FTAA countries was that the FTAA process would not be able to sustain its original scope or ambition for the agreed January, 2005 completion date.

The major disagreements which erupted earlier between the US and Brazil had threatened the Miami Ministerial with a Cancun-like failure. The United States, backed by Chile, Canada, Mexico, Costa Rica and Central America, insisted on a comprehensive Agreement which maintains the original scope and coverage of each negotiating area in keeping with the mandates established by Ministers at the launch of the negotiating phase in San Jose in 1998. In the case of agriculture, however, the US and Canada, themselves major agricultural producers and exporters, have argued that unless the multilateral disciplines are first settled in the WTO regarding agricultural domestic supports etc., it would not be realistic to implement hemispheric rules.

The MERCOSUR group, led by Brazil, wanted a scaled down Vision of the FTAA and advocated a hemispheric trade accord to be comprised of or achieved through different components, namely: bilateral, plurilateral and multilateral arrangements. In this vein, countries which want to negotiate deeper or additional commitments could do so in the context of bilateral and plurilateral agreements, but within the framework of the FTAA. Concerning agriculture, however, MERCOSUR's position remains diametrically opposed to that of US/Canada.

Mr. Speaker, Guyana has always considered it to be in CARICOM's better interest to hold to the stated deadline with a trimmed agenda, common for all countries, since delaying the conclusion to the FTAA key market access issues well beyond 2005 could likely complicate matters for the region in the other external negotiations as well as delay any adjustment assistance (which is important for all negotiations) and which could likely accrue to the region under the hemispheric and sub-regional processes. In this particular sense, therefore, at the Miami Ministerial, CARICOM reaffirmed its

support for the January 2005 deadline but argued that "the agreement must have a balance of ambition, accommodating capabilities and need" and include a comprehensive package of special and differential measures in each negotiating area.

The Ministers agreed on a FTAA Vision which would be realized through a two-tiered approach. At the first level all countries will accede to a common set of rights and obligations. At the second level countries, on their own determination, may agree to additional rights and obligations on a plurilateral basis.

Mr. Speaker, Guyana remains committed to the FTAA Negotiations. In the context of CARICOM's group approach, Guyana has reaffirmed its active participation in three of the existing ten groups and committees, namely: Consultative Group on Smaller Economies, Agriculture Negotiating Group (NGAG) and the Trade Negotiations Committee (TNC)."
