(i). The Draft Legislation is being studied by a select committee organised by the subject Minister.

- (ii) The select committee's report and recommendations will go to Cabinet for consideration before the proposed legislation is sent to the National Assembly.
- (iii) The intended legislation will set criteria and pronounce on all matters related to the broadcast sector including regulation and registration of users.
- (iv) There has been no central compilation of these applications.
 Some applications include multi media capability. They are forwarded to a variety of offices and officers.

NO. 13 - FIREARMS IN REGION 8

Question by Mr. Matheson Williams (For Written Reply)

- (i) Is the Minister aware of reports from Chenapovu in Region 8 of an illegal trade in sidearme bought from Brazil?
- (ii) Is the Minister aware that Chenagovu residents complain of being at a disadvantage when faced with miners with unlicensed sidearms?

Written Reply by the Senior Minister of Home Affairs

- (1) The Minister, nor the police are aware of reports from Chenapau in Region 8 of illegal trading of side arms brought from Brazil. However, the Minister has been informed by the Police that on April 21, 1995 police from Orinduik Police Station went to Chenapau and arrested one John Washington with a .38 revolver and six rounds ammunition which were suspected to have been stolen from Armatung in Brazil. He was charged and placed before the court. Police is also looking for another person suspected of being in possession of firearms.
- (ii) The Minister is not aware of any complaint from the residents of Chenapau of being disadvantaged when faced with Miners. The records at Orinduik and Mahdia Police Stations revealed no reports by Chenapau residents of any harassment by miners in terms of the use of firearms.

(III) The Minister has not been apprised of any acute need (iv) for ammunition in the hinterland communities. How ever he has taken the opportunity to request of the police to enquire into this, and, if this be so, to see that arrangements are made by the Commander of 'E & F' Division to assist these communities in this respect.

> He has additionally requested that consideration be given to allow persons of repute to obtain permission to sell ammunition if they are so interested and can provide adequate security.

May I also take this opportunity to remind this honourable house of my appeal made previously that it will be appreciated if honourable members in possession of information requiring police intervention could bring same to the attention of the Commander of the respective division or the Commissioner of Police so that appropriate action be pursued.

In addition, Community Health Workers from Issano and Kaikan in Region 7 and Waipa in Region 8 recently completed a six(8) months updating course in maternal care and have returned to their posts.

A new batch of forty(40) Community Health Workers will commence training from 24th July. These include five(5) from Region # 7 and two (2) from Region # 8 from the following areas:-

(iv) For both Regions, Pharmaceuticals and supplies are sent on a guarterly basis.

In the case of Bartica Hospital, Pharmacouticals were sent twice this year on a quarterly basis so far. In addition whenever supplies are finished requests are made and almost every month additional supplies have been sent according to requests.

With respect to the outlying Health facilities in Region # 7, the Medex at Bartica who is the Regional Supervisor of Health Centres makes requisition for Pharmaceuticals on a quarterly basis and takes them to these facilities when he visits. These Pharmaceuticals are sent from the Bond labelled according to facility to the Medex at Bartica. So far for this year Drugs were sent twice for the other facilities in Region # 7 apart from Bartica Hospital. Ministry of Health flies drugs in at its expense and availability of flights to Kamarang for that sub- regions.

In Region # 8, Pharmaceuticals and supplies are sent directly by Guyana Airways Corporation (GAC) to Kato, Paramekatoi and Mahdia on a quarteriy basis. Drugs for outlying health posts are sent to these three locations and distributed accordingly.

One constraint is that the commercial planes very often do not have enough space to take all Pharmaceuticals and supplies in at one time and as a result there are delays in taking the drugs into these areas.

The Ministry of Health is amending its procedure for the distribution of pharmaceuticals and supplies from a guarterly to a monthly basis in order to have easier access to isolated areas in Regions 7 and 8.

At the present time all requisitions for Pharmaceuticals have been fulfilled and drugs sent out. The Chief Pharmacist is now awaiting new requisitions for the third quarter of the year.

STATEMENTS BY MINISTERS

(i) <u>Select Parliamentary Borders Committee</u>

(ii) <u>Funds for Guyana Defence Force and Guyana Police Force for</u> <u>Service in Haiti</u>

The Senior Minister of Foreign Affairs made the following statement:-

"Mr. Speaker, I have asked to make this statement in the light of recent and past experiences following upon debates in this Honourable House on two issues of National importance.

First on the establishment of a Select Committee on Border Affairs and secondly, in the case of disbursement of funds to the ranks of the Guyana Defence Force and Guyana Police Force who served in Haiti. In both cases I have been publictly accused by the Minority Leader of misleading the National Assembly. The implications here Mr. Speaker, are that I, as Foregin Affairs Minister of this country, lied on two separate occasions to this Honourable House.

Mr. Speaker, I consider these very serious charges in that the Minority Leader has raised doubts in the public domain about the credibility and integrity of the Nation's Foreign Minister with regards to his participation in the National Assembly.

Mr. Speaker while I recognise that such accusations are not uncommon in the world of politics, at the sametime, it is also important that they should not be left unanswered.

Mr. Speaker, I refer to the debate of Thursday, December 1, 1994 in this Honourable House on a Motion which I introduced proposing the establishment of a multi-party Select Committee to treat with issues affecting the country's borders.

I was accused by the Minority Leader of bringing into being a letter for the purpose of the debate on the said Motion. Moreover, I was accused of practicing "gross deception on the Members of the National Assembly and, in a way, on the public at large"

Mr. Speaker, I consider it my duty to call upon the Minority Leader, to withdraw these unfounded allegations and to reconsider his position of non-participation in the Select Committee on Border Affairs.

Mr. Speaker as regards the second issue, this has to do with the disbursement of funds to the ranks of the Guyana Defence Force and Guyana Police Force. It is to be recalled that a debate took place on this subject during the sitting of the National Assembly on 26 May 1995 when the National Assembly met to discuss Financial Paper No. 1/1995.

Certain questions were asked and reasonable answers provided based on information that was available at the time. From subsequent development it became clear that the answers provided were not satisfactory to the PNC. The issue went further not only was I accused of "<u>resorting to <u>palpable untruths</u>" but that I sought to "<u>deceive</u>" the National Assembly and that I was <u>"inaccurate</u>" in the information I provided to the National Assembly.</u>

Mr. Speaker, I wish to reiterate that the information provided at the time to the National Assembly was based on all the information at hand at the time from all agencies involved.

I wish to reassure this Honourable House that it was never my intention to invent or concoct information or figures relative to this matter.

The accusation levelled against my personal integrity and my Ministry were uncalled for and unjustifiable.

I therefore call upon the Honourable Minority Leader to withdraw his uncalled for remarks in this matter, particularly in view of the following documents I now submit to the Honourable House.

AND WHEREAS Guyana adheres to the Constitution of the International <u>Labour</u> Organisation of which it is a member since 1966;

AND WHEREAS the Government of Guyana proposes to use the provisions of the Conventions and Recommendations adopted from time to time by the International Labour Conference as aims of policy and to ratify those Conventions which are in keeping with the social philosophy of the Guyanese Society; BE IT RESOLVED:

That this National Assembly approve the conclusions set out in the State Paper on the following Conventions and Recommendations adopted at the 74th session of the International Labour Conference held in September, 1987:-

- (i) Seafargrs Welfare Convention, 1987, No. 163.
- (ii) Seafarers Welfare Recom a Mation, 1987, No. 173.
- (iii) Bealth Protection and Medical Care (Seafarers) Convention, 1987, No. 164.
- (iv) Social Security (Seafarers) Convention,
- (Revised) 1987, No. 165.
 (v) Repatriation of Seafarers Convention (Revised) 1987, No. 166.
- (vi) Repatriation of Seafarers Recommendation, 1987, No. 174,

AND BE IT FURTHER RESOLVED:

That the decision of this National Assembly be conveyed to the Director Ganaral of the International Labour Organisation.

ITEM 2 RATIFICATION OF THE PHOTOCOLS OF AMENDMENTS TO THE CHARTER OF THE ORGANISATION OF AMERICAN STATES: THE PROTOCOL OF WASHINGTON AND THE PROTOCOL OF MANAGUA

The Senior Minister of Foreign Affairs moved the following motion:

WHEREAS the Sixteenth Special Session of the General Assembly of the Organisation of American States (OAS), meeting in Washington, DC, USA, on December 14, 1992, considered amendments to the OAS Charter which would provide for new arrangements relating to representative democracy and extreme poverty;

AND WHEREAS the Sixteenth Special Session adopted the Protocol of Amendments to the Charter of the OAS known as the Protocol of Washington; AND WHEREAS the Sixteenth Special Session also approved inclusion in the OAS Charter of new provisions and modifications to address the issue of the elimination of extreme poverty;

AND WHEREAS the Nineteenth Special Session of the OAS Gameral Ass key, meeting in Managua, Nicaragua, on June 10, 1993, adopted another Protocol of Amendments to the Charter of the OAS known as the Protocol of Managua;

AND NEEREAS the Protocol of Managua addresses the problem of extreme powerty in that it specifically provides for greater effectiveness and efficiency in the area of OAS technical co-operation by marging the functions of the two existing OAS technical co-operation Councils, the Inter-American Economic and Social Council (CIES) and the Inter-American Council for Education, Science and Culture, into a new Inter-American Council for Integral Development (CIDI);

AND WHEREAS the Government of Guyana signed the Protocols of Washington and Managua on December 14, 1992 and on June 10, 1993, respectively:

BE IT RESOLVED:

That this National <u>Ass shy</u> approve the ratification by the Government of Guyana of the Protocols of <u>A endments</u> to the Charter of the Organisation of American States: the Protocol of <u>Nachington</u> and the Protocol of Managua.
