Cde. Hoyte, Vice-President (Economic Planning and Finance), reported to the Assembly that the Committee of Supply had considered and had approved of the Estimates of Expenditure for 1981 with increases to two Heads and one Division as follows:

Head 34 Labour \$1,382,100 had been increased by \$387,000 and had been passed at \$1,769,100.

Head 51 Plant Maintenance and Mire Division \$5,250,100 had been increased by \$1,732,000 and had been passed at \$6,982,100.
