#### QUESTIONS TO MINISTERS

#### No. 10 - Statistics on Women Employed, etc.

<u>Cde. Reepu Daman Persaud</u>, on behalf of Cde. Ram Karran, asked the Minister of Manpower and Co-operatives the following question:

- QUESTION: (1) Will the Minister state -
  - (i) The Number of employed wemen in the country in --
    - (a) Industry and Commerce
    - (b) Agriculture
    - (c) Domestic Work
  - (ii) The number of women engaged in the sugar industry in —
    - (a) Office Type Jobs
    - (b) Field Jobs
  - (iii) The number of women who though contributing to the N.I.S. fail to qualify for retirement benefits due to —
    - (a) Early Retirement
    - (b) Other Reasons
  - (2) Will the Minister indicate the pattern of retirement practice among women giving percentages of those who retire before the attainment of age 60?

The Minister of Manpower and Co-operatives gave the following reply:-

- ANSWER: (1) The Ministry does not have the up-to-date figures.

  The most recent census in 1980 provides the figures but the processing of the returns which is being done in Barbados is not ye completed.
  - (2) National Insurance Scheme Retirement Benefits are paid to insured workers (men and women) the only exception being contributors who have made less than fifty (50) contributions. Retirement Benefits take the form of either an Old Age Pension or an Old Age Grant. The award of either is dependent on the number of contributions the individual has paid to the Scheme. Should a worker retire before age 60 years on his or her own accord, that worker would have to wait until age 60 to the awarded retirement benefits provided that he or she has made the minimum of fifty (50) contributions.

For 1981 and 1982 no appliation for Old Age (Retirement) Benefits was disqualified due to insufficient contributions.

Supplementary questions were asked by Cde. Reepu Daman Persaud.

#### No. 11 - Unemployment Relief

Cde. Reepu Daman Persaud, on behalf of Cde. J. Jagan, asked the Minister of Manpower and Co-operatives the following question:

<u>QUESTION:</u> Will the Minister say when the Government proposes to provide unemployment relief for the thousands who are out of work?

The Minister of Manpower and Co-operatives gave the following reply:

One of the Government's objectives is to create full employment. There are many opportunities for self employment in this country for which the Government will give as much assistance as possible. There are many employment opportunities available mainly in the area of agriculture and simple manufacturing. If Guyanese will merely take up the employment opportunities available, we really have no unemployment in Guyana, therefore the payment of unemployment relief does not arise.
