ITEM 1 REVISION OF THE STANDING ORDERS

The Vice-President, Parliamentary Affairs and Party/State Relations, moved the following motion which was put and carried:

WHEREAS the Standing Orders used by the National Assembly were made several years

AND WHEREAS constitutional and other changes have from time to time taken place since these Standing Orders were made;

AND WHEREAS a new Constitution providing for the restructuring of the society and the economy of Guyana on socialist principles was prepared by the People of Guyana and was adopted in 1980 for the Co-operative Republic of Guyana;

AND WHEREAS it is expedient that the Standing Orders of the National Assembly be modified and revised to bring them into conformity with the new Constitution and with other changes and requirements:

BE IT RESOLVED:

That the National Assembly refer the Standing Orders to the Standing Orders Committee for review and revision and for report thereafter to the Assembly.

ITEM 2 - CREATION OF GUYANA NATIONAL GROUP OF THE INTER-PARLIAMENTARY UNION

The Vice-President, Parliamentary Affairs and Party/State Relations, moved the following motion:

BE IT RESOLVED:

That the National Assembly of the Parliament of the Co-operative Republic of Guyana approves of the creation in Guyana of a National Group of the Inter-Parliamentary Union;

AND BE IT FURTHER RESOLVED:

That the National Assembly of the Parliament of the Co-operative Republic of Guyana constitutes itself with all the Members of the National Assembly as the Guyana National Group of the Inter-Parliamentary Union.

Cde. J. Jagan spoke to the motion.

Thereafter, the Vice-President, Parliamentary Affairs and Party/State Relations, replied.

The motion was then put and carried.

ITEM 3 - MEETING OF GUYANA NATIONAL GROUP OF INTER-PARLIAMENTARY UNION

The Vice-President, Parliamentary Affairs and Party/State Relations, moved the following motion which was put and <u>carried</u>.

BE IT RESOLVED:

That the National Assembly of the Parliament of Guyana empowers the Guyana National Group of the Inter-Parliamentary Union created and constituted by the National Assembly to hold its first Meeting at such time and place as the Speaker of the National Assembly shall determine:

AND BE IT FURTHER RESOLVED:

That, pending the coming into operation of such Rules as the Guyana National Group of the Inter-Parliamentary Union may make for the effective participation of the Group in the work of the Inter-Parliamentary Union, the functions of President of the Group be performed by the Speaker of the National Assembly, and the functions of Secretary of the Group be performed by the Clerk of the National Assembly.

BILLS - Second and Third Readings

ITEM 4 - MISCELLANEOUS ENACTMENTS (AMENDMENT) BILL 1981 - Bill No. 6/1981 published 6.6.81

The Prime Minister moved the second reading of the following Bill:

For "fifty years, at his option exercisable in accordance with section 12, <u>substitution</u> of "forty years, at his option exercisable in accordance with section 12 at any time after he attains that age" in the new subsection (8) of section 9 of the Pensions (President, Parliamentary and Special Offices) Act, Chapter 27:03.

The Schedule was then passed as amended.

Assembly resumed.

On a motion by the Attorney General and Minister of Justice, on behalf of the Prime Minister, the Bill was read the third time and passed as amended in Committee.

ITEM 5 - MISCELLANEOUS ENACTMENTS (AMENDMENT)(NO. 2) Bill 1981 - Bill No. 7/1981 published 8.6.81

The Minister, Finance, in the Ministry of Economic Planning and Finance, on behalf of the Vice-President, Economic Planning and Finance, moved the second reading of the following Bill:
