  - 2. If Government is prepar ng the said legislation when is it likely to come before Council for consideration?

- (b) that a special educational tax be imposed to cover any increase cost in connection with Frimary Education.

WHEREAS the policy of racial aegregation as enforced by the Government of South Africa abuses the rights of human beings;

AND WHEREAS it is meet that this Colony shows its abhorrence and disappro ation of such policy;

BE IT RESOLVED that this Council condemns the policy of racial segregation enforced by the South African Government and places on record its abhorence of the attitude adopted to the various races in the pursuit of this policy which is likely to affect adversely the amicable relations existing amongst the peoples of this Colony and of other mixed communities;

AND BE IT FURTHER RESOLVED that this Council respectfully prays His Excellency the Governor to transmit a copy of this Resolution to the Secretary of State for the Colonies and to the United Nations urging that steps be taken y the United Nations to persuade the South Afri an Government to desist from such a disastrous course and to adopt a policy towards all races in South Africa in keeping with the Declaration of Human Rights.

7. Dr. Jagan to move the following motion:-

WHEREAS there are examples of questions being asked by Legislators in the Legislative Council, answers to which are unduly delayed or never supplied;

AND WHEREAS there are many motions tabled in the Legislative Council which are never placed on the Order Paper for discussion by the Legislative Council;

BE IT RESOLVED that this Council recommends to Government that proposed incleased fares and freight charges for railway and stea er services be non-effective until such time as the Legislative Council has fully discussed the rece t "Peport of the Committee appointed to consider Ways a d Means of Effecting Economies".
