1. BILL - First Reading.

2. The Member for Agriculture, Forests, Lands and Mines to move the second reading of the following Bill:

A BILL intituled AN ORDINANCE TO MAKE PROVISION FOR THE GRANT OF LICENCES AUTHORIZING THE UTILISATION OF THE WATERS OF THE COLONY FOR THE PURPOSE OF GENERATING ELECTRICAL ENERGY, AND FOR MATTERS CONNECTED THEREWITH.

MOTION

3. Mr. Lee to move the following motion:

WHEREAS Government has declared that recruitment to the Public Service of British Guiana rests upon the general principle that first consideration will be given to candidates of local origin who possess the requisite qualifications and experience;

AND WHEREAS it appears necessary for this principle to be laid down as a firm policy to be accepted and followed by the local Government and the Secretary of State for the Colonies:

BE IT RESOLVED:

That this Council recommends to Government that steps be taken to adopt the policy that British Guianese should be given first preference on all occasions in the filling of vacancies in the Public Service of British Guiana provided that candidates for vacant posts possess the requisite qualifications and experience:

AND BE IT FURTHER RESOLVED:

That a copy of this Resolution be forwarded to the Secretary of State for the Colonies, for his notification and approval.
