MOTIONS

1. NATURAL GAS FLARING AT THE ESSO EXPLORATION AND PRODUCTION GUYANA LIMITED

Mr. David Patterson, M.P. to move the following motion:

WHEREAS Esso Exploration and Production Guyana Limited (EEPGL) was on June 1, 2017, granted an Environmental Permit, No. 20160705-EEDPF, to undertake Phase 1 of the Liza Development Project (Liza 1) which included, the use of a Floating Production, Storage, and Offloading (FPSO) vessel "to process, store and offload the recovered oil during production operations within the Stabroek Block";

AND WHEREAS the Liza 1 Permit (Clause 1.10) enjoined the Permit Holder, EEPGL, to "Employ effective operational and maintenance systems on all aspects of the facility whose failure could impact the environment...";

AND WHEREAS the Liza 1 Permit (Clause 3.6) expressly prohibits flaring and venting; with exceptions being made for "tank flashing emission, standing/working/breathing losses" and flaring related to the startup of the FPSO, emergencies or during periods of maintenance;

AND WHEREAS EEPGL has routinely been engaged in flaring in direct contravention of the terms of the Liza 1 Permit issued and acknowledged, and as a result, has caused, and is causing substantial damage to the environment and the credibility of the Liza 1 Development Project;

AND WHEREAS calculations based upon reported EEPGL's production data shows that zero flaring, except for the small amount allowed for pilot flaring, may be achieved by reducing oil production by approximately 15,000 bopd;

AND WHEREAS according to Clause 13.1 in the Liza 1 and Liza 2 Permits, "The Environmental Protection Agency reserves the right to review and amend the conditions attached to this Permit",

BE IT RESOLVED:

That this National Assembly expresses its dissatisfaction, that all reasonable measures have not been taken or are being taken to prevent the flaring of gas as currently exists, and which reported by EEPGL to be 16 million cubic feet, per day (mcfd) at the designed maximum safe oil production limit of 120,000 barrels oil, per day (bopd).

BE IT FURTHER RESOLVED:

That the National Assembly calls on the Government of Guyana:

- 1. To direct Esso Exploration and Production Guyana Limited to abide by the terms and conditions of the Liza 1 Permit issued on June 1, 2017;
- 2. To request that the Environmental Protection Agency takes all reasonable measures to ensure compliance including, EEPGL achieving zero flaring at the Liza 1 Project through reduction of oil production rates; and suspension of same Liza 1 Permit if zero flaring is not met, until it is satisfied that all reasonable and lawful efforts are being made to ensure that there is no flaring of gas as has occurred over the past several weeks; and
- 3. To request that the Liza 1 and Liza 2 Permits be immediately amended by the EPA to become consistent with the updated conditions in the Payara Permit, relative to flaring.

WHEREAS successive Governments of Guyana have approved three Development Plans for ExxonMobil (Liza I, Liza II and Payara) and additionally, the company has announced its intention to apply for a 4th Development Plan (Yellowtail) before the end of 2021;

AND WHEREAS the Guyana Shore Base Inc., is located on the Demerara River, which is the busiest river in the country;

AND WHEREAS ExxonMobil has recently issued a Request for Information to identify contractors who can provide fully functional, fit for purpose shore base facilities, to support their needs of future projects, starting 2023,

BE IT RESOLVED:

That the National Assembly advises the Government to establish a Multi-Agency Taskforce to prepare a Land Use Policy, specifically for the location of the Oil and Gas Sector and present their Report to this Assembly, as early as possible, but within six (6) months;

BE IT FURTHER RESOLVED:

That the Government advises the Taskforce that it is the preference of this National Assembly for future onshore bases to be in the Counties of Berbice and Essequibo to ensure parity in development of the Oil and Gas Industry and the equal-able development across Guyana for the benefit of all Citizens;

BE IT FURTHER RESOLVED:

That the Government of Guyana advises ExxonMobil and all other Oil and Gas Operators that they should suspend their RFI until the Taskforce completes its Report on the Land Use Policy, which should be completed within six (6) months; and

BE IT FURTHER RESOLVED:

That the Government of Guyana informs ExxonMobil and all other Oil and Gas Operators that all future shore bases shall be State-Owned but leased to private operators so as to ensure the maximum benefit for all Guyanese.

*3. CONDEMN THE BRUTAL AND HORRIFIC KILLING OF JOEL HENRY, ISIAAH HENRY AND HARESH SINGH, BETWEEN THE PERIOD SEPTEMBER 6 to 9, 2020

WHEREAS, Guyanese citizens, Joel Henry, Isiah Henry and Haresh Singh, all under the age of 20 years old, from the village of N0. 3 Village, West Coast Berbice, were brutally, barbarically and horrifically killed, and the bodies found at or near the Cotton Tree Back Dam in the Mahaica/ Berbice Region No. 5;

AND WHEREAS, the period September 6 to 9, 2020, will go down in the history of our country as the period when these unspeakable crimes left the nation numb and in a state of shock and sadness;

AND WHEREAS. these brutal, senseless, barbaric, depraved and horrific killings have caused untold pain, agony, grief, anguish, anger and despair to the surviving family members, fellow villagers and the entire Guyanese Community;

AND WHEREAS, these brutal and horrific killings have evoked unequivocal condemnation from Guyanese, living in Guyana and in the diaspora;

AND WHEREAS, the diplomatic community and civil society have also unequivocally condemned these brutal, barbaric and horrific killings;

AND WHEREAS, Parliament, of which the National Assembly is a part of the supreme legislative forum of our Republic wherein the people's elected representatives discuss and determine matters of national interest and is obliged to consider the grave threats to the public welfare and public security;

AND WHEREAS, Article 138(1) of the Constitution of the Cooperative Republic of Guyana prescribes that no person shall be deprived of his life intentionally save in the execution of the sentence of a court in respect of an offence under the Laws of Guyana of which he has been convicted;

AND WHEREAS, to date these horrific deaths which are of public importance, concern and welfare remain substantially unresolved.

BE IT RESOLVED:

That the National Assembly recommends to the Government to procure and finance the assistance of expert and competent professionals who can resolve these cases;

BE IT FURTHER RESOLVED:

That the National Assembly condemns the killing of the three Citizens aforementioned, and extends sincerest condolences to the families of the deceased; and

BE IT FURTHER RESOLVED:

That the National Assembly calls on the Government to continue its earnest investigations, so as to ensure expeditious justice to the family.

MOTION

4. REMOVAL OF THE CHAIRPERSON OF THE PUBLIC ACCOUNTS <u>COMMITTEE</u>

The Minister of Parliamentary Affairs and Governance and Government Chief Whip to move the following motion:

WHEREAS the Public Accounts Committee met on December 28, 2020, under the Chairmanship of the Honourable Speaker of the National Assembly where Mr. David Patterson, M.P., was nominated and declared the Chairperson;

AND WHEREAS at the Sixth Meeting of the Public Accounts Committee, on February 1, 2021, following certain exposures during the examination of the 2016 Auditor General's Report, a motion was moved by Minister Gail Teixeira calling for Mr. David Patterson to resign as Chairperson while remaining as a member of the Committee and that another member of the Opposition be elected as the Chairperson; the motion was put in accordance with Standing Orders 26 (Admissibility of Motions) and 30 (h) Exemption from Notice;

AND WHEREAS the Chairperson having not agreed to resign, the motion was then moved and supported by the majority of the members for the removal of the Chairperson;

AND WHEREAS the Chairperson having not "put' the motion to a vote as required by the Standing Orders, the Clerk of the National Assembly was invited into the meeting to provide guidance;

AND WHEREAS the Clerk advised the Committee that the Regional Group of Clerks in the Caribbean had agreed that any member could move a motion for the Chairperson to step aside and that "no notice was required for a motion to be brought in a committee and the motion should be "put", and if a division was called, it should be voted on;"

AND WHEREAS on the departure of the Clerk, the Chairperson did not 'put" the motion but instead vacated the chair while remaining in the room and invited other members of the Opposition to take the chair whereby they declined; resulting in their being no Chair and the meeting being aborted;

AND WHEREAS the Seventh Meeting was summoned by the Chairperson on March 15, 2021, with the "Motion for the removal of the Chairperson" not listed as an item on the Agenda;

AND WHEREAS at the said Meeting, a motion was moved to amend the agenda to include, as the first item, "the Motion for the removal of Mr. David Patterson as Chairperson of the PAC"; this motion to amend the agenda was put to a vote and carried; and again, the Chairperson did not put the motion for his removal;

AND WHEREAS the Clerk of the National Assembly was again invited to the meeting and advised that the Clerk of the Committee could conduct an election for a temporary Chair for the day's meeting; it was also noted that the Chairperson, according to SO 102(3), has "no original vote but in the event of an equality of votes shall have a casting vote"; therefore, the Chairperson

although personally involved could occupy the Chair and "put" the motion; the Chairperson did not comply and again vacated the Chair; there was no Chairperson in place to "put" the motion to a vote once again; it was then agreed that the Clerk of the National Assembly would seek legal advice from a lawyer who was "not politically aligned" on the interpretation of the Standing Orders;

AND WHEREAS the Clerk of the National Assembly formally circulated the legal advice he received dated March 23, 2021 "on whether SO 95(4) overrides SO 82(2)" to the Chairperson and Members of the Committee and called for a meeting to be held on March 31, 2021, no meeting was held, however, until April 12;

AND WHEREAS at the April 12th Meeting, the legal opinion was listed as Item #1 and "Motion for the removal of the Chairperson" as Item #2 on the Agenda;

AND WHEREAS the Chairperson refused to allow a motion for the adoption of the legal opinion circulated by the Clerk and repeatedly ignored and refused to allow motions to go to Item 2 on the agenda and "put" the "Motion for the removal of the Chairperson" instead he overrode every effort to do so and moved to other items on the Agenda;

AND WHEREAS a Committee Meeting was convened for April 19, at which Item # 1 "Motion for the removal of Mr. David Patterson as Chairperson" was asterisked by the Chairperson on the Agenda; the meeting was subsequently cancelled;

AND WHEREAS on May 3, 2021, the Speaker of the National Assembly wrote the Chairperson of the Public Accounts Committee, copied to all members of the Public Accounts Committee, in which he stated that i) as Speaker he could intervene in a committee related issue in "very serious and special circumstances;" (ii) the Chairperson of a Committee does not have the authority to place an asterisk against a Member's motion, only the mover could; (iii) this action by the Chairperson was a "gross violation of the Standing Orders and tantamount to bullyism," and, iv) he compelled the Chairperson to "put" the motion;

AND WHEREAS to date Mr. David Patterson has demonstrated that he has no respect for the Speaker of the National Assembly and, it would appear, in the absence of a response to the Speaker's letter he is unprepared to obey the Speaker's instruction; he has disregarded the advice of the Clerk of the National Assembly on several occasions with regard to the Standing Orders and is resolute in his refusal, using all forms of subterfuge, to allow the motion for his removal to be "put" to the vote;

AND WHEREAS Mr. David Patterson has consistently and openly violated the Standing Orders and has introduced a level of bullyism unbefitting of a Member of Parliament, and, in doing so, bringing the image of the National Assembly into disrepute,

BE IT RESOLVED:

That as a result of Mr. David Patterson's conduct as Chairperson of the Public Accounts Committee with respect to his open violation of the Standing Orders, among other things, in particular since February 1, the majority of the members of the Public Accounts Committee have lost confidence in him as the Chairperson of the Public Accounts Committee:

BE IT FURTHER RESOLVED:

That this National Assembly approves the removal of Mr. David Patterson as the Chairperson of the Public Accounts Committee.
