# 2. **INCREASE IN THE COST OF LIVING FOR GUYANESE**

Ms Annette Ferguson, M.P., to move the following motion:

WHEREAS Guyana, and countries around the world, continue to experience a tremendous health and socio-economic (cost of living) impact from the Coronavirus 19 pandemic: raging in Guyana, over a thousand tragic deaths so far to an alarming increase in the cost of living;

AND WHEREAS the Government of Guyana, in its efforts to cushion the effects of the COVID-19 pandemic, provided a one-off twenty-five thousand (\$25,000.00) COVID-19 cash grant;

AND WHEREAS there has been a substantial increase in the cost of essential food items, some doubling or nearly doubling from pre-pandemic levels, including those grown here in Guyana;

AND WHEREAS the Government of Guyana provided a 7%, taxable increase in salary to Public Servants in December 2021;

AND WHEREAS inflation persist, and Guyanese must brace themselves for further increases in the cost of living in 2022;

AND WHEREAS the Government of Guyana has failed to devise strategies or implement policies, that have proven effective at combating inflation or cushioning its impact on the lives of Guyanese,

#### BE IT RESOLVED:

That the Government of Guyana promptly devise a strategy or plan to address the high cost of living Guyanese are burdened with; and

#### BE IT FURTER RESOLVED:

That the Government of Guyana makes provision for EACH Guyanese above the age of eighteen (18) years, to be assisted with the high cost of living in Guyana.

# 3. <u>LIABILITY INSURANCE COVERAGE FOR OIL SPILLS IN GUYANA</u>

Mr. David Patterson, M.P., to move the following motion:

WHEREAS Oil production offshore Guyana is expected to increase rapidly from its current rate of 120,000 barrels per day (bopd) to close to 1 million bopd, with the number of FPSOs increasing over 10 times by 2026;

AND WHEREAS the emergency response and cleanup of the British Petroleum Macondo oil spill in the Gulf of Mexico has so far cost more than \$70 Billion USD;

AND WHEREAS a major oil spill offshore Guyana would result in the environmental devastation of Guyana and its neighbouring countries, obliterating the areas fishing industry, aquatic vegetation, including possible lawsuits from neighbouring countries;

AND WHEREAS the Liza 1 Permit signed by the current EPA Head and issued in June 2017, designates as Permit Holder – Esso Exploration and Production Guyana Limited (EEPGL), a subsidiary Limited Liability Corporation (LLC) of parent companies, ExxonMobil, Hess and CNOOC;

AND WHEREAS following the change in EPA's Leadership, Liza 2 permit included provisions for unlimited liability for all spills by including a provision requiring EEPGL's purchase of the maximum available private insurance offered in the market, with all of the remaining liabilities to be covered by EEPGL's parent companies – Exxon, Hess and CNOOC;

AND WHEREAS EEPGL agreed to the unlimited liability coverage commitment in the Liza 2 Permit and urgent purchase of the maximum available private insurance prior to signing the Permit;

AND WHEREAS EEPGL timely obtained the maximum \$2.5 Billion private insurance available on the market prior to EPA signing and issuing the Liza 2 Permit in April, 2019,

#### BE IT RESOLVED:

That the Government recants its decision to cancel the process already established in 2017 for obtaining unlimited liability coverage by EEPGL's parent companies – a process that was agreed upon by Exxon and made a condition of the Liza 2 Permit, and was close to being finalised when the current administration took office in 2020;

#### BE IT FURTHER RESOLVED:

That the Government returns to the already well-established process put in place by the previous administration which made a condition of the Liza 2 Permit for guaranteed coverage by EEPGL's parent companies, agreed upon by EEPGL, and was nearing completion when the current administration took office;

#### BE IT FURTHER RESOLVED:

That this Parliament calls on the Government of Guyana, to include full unlimited liability coverage for oil spills and other disasters related to petroleum production as a condition for granting approval for the proposed Yellowtail development and all other future petroleum development;

## BE IT FURTHER RESOLVED:

That the Government of Guyana, conducts an independent analysis on the possible ill effects of an oil spill, and present this report to the Parliamentary Committee on Natural Resources to be used as a reference for all other future oil development submissions; and

#### BE IT FURTHER RESOLVED:

That, if necessary, the Opposition stands ready, able and willing to assist the Government in getting back on track the expeditious acquisition of unlimited liability coverage for an oil spill.

# \*4. NATURAL GAS FLARING AT THE ESSO EXPLORATION AND PRODUCTION GUYANA LIMITED

Mr. David Patterson, M.P. to move the following motion:

WHEREAS Esso Exploration and Production Guyana Limited (EEPGL) was on June 1, 2017, granted an Environmental Permit, No. 20160705-EEDPF, to undertake Phase 1 of the Liza Development Project (Liza 1) which included, the use of a Floating Production, Storage, and Offloading (FPSO) vessel "to process, store and offload the recovered oil during production operations within the Stabroek Block";

AND WHEREAS the Liza 1 Permit (Clause 1.10) enjoined the Permit Holder, EEPGL, to "Employ effective operational and maintenance systems on all aspects of the facility whose failure could impact the environment...";

AND WHEREAS the Liza 1 Permit (Clause 3.6) expressly prohibits flaring and venting; with exceptions being made for "tank flashing emission, standing/working/breathing losses" and flaring related to the startup of the FPSO, emergencies or during periods of maintenance;

AND WHEREAS EEPGL has routinely been engaged in flaring in direct contravention of the terms of the Liza 1 Permit issued and acknowledged, and as a result, has caused, and is causing substantial damage to the environment and the credibility of the Liza 1 Development Project;

AND WHEREAS calculations based upon reported EEPGL's production data shows that zero flaring, except for the small amount allowed for pilot flaring, may be achieved by reducing oil production by approximately 15,000 bopd;

AND WHEREAS according to Clause 13.1 in the Liza 1 and Liza 2 Permits, "The Environmental Protection Agency reserves the right to review and amend the conditions attached to this Permit",

#### BE IT RESOLVED:

That this National Assembly expresses its dissatisfaction, that all reasonable measures have not been taken or are being taken to prevent the flaring of gas as currently exists, and which reported by EEPGL to be 16 million cubic feet, per day (mcfd) at the designed maximum safe oil production limit of 120,000 barrels oil, per day (bopd).

#### BE IT FURTHER RESOLVED:

That the National Assembly calls on the Government of Guyana:

- 1. To direct Esso Exploration and Production Guyana Limited to abide by the terms and conditions of the Liza 1 Permit issued on June 1, 2017;
- 2. To request that the Environmental Protection Agency takes all reasonable measures to ensure compliance including, EEPGL achieving zero flaring at the Liza 1 Project through reduction of oil production rates; and suspension of same Liza 1 Permit if zero flaring is not met, until it is satisfied that all reasonable and lawful efforts are being made to ensure that there is no flaring of gas as has occurred over the past several weeks; and

3. To request that the Liza 1 and Liza 2 Permits be immediately amended by the EPA to become consistent with the updated conditions in the Payara Permit, relative to flaring.

# \*5. CONDEMN THE BRUTAL AND HORRIFIC KILLING OF JOEL HENRY, ISIAAH HENRY AND HARESH SINGH, BETWEEN THE PERIOD SEPTEMBER 6 to 9, 2020

WHEREAS, Guyanese citizens, Joel Henry, Isiah Henry and Haresh Singh, all under the age of 20 years old, from the village of N0. 3 Village, West Coast Berbice, were brutally, barbarically and horrifically killed, and the bodies found at or near the Cotton Tree Back Dam in the Mahaica/ Berbice Region No. 5;

AND WHEREAS, the period September 6 to 9, 2020, will go down in the history of our country as the period when these unspeakable crimes left the nation numb and in a state of shock and sadness;

AND WHEREAS. these brutal, senseless, barbaric, depraved and horrific killings have caused untold pain, agony, grief, anguish, anger and despair to the surviving family members, fellow villagers and the entire Guyanese Community;

AND WHEREAS, these brutal and horrific killings have evoked unequivocal condemnation from Guyanese, living in Guyana and in the diaspora;

AND WHEREAS, the diplomatic community and civil society have also unequivocally condemned these brutal, barbaric and horrific killings;

AND WHEREAS, Parliament, of which the National Assembly is a part of the supreme legislative forum of our Republic wherein the people's elected representatives discuss and determine matters of national interest and is obliged to consider the grave threats to the public welfare and public security;

AND WHEREAS, Article 138(1) of the Constitution of the Cooperative Republic of Guyana prescribes that no person shall be deprived of his life intentionally save in the execution of the sentence of a court in respect of an offence under the Laws of Guyana of which he has been convicted;

AND WHEREAS, to date these horrific deaths which are of public importance, concern and welfare remain substantially unresolved.

#### BE IT RESOLVED:

That the National Assembly recommends to the Government to procure and finance the assistance of expert and competent professionals who can resolve these cases;

#### BE IT FURTHER RESOLVED:

That the National Assembly condemns the killing of the three Citizens aforementioned, and extends sincerest condolences to the families of the deceased; and

#### BE IT FURTHER RESOLVED:

That the National Assembly calls on the Government to continue its earnest investigations, so as to ensure expeditious justice to the family.
