## ORDER

MADE UNDER

## THE TRADE ORDINANCE, 1958 (No. 34 of 1958).

## UNDER SECTION 5 OF THE TRADE ORDINANCE, 1958, IT IS HEREBY ORDERED AS FOLLOWS:—

- 1. (1) This Order, which amends the Trade (Control of Prices) Order, 1963,\* may be cited as the Trade (Control of Prices) (Chemicals and Pharmaceutical Products) Order, 1971.
- (2) Clause 3 of this Order shall come into operation on the 23rd February, 1971.
- 2. Clause 14 of the Principal Order is hereby amended in the following respects
  - (a) by the renumbering of the clause as clause 14(1); and
  - (b) by the addition thereto of the following paragraph
    - "(2) Any person carrying on or employed in connection with any trade or business whereby there is sold or offered for sale any price controlled article shall—
      - (a) produce to the Competent Authority, any person authorised in writing by the said authority in that behalf, or any police constable duly authorised as aforesaid such books, accounts or other documents relating to their trade or business as the authority may require for the purpose of determining whether or not the provisions of any order made under section 5 of the Ordinance have been breached;

- (b) furnish to the Competent Authority such estimates, returns or information relating to any price controlled article as the Competent Authority may by writing from time to time require."
- 3. (1) The particulars specified in relation to the articles listed in Part A and Part B, respectively, of the schedule shall be the maximum prices at which those articles shall be sold in the respective areas of Guvana.
- (2) References in the schedule to goods of an item or group number means such goods as are or would be classified under such number of the Trade Classification List and Tariff set out in the Customs Ordinance.
- (3) Duty paid price in the schedule has the same meaning as in the Trade (Control of Prices) (Amendment) Order 1971.\*\*
