IN EXERCISE OF THE POWER CONFERRED UPON THE MINISTER BY SECTION 5 OF THE TRADE ACT, I HEREBY MAKE THE FOL-LOWING ORDER:—

Citation.

1. This Order may be cited as the Trade (Control of Prices) (Chicken) Order 1974 and shall be construed and read with the Trade (Control of Prices) Order*.

Interpre-

2. In this Order —

"chicken" means the specie of bird commonly known as the domestic fowl but does not include the poussin;

"drawn and trussed" means with the feathers, head, shanks and all inedible offal removed but inclusive of the giblets and without the addition of any other substance;

"giblets" means the edible gizzard, heart, liver and neck; "pre-packed" means the packing of chicken (otherwise than by a retailer for the purposes of sale by retail by him on the premises on which the chicken is so packed) in advance ready for sale by retail.

Maximum wholesale and retail prices.

- 3.(1) The maximum price at which chicken described in the first column of Part A of the Schedule shall be sold by wholesale, shall be the price specified in relation to that description in the second, third and fourth columns, respectively of the said Part.
- (2) The maximum price at which chicken described in the first column of Part B of the Schedule shall be sold by retail, shall be the price specified in relation to that description in the second, third and fourth columns, respectively, of the said Part.

Pre-packing of chicken.

- 4.(1) No wholesaler or retailer shall sell, offer or expose for sale any chicken described in this Order unless the chicken is pre-packed.
- (2) No charge additional to the maximum price specified in this Order shall be made for the pre-packing of the chicken.
