# THE ACQUISITION OF LANDS FOR PUBLIC PURPOSES ACT

(Chapter 62: 05)

IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTIONS 3 AND 4 OF THE ACQUISITION OF LANDS FOR PUBLIC PURPOSES ACT, I HEREBY MAKE THE FOLLOWING ORDER:—

- 1. This Order may be cited as the Acquisition of Lands for Public Purposes (Construction of a road under the Guyana/Suriname Ferry Project) Order 1988.
- 2. The proposed construction of a road under the Guyana/ Suriname Ferry Project on the lands, described in the Schedule hereto, is hereby declared to be a public work.
- 3. The Chief Works Officer, together with his agents, servants or workmen, is hereby authorised to enter upon the said lands for the purpose of surveying or otherwise examining such lands with a view to the acquisition of the whole or of part of such lands for the public work aforesaid.
