- IN EXERCISE OF THE POWERS CONFERRED UPON THE MINISTER BY SECTION 8(1) OF THE LOCAL AUTHORITIES (ELECTIONS) ACT, I HEREBY MAKE THE FOLLOWING ORDER:—
- 1. This Order may be cited as the Local Authorities (Elections) Citation. (Registration of Voters) Order 1986.
- 2. The electoral registrar of every local authority area described of register of in the First Schedule is required to prepare a register of voters for voters, the local authority area of which he is the electoral registrar.
- 3. The 30th October, 1986 shall be the qualifying date with data reference to which a register of voters shall be compiled in pursuance of this Order.
