MADE UNDER

THE TOWN AND COUNTRY PLANNING ORDINANCE (Chapter 181).

UNDER SUBSECTION (1) OF SECTION 2 OF THE TOWN AND COUNTRY PLANNING ORDINANCE, IN ACCORDANCE WITH ARTICLE 22 OF THE CONSTITUTION OF BRITISH GUIANA AND BY VIRTUE AND IN EXERCISE OF ALL POWERS ENABLING HIM IN THAT BEHALF IT IS HEREBY ORDERED BY THE GOVERNOR AS FOLLOWS:

- 1. This Order may be cited as the Town and Country Planning (Local Authority) (Christianburg-Wismar) Order, 1963.
- 2. The Local Authority of the Christianburg and Wismar Village District is hereby declared to be a Local Authority for the purposes of the above Ordinance within the area and to the extent specified in the schedule to this Order.

SCHEDULE

The Christianburg and Wismar Area situate on the left bank of the Demerara River in the County of Demerara and Colony of British Guiana, commencing about 3,450 feet above the mouth of the Itaru Creek, at the south eastern corner of Lot 24 Section 'A' which is shown on a plan by William Chalmers, Crown Surveyor, dated 21st August, 1900 and recorded in the Department of Lands and Mines as Plan No. 1232, and extending thence N 283° 31' 00" (tr.) 2097 feet, thence N 307° 24' (tr.) 2197.4 feet, thence N 327° 38' 00" (tr.) for about 1841 feet, thence N 283° 31' 00" (tr.) for about 560 feet, thence N 224° 45' 37" (tr.) 975.9 feet. thence N 224° 15′ 17" (tr.) 688.22 feet, thence N 327° 49′ 28" (tr.) 5390.21 feet, thence N 81° 05' 02" (tr.) 177.8 feet, thence N 60° 06' 18" (tr.) 550.38 feet, thence N 25° 40′ 48″ (tr.) 418.44 feet, thence N 48° 28′ 40″ (tr.) 1117.93 feet, thence N 98° 03′ 46″ (tr.) 516.86 feet, thence N 11° 58′ 35″ (tr.) 365.45 feet, thence N 12° 49′ 07" (tr.) 196.72 feet, thence N 12° 21' 17" (tr.) 370.17 feet, thence N 12° 25' 25" (tr.) 585.98 feet, thence N 12° 15' 45" (tr.) 576.15 feet, thence N 12° 33′ 23″ (tr.) 439.03 feet, thence N 101° 17′ 25″ (tr.) 380.93 feet, thence N 100° 50′ 38″ (tr.) 608.62 feet, thence N 100° 45′ 58″ (tr.) 448.43 feet, thence N 103° 56' 00" (tr.) about 1816 feet, thence N 13° 56' 00" (tr.) 1638.5 feet, thence N 14° 47′ 53" (tr.) 814.8 feet, thence N 13° 56′ 00" (tr.) 1819.9 feet, thence N 103° 56′ 00″ (tr.) 740.7 feet, thence N 42° 56′ 00″ (tr.) 570 feet, thence N 104° 00' 00" (tr.) about 875 feet to the left bank Demerara River, thence upwards along the left bank of the Demerara River to the point of commencement, and defined on a compiled plan prepared by the Lands and Mines Department, dated the 18th of January, 1962, and recorded as Plan No. 10,214.
