Citation.

1. This Order may be cited as National Industrial and Commercial Investments Limited (Transfer of Property) Order.

Interpretation.

- 2. In this Order: -
 - (a) "Appointed Day" means the date on which this Order shall come into operation.
 - (b) "NICIL" means National Industrial and Commercial Investments Inc., being a company incorporated under the Companies Act 1991, with its registered office situate at Lot 199 Camp Street, South Cummingsburg, Georgetown:

Schedule

- (c) "The Purchaser" means **BK Marine Inc.** of Lots 119 Peter Rose and Laluni Streets, Queenstown, Georgetown, Guyana;+
- (d) "Property" means the immovable property described in the Schedule, being property belonging to NICIL.

Transfer of property.

3. The title to the Property shall, as from the Appointed Day, stand transferred to and shall be vested in the Purchaser absolutely, free and clear from all claims and liabilities

The Property referred to herein are:

- (a) The immovable property specified in the Schedule which is owned by NICIL immediately before the Appointed Day; and
- (b) The title of immovable property of NICIL mentioned in the Schedule shall from the Appointed Day stand transferred and vested in the Purchaser. As from the Appointed Day, a certified copy of this Order shall be deemed to be conclusive evidence that the Purchaser has absolute title to the Property so that any lease, license, transfer, assignment, agreement or otherwise granted in furtherance of this Order shall be conclusive evidence that the person named in such lease or agreement or otherwise is seized of or possessed of or entitled to such land for the estate or interest therein specified.
