THE CUSTOMS ACT (Cap. 82:01)

**IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION 8 OF THE
CUSTOMS ACT, I MAKE THE FOLLOWING ORDER:-**

Citation and
commencement.

1. This Order, which amends the First Schedule to the Customs Act, may be cited as the Customs (Amendment of First Schedule) (No. 3) Order 2020 and shall come into operation on the 1st of January 2021.

Amendment of
Part III of the
First Schedule to
the Act.

2. PART III OF THE FIRST SCHEDULE C – TRADE AGREEMENTS to the Act is amended as follows –

(a) in paragraph vi, by the substitution for the words –

**“AGREEMENT ESTABLISHING THE FREE TRADE
AREA BETWEEN THE CARIFORUM STATES AND
THE EUROPEAN COMMUNITY”**

of the words –

**“AGREEMENT ESTABLISHING THE FREE TRADE
AREA BETWEEN THE CARIFORUM STATES AND
THE EUROPEAN COMMUNITY EXCLUDING THE
UNITED KINGDOM OF GREAT BRITAIN AND
NORTHERN IRELAND**

**Any reference to the United Kingdom of Great Britain and
Northern Ireland in the CARIFORUM-European
Community Economic Partnership Agreement, shall be
construed as deleted.”; and**

(b) immediately after paragraph vi, by the insertion of the following paragraph –

**“vii. AGREEMENT ESTABLISHING THE FREE TRADE
AREA BETWEEN THE CARIFORUM STATES
AND THE UNITED KINGDOM OF GREAT
BRITAIN AND NORTHERN IRELAND**
