IN EXERCISE OF THE POWER CONFERRED UPON THE BANK BY SECTION 18 OF THE DEALERS IN FOREIGN CURRENCY (LICENSING) ACT, THE BANK HEREBY MAKES THE FOLLOWING REGULATIONS:-

Citation.

1. These Regulations, which amend the Dealers in Foreign Currency (Licensing) Regulations 1990*, may be cited as the Dealers in Foreign Currency (Licensing) (Amendment) Regulations 2000.
